## AN ACT

- To amend the Public Health Service Act to authorize the Secretary of Health and Human Services to carry out a program of research, training, and investigation related to Down syndrome, and for other purposes.
  - 1 Be it enacted by the Senate and House of Representa-
  - 2 tives of the United States of America in Congress assembled,

### 1 SECTION 1. SHORT TITLE.

2 This Act may be cited as the "DeOndra Dixon IN-3 CLUDE Project Act of 2024".

### 4 SEC. 2. DOWN SYNDROME RESEARCH.

5 Part A of title IV of the Public Health Service Act
6 (42 U.S.C. 281 et seq.) is amended by adding at the end
7 the following:

### 8 "SEC. 404P. DOWN SYNDROME RESEARCH.

9 "(a) IN GENERAL.—The Secretary, acting through 10 the Office of the Director of NIH, and in consultation with 11 other Federal agencies and partners, shall carry out a pro-12 gram of research, training, and investigation related to 13 Down syndrome to be known as the 'INvestigation of Co-14 occurring conditions across the Lifespan to Understand 15 Down syndromE Project' or the 'INCLUDE Project'.

16 "(b) PROGRAM ELEMENTS.—The program under
17 subsection (a) shall include research, training, and inves18 tigation related to—

19 "(1) high-risk, high reward basic science studies
20 of the effects of chromosome 21 on human develop21 ment and health;

22 "(2) assembling and maintaining a large study
23 population of individuals with Down syndrome;

24 "(3) expanding the number of clinical trials
25 that are inclusive of, or expressly for, individuals
26 with Down syndrome, including novel biomedical and

living;

pharmacological interventions and other therapies

designed to promote or enhance activities of daily

4 "(4) the biological mechanisms in individuals 5 with Down syndrome responsible for structural and 6 functional anomalies in cells, tissues, and organs, 7 cognitive and behavioral dysfunction, and stunted 8 growth; 9 "(5) the identification of biomarkers for the de-10 tection of risk factors, diagnosis, and customized 11 interventions and treatments for conditions co-occur-12 ring with Down syndrome; 13 "(6) why several co-occurring conditions, such 14 as Alzheimer's Disease and autoimmunity, are prev-15 alent in individuals with Down syndrome and how 16 such conditions can be treated concurrently with 17 Down syndrome; and 18 "(7) improving the quality of life of individuals 19 with Down syndrome and their families. "(c) COORDINATION; PRIORITIZING NONDUPLICA-20 21 TIVE RESEARCH.—The Secretary shall ensure that— 22 "(1) the programs and activities of the insti-23 tutes, centers, agencies, and offices of the National 24 Institutes of Health relating to Down Syndrome and 25 co-occurring conditions are coordinated, including •HR 7406 EH

4	((2) such institutes, centers, agencies, and of-
5	fices prioritize, as appropriate, Down syndrome re-

7	tivities of the National Institutes of Health.
8	"(d) TECHNICAL ASSISTANCE.—The Secretary shall
9	provide technical assistance to grantees and other involved
10	entities, as appropriate, for carrying out activities pursu-
11	ant to this section.
12	"(e) BIENNIAL REPORTS TO CONGRESS.—
13	"(1) IN GENERAL.—The Secretary shall submit,
14	on a biennial basis, to the Committee on Energy and
15	Commerce and the Subcommittee on Labor, Health

1	"(A) identification of the institute, center,
2	agency, office, or entity involved;
3	"(B) a statement of whether the research
4	is or was being carried out directly by the insti-
5	tute, center, agency, office, or entity or by mul-
6	tiple institutes, centers, agencies, offices, or en-
7	tities; and
8	"(C) identification of any resulting real
9	world evidence that is or may be used for clin-
10	ical research and medical care for patients with
11	Down syndrome.
12	"(f) Authorization of Appropriations.—
13	"(1) IN GENERAL.—To carry out this section,
14	there is authorized to be appropriated \$90,000,000
15	for each of fiscal years 2025 through 2029.
16	"(2) SUPPLEMENT, NOT SUPPLANT.—Funds
17	appropriated to carry out this section shall be used
18	to supplement, not supplant, other funds allocated
19	by the National Institutes of Health for research
20	and other activities relating to Down syndrome.".
