A BILL

To direct the Secretaries of Defense and of Veterans Affairs to take certain steps regarding research related to menopause, perimenopause, or mid-life women's health, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the "Servicewomen and Veter-
5 ans Menopause Research Act".

1 **SEC. 2. EVALUATION OF CERTAIN RESEARCH RELATED TO**
2 **MENOPAUSE, PERIMENOPAUSE, OR MID-LIFE**
3 **WOMEN'S HEALTH.**

4 (a) IN GENERAL.—The Secretary of Defense, in co-
5 ordination with Secretary of Veterans Affairs, shall evalu-
6 ate—

7 (1) the results of research, conducted by either
8 such Secretary, related to menopause,
9 perimenopause, or mid-life women's health that is
10 complete;

11 (2) the status of such research that is ongoing;
12 and

13 (3) any gaps in knowledge and research on—

14 (A) treatments for menopause-related
15 symptoms;

16 (B) the safety and effectiveness of treat-
17 ments for menopause-related symptoms;

18 (C) the relation to and impact of military
19 service to perimenopause and menopause;

20 (D) the effect of combat roles on
21 perimenopause and menopause-related symp-
22 toms, including exposure to burn pits, toxic
23 chemicals, and perfluoroalkyl and
24 polyfluoroalkyl substances (commonly known as
25 “PFAS”); and

(E) the impact perimenopause and menopause has on the mental health of women who are members of the Armed Forces or veterans.

4 (b) REPORT; STRATEGIC PLAN.—Not later than 180
5 days after the date of the enactment of this Act, each Sec-
6 retary shall submit to Congress—

7 (1) a report on the findings of such evaluation;

8 and

(A) resolves the gaps in knowledge and research identified in such report; and

(B) identifies topics in need of further research relating to potential treatments for menopause-related symptoms of women who are members of the Armed Forces or veterans.

16 SEC. 3. ADDITIONAL RESEARCH RELATED TO MENOPAUSE,
17 PERIMENOPAUSE, OR MID-LIFE WOMEN'S
18 HEALTH.

19 The Secretary of Defense and the Secretary of Sec-
20 retary of Veterans Affairs shall each conduct or fund re-
21 search related to menopause, perimenopause, or mid-life
22 health regarding women who are members of the Armed
23 Forces or veterans.
