Mr. GIMENEZ (for himself and Ms. WASSERMAN SCHULTZ) introduced the following bill; which was referred to the Committee on Natural Resources

A BILL

To direct the Secretary of Commerce to establish a grant program to support the restoration of coral reefs in South Florida.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SOUTH FLORIDA CORAL REEF RESTORATION**
4 **GRANT PROGRAM.**

5 (a) IN GENERAL.—The Secretary shall establish a
6 grant program to award amounts to eligible entities—

7 (1) to carry out coral reef restoration activities
8 in South Florida; or

9 (2) to reimburse such eligible entities for
10 amounts spent by such eligible entities to carry out

1 coral reef restoration activities in South Florida
2 within the 5 years preceding the date on which such
3 eligible entities are awarded a grant under this sec-
4 tion.

5 (b) APPLICATIONS.—To be eligible for a grant under
6 this section, an eligible entity shall submit to the Secretary
7 an application in such form, at such time, and containing
8 such information as the Secretary determines appropriate.

9 (c) GRANT AMOUNT LIMITATION.—The Secretary
10 may not award any single eligible entity more than
11 \$1,000,000 under this section in a single fiscal year.

12 (d) AUTHORIZATION OF APPROPRIATIONS.—There is
13 authorized to be appropriated to the Secretary to carry
14 out this section \$5,000,000 for each of fiscal years 2024
15 through 2028.

16 (e) DEFINITIONS.—In this section:

17 (1) CORAL REEF RESTORATION ACTIVITY.—The
18 term “coral reef restoration activity” means—

19 (A) the sexual propagation of coral to in-
20 crease diversity of genetic-based resiliency in
21 support of coral restoration; and

22 (B) the evacuation, rehabilitation, and re-
23 deployment of coral fragments.

24 (2) ELIGIBLE ENTITY.—The term “eligible enti-
25 ty”—

- 1 (A) means—
2 (i) a State;
3 (ii) a local municipality;
4 (iii) a nonprofit organization; and
5 (iv) a nongovernmental organization;
6 and
7 (B) includes the Mote Marine Laboratory.
- 8 (3) NONPROFIT ORGANIZATION.—The term
9 “nonprofit organization” means an organization—
10 (A) described in section 501(c)(3) of the
11 Internal Revenue Code of 1968; and
12 (B) exempt from taxation under section
13 501(a) of such Code.
- 14 (4) SECRETARY.—The term “Secretary” means
15 the Secretary of Commerce, acting through the Ad-
16 ministrator of the National Oceanic and Atmos-
17 pheric Administration.
- 18 (5) SOUTH FLORIDA.—The term “South Flor-
19 ida” means—
20 (A) all land and water within the adminis-
21 trative boundaries of the South Florida Water
22 Management District;
23 (B) regional coastal waters, including Bis-
24 cayne Bay, the Caloosahatchee Estuary, Florida

- 1 Bay, Indian River Lagoon, and St. Lucie River
- 2 Estuary; and
- 3 (C) the Florida Reef Tract.
