# A BILL

To amend the Elder Abuse Prevention and Prosecution Act to authorize the Elder Justice Initiative, to require that online resources of such initiative are made available in Spanish, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2   *tives of the United States of America in Congress assembled,*

3   **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Elder Abuse Protection  
5   Act of 2020”.

6   **SEC. 2. ELDER JUSTICE INITIATIVE.**

7       Section 101(b) of the Elder Abuse Prevention and  
8   Prosecution Act (34 U.S.C. 21711(b)) is amended to read  
9   as follows:

10      “(b) ELDER JUSTICE INITIATIVE.—

11       “(1) PERMANENT INITIATIVE.—The Attorney  
12   General shall establish within the Criminal Division  
13   an Elder Justice Initiative to coordinate criminal en-  
14   forcement and public engagement efforts to combat  
15   elder abuse, neglect, and financial fraud and scams  
16   that target elders, and to support and coordinate the  
17   efforts of the Elder Justice Coordinators designated  
18   under subsection (a).

19       “(2) DEPARTMENT OF JUSTICE ELDER JUSTICE  
20   COORDINATOR.—The Attorney General shall des-  
21   ignate an Elder Justice Coordinator within the De-  
22   partment of Justice who, in addition to any other re-  
23   sponsibilities, shall be responsible for—

24       “(A) coordinating and supporting the law  
25   enforcement efforts and policy activities as the

1 head of the Elder Justice Initiative for the De-  
2 partment of Justice on elder justice issues;

3 “(B) evaluating training models to deter-  
4 mine best practices and creating or compiling  
5 and making publicly available replication guides  
6 and training materials for law enforcement offi-  
7 cers, prosecutors, judges, emergency respond-  
8 ers, individuals working in victim services, adult  
9 protective services, social services, and public  
10 safety, medical personnel, mental health per-  
11 sonnel, financial services personnel, and any  
12 other individuals whose work may bring them in  
13 contact with elder abuse regarding how to—

14 “(i) conduct investigations in elder  
15 abuse cases;

16 “(ii) address evidentiary issues and  
17 other legal issues; and

18 “(iii) appropriately assess, respond to,  
19 and interact with victims and witnesses in  
20 elder abuse cases, including in administra-  
21 tive, civil, and criminal judicial pro-  
22 ceedings; and

23 “(C) carrying out such other duties as the  
24 Attorney General determines necessary in con-  
25 nection with enhancing the understanding, pre-

1 vention, and detection of, and response to, elder  
2 abuse.

3 “(3) ONLINE PUBLIC RESOURCES.—The Elder  
4 Justice Initiative shall maintain and publish on the  
5 internet, information aimed at protecting elders  
6 from fraudulent schemes and contain resources  
7 aimed at preventing elder abuse.

8 “(4) SPANISH LANGUAGE RESOURCES.—The  
9 Attorney General shall ensure that Elder Justice  
10 Initiative online resources are available in Spanish  
11 and link linguistically appropriate resources to in-  
12 form Spanish-speaking elders of Federal and State  
13 resources to combat fraud and abuse that targets  
14 the elderly, to include—

15 “(A) Spanish-language resources and links  
16 that help report instances of elder fraud and  
17 abuse to State and local law enforcement; and

18 “(B) resources that help prevent financial  
19 exploitation of elders.”.
