## A BILL

To award a Congressional Gold Medal to President Donald J. Trump in recognition of his exceptional leadership and dedication to strengthening America's diplomatic relations during his presidency.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

**3 SECTION 1. SHORT TITLE.**

4       This Act may be cited as the "President Donald J.  
5       Trump Congressional Gold Medal Act".

**6 SEC. 2. FINDINGS.**

7       Congress find the following:

1                     (1) On November 8, 2016, Donald J. Trump  
2 was elected the 45th President of the United States.

3                     (2) President Trump's time in office ushered in  
4 profound changes to United States diplomatic rela-  
5 tions with countries around the world.

6                     (3) On June 30, 2019, President Trump made  
7 history by becoming the first sitting United States  
8 President to cross into North Korea for a meeting  
9 with Kim Jong Un in the Demilitarized Zone (DMZ)  
10 between North and South Korea.

11                    (4) During this visit, President Trump facili-  
12 tated an unprecedented brief meeting between Kim  
13 Jong Un and South Korea's President Moon Jae-in.  
14 During his conversations, President Trump worked  
15 to resume stalled nuclear talks and expressed hope  
16 for peace between North and South Korea.

17                    (5) On September 15, 2020, President Trump  
18 established historic diplomatic relations between  
19 Israel and its neighbors in the Middle East through  
20 the Abraham Accords.

21                    (6) The Abraham Accords were a series of  
22 agreements to normalize relations between Israel  
23 and its regional neighbors. The Abraham Accords  
24 consisted of a general declaration that recognized

1       the importance of maintaining and strengthening  
2       peace in the Middle East.

3           (7) The general declaration was signed along-  
4       side bilateral agreements between Israel and the  
5       United Arab Emirates, Bahrain, and Morocco to  
6       normalize relations between the countries.

7           (8) President Trump commemorated the Abra-  
8       ham Accords by welcoming Israeli Prime Minister  
9       Benjamin Netanyahu, Minister of Foreign Affairs of  
10      Bahrain Dr. Abdullatif bin Rashid Al-Zayani, and  
11      Minister of Foreign Affairs for the United Arab  
12      Emirates Abdullah bin Zayed Al Nahyanisigns to  
13      the White House for the Abraham Accords Signing  
14      Ceremony.

15           (9) The greatest of President Trump's foreign  
16       policy achievements was that no wars were started  
17       while he was in office.

18 **SEC. 3. CONGRESSIONAL GOLD MEDALS.**

19           (a) PRESENTATION AUTHORIZATION.—The Speaker  
20      of the House of Representatives and the President pro  
21      tempore of the Senate shall make appropriate arrange-  
22      ments for the presentation, on behalf of the Congress, of  
23      a gold medal of appropriate design, to President Donald  
24      J. Trump, in recognition of his exceptional leadership and

1 dedication to strengthening America's diplomatic relations  
2 during his presidency.

3 (b) DESIGN AND STRIKING.—For the purposes of the  
4 presentation referred to in subsection (a), the Secretary  
5 of Treasury (referred to in this Act as the "Secretary")  
6 shall strike the gold medals with suitable emblems, de-  
7 vices, and inscriptions, to be determined by the Secretary.

8 **SEC. 4. DUPLICATE MEDALS.**

9 The Secretary may strike and sell duplicates in  
10 bronze of the gold medal struck pursuant to section 3  
11 under such regulations as the Secretary may prescribe, at  
12 a price sufficient to cover the cost thereof, including labor,  
13 materials, dies, use of machinery, and overhead expenses.

14 **SEC. 5. STATUS OF MEDALS.**

15 (a) NATIONAL MEDALS.—The medals struck pursu-  
16 ant to this Act are national medals for purposes of chapter  
17 51 of title 31, United States Code.

18 (b) NUMISMATIC ITEMS.—For purposes of sections  
19 5134 and 5136 of title 31, United States Code, all medals  
20 struck under this Act shall be considered to be numismatic  
21 items.

22 **SEC. 6. AUTHORITY TO USE FUND AMOUNTS; PROCEEDS OF**  
23 **SALE.**

24 (a) AUTHORITY To USE FUND AMOUNTS.—There is  
25 authorized to be charged against the United States Mint

1 Public Enterprise Fund such amounts as may be nec-  
2 essary to pay for the costs of the medals struck pursuant  
3 to this Act.

4 (b) PROCEEDS OF SALE.—The amounts received  
5 from the sale of duplicate bronze medals authorized under  
6 section 4 shall be deposited into the United States Mint  
7 Public Enterprise Fund.
