## A BILL

To amend the Infrastructure Investment and Jobs Act to modify the requirements for an eligible project under the competitive grant program for large-scale water recycling and reuse projects, to provide for an additional authorization of appropriations for that program, to repeal the termination of authority for that program, and for other purposes.

2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Facilitating Large-  
3 Scale Water Recycling and Reuse Projects Act”.

4 **SEC. 2. ADDITIONAL REQUIREMENTS FOR ELIGIBLE**  
5 **PROJECTS, REPEAL OF TERMINATION OF AU-**  
6 **THORITY, AND ADDITIONAL AUTHORIZATION**  
7 **OF APPROPRIATIONS FOR COMPETITIVE**  
8 **GRANT PROGRAM FOR LARGE-SCALE WATER**  
9 **RECYCLING AND REUSE PROJECTS.**

10 (a) **ELIGIBLE PROJECT.**—Section 40905(c) of the In-  
11 frastructure Investment and Jobs Act (43 U.S.C. 3205(c))  
12 is amended by striking paragraph (4) and inserting the  
13 following:

14 “(4) is—

15 “(A) constructed, operated, and main-  
16 tained by an eligible entity; or

17 “(B) owned by an eligible entity; and”.

18 (b) **REPEAL OF TERMINATION OF AUTHORITY; ADDI-**  
19 **TIONAL AUTHORIZATION OF APPROPRIATIONS.**—Section  
20 40905 of the Infrastructure Investment and Jobs Act (43  
21 U.S.C. 3205) is amended by striking subsection (k) and  
22 inserting the following:

23 “(k) **AUTHORIZATION OF APPROPRIATIONS.**—In ad-  
24 dition to the amounts made available to carry out this sec-  
25 tion under section 40901(4)(B), there is authorized to be

- 1 appropriated to carry out this section \$700,000,000, to
- 2 remain available until expended.”.
