## A BILL

To prohibit the Secretary of Homeland Security from using Federal funds to establish the ICE Secure Docket Card program and to prohibit the use of documentation issued in connection with immigration proceedings to establish eligibility for Federal public benefits.

1       *Be it enacted by the Senate and House of Representa-  
2       tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “No Taxpayer Funds  
5       for Illegal Immigrant Identity Cards Act”.

**1 SEC. 2. PURPOSES.**

2       The purposes of this Act are to prohibit the Secretary  
3 of Homeland Security from using Federal funds to estab-  
4 lish the ICE Secure Docket Card program or any other  
5 Federal program that issues free identity cards to aliens  
6 who are unlawfully present in the United States.

**7 SEC. 3. PROHIBITIONS.**

8       (a) ICE SECURE DOCKET CARD.—Notwithstanding  
9 any other provision of law, no Federal funds may be used  
10 to establish, implement, or otherwise support the activities  
11 of the U.S. Immigration and Customs Enforcement Se-  
12 cure Docket Card program or of any other similar pro-  
13 gram of the Department of Homeland Security.

14       (b) PROOF OF IDENTIFICATION.—No documentation,  
15 in any form, which was issued for the primary purpose  
16 of providing access to information regarding the status of  
17 an individual's immigration proceedings, may be used as  
18 proof of identification for the purpose of establishing eligi-  
19 bility for any Federal public benefit (as defined in section  
20 401(c) of the Personal Responsibility and Work Oppor-  
21 tunity Reconciliation Act of 1996 (8 U.S.C. 1611(c))).

**22 SEC. 4. REPORT.**

23       Not later than 6 months after the date of enactment  
24 of this Act, the Inspector General of the Department of  
25 Homeland Security shall submit a report to the Committee  
26 on Homeland Security and Governmental Affairs of the

1 Senate and the Committee on Homeland Security of the  
2 House of Representatives that describes the establish-  
3 ment, operation, and any costs associated with the ICE  
4 Secure Docket Card program or any other Federal pro-  
5 gram that issues free identity cards to aliens who are un-  
6 lawfully present in the United States.
