Mr. ARRINGTON (for himself, Mr. CUELLAR, Mr. BABIN, Mr. WILLIAMS of Texas, Mr. WRIGHT, Mr. JACKSON, and Mr. WEBER of Texas) introduced the following bill; which was referred to the Committee on Transportation and Infrastructure

## A BILL

To designate the Rocksprings Station of the U.S. Border Patrol located on West Main Street in Rocksprings, Texas, as the “Donna M. Doss Border Patrol Station”.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Donna M. Doss Memo-  
5       rial Act of 2021”.

6       **SEC. 2. FINDINGS.**

7       Congress finds the following:

1           (1) A native of the State of Washington, Agent  
2 Donna Marie Doss—

3           (A) proudly and honorably served her  
4 country as an Agent of the U.S. Border Patrol  
5 for more than 15 years;

6           (B) began her service with the U.S. Border  
7 Patrol in 2003; and

8           (C) graduated as part of the 569th Session  
9 of the Border Patrol Academy with Class 584  
10 on June 6, 2005.

11          (2) Agent Doss—

12           (A) served on a Drug Enforcement Admin-  
13 istration Task Force on the southern border for  
14 3 years before being assigned to the northern  
15 border;

16           (B) was promoted to Supervisory Border  
17 Patrol Agent in Laredo Border Patrol Sector,  
18 where she was named an Operations Officer in  
19 2016; and

20           (C) relocated to Abilene, Texas in 2017,  
21 where she served as a Resident Agent.

22          (3) On February 2, 2019, Agent Doss re-  
23 sponded to a call for assistance from the Texas De-  
24 partment of Public Safety near Interstate 20 in Tye,

1 Texas. While on scene, Agent Doss was struck and  
2 killed by a passing vehicle.

3 (4) Agent Doss is survived by her husband, fa-  
4 ther, mother, 2 step-children, a sister and a brother.

5 **SEC. 3. DESIGNATION.**

6 The Rocksprings station of the U.S. Border Patrol  
7 located on West Main Street in Rocksprings, Texas, shall  
8 be known and designated as the “Donna M. Doss Border  
9 Patrol Station”.

10 **SEC. 4. REFERENCES.**

11 Any reference in a law, map, regulation, document,  
12 paper, or other record of the United States to the station  
13 described in section 3 shall be deemed to be a reference  
14 to the “Donna M. Doss Border Patrol Station”.
