A BILL

To direct the Secretary of Transportation to establish a national aviation preparedness plan for communicable disease outbreaks, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “National Aviation Pre-*
5 *paredness Plan Act of 2022”.*

6 **SEC. 2. NATIONAL AVIATION PREPAREDNESS PLAN.**

7 *(a) IN GENERAL.—Not later than 2 years after the*
8 *date of enactment of this Act, the Secretary of Transpor-*
9 *tation, in coordination with the Secretary of Health and*
10 *Human Services, the Secretary of Homeland Security, and*
11 *the heads of such other Federal departments or agencies as*
12 *the Secretary of Transportation considers appropriate,*
13 *shall develop a national aviation preparedness plan for*
14 *communicable disease outbreaks.*

15 *(b) CONTENTS OF PLAN.—The plan developed under*
16 *subsection (a) shall, at a minimum—*

17 *(1) provide airports and air carriers with an*
18 *adaptable and scalable framework with which to align*
19 *the individual plans, including the emergency re-*
20 *sponse plans, of such airports and air carriers and*
21 *provide guidance as to each individual plan;*

22 *(2) improve coordination among airports, air*
23 *carriers, U.S. Customs and Border Protection, the*
24 *Centers for Disease Control and Prevention, other ap-*
25 *propriate Federal entities, and State and local gov-*

1 *ernments and health agencies with respect to pre-*
2 *paring for and responding to communicable disease*
3 *outbreaks;*

4 *(3) to the extent practicable, improve coordina-*
5 *tion among relevant international entities;*

6 *(4) create a process to identify appropriate per-*
7 *sonal protective equipment, if any, for covered em-*
8 *ployees to reduce the likelihood of exposure to a cov-*
9 *ered communicable disease, and thereafter issue rec-*
10 *ommendations for the equipage of such employees;*

11 *(5) create a process to identify appropriate tech-*
12 *niques, strategies, and protective infrastructure, if*
13 *any, for the cleaning, disinfecting, and sanitization of*
14 *aircraft and enclosed facilities owned, operated, or*
15 *used by an air carrier or airport, and thereafter issue*
16 *recommendations pertaining to such techniques, strat-*
17 *egies, and protective infrastructure;*

18 *(6) identify and assign Federal agency roles in*
19 *the deployment of emerging and existing technologies*
20 *and solutions to reduce covered communicable diseases*
21 *in the aviation ecosystem;*

22 *(7) clearly delineate the responsibilities of the*
23 *sponsors and operators of airports, air carriers, and*
24 *Federal agencies in responding to a covered commu-*
25 *nicable disease;*

1 (8) *incorporate, as appropriate, the rec-*
2 *ommendations made by the Comptroller General of*
3 *the United States to the Secretary of Transportation*
4 *contained in the report titled “Air Travel and Com-*
5 *municable Diseases: Comprehensive Federal Plan*
6 *Needed for U.S. Aviation System’s Preparedness”,*
7 *issued in December 2015 (GAO-16-127);*

8 (9) *consider the latest peer-reviewed scientific*
9 *studies that address communicable disease with re-*
10 *spect to air transportation; and*

11 (10) *consider funding constraints.*

12 (c) *CONSULTATION.*—*When developing the plan under*
13 *subsection (a), the Secretary of Transportation shall consult*
14 *with aviation industry and labor stakeholders, including*
15 *representatives of—*

16 (1) *air carriers, which shall include domestic air*
17 *carriers consisting of major air carriers, low-cost car-*
18 *riers, regional air carriers and cargo carriers;*

19 (2) *airport operators, including with respect to*
20 *large hub, medium hub, small hub, and nonhub com-*
21 *mercial service airports;*

22 (3) *labor organizations that represent airline pi-*
23 *lots, flight attendants, air carrier airport customer*
24 *service representatives, and air carrier maintenance,*
25 *repair, and overhaul workers;*

1 (4) *the labor organization certified under section*
2 *7111 of title 5, United States Code, as the exclusive*
3 *bargaining representative of air traffic controllers of*
4 *the Federal Aviation Administration;*

5 (5) *the labor organization certified under such*
6 *section as the exclusive bargaining representative of*
7 *airway transportation systems specialists and avia-*
8 *tion safety inspectors of the Federal Aviation Admin-*
9 *istration;*

10 (6) *trade associations representing air carriers*
11 *and airports;*

12 (7) *aircraft manufacturing companies; and*

13 (8) *such other stakeholders as the Secretary con-*
14 *siders appropriate.*

15 (d) *REPORT.*—*Not later than 30 days after the plan*
16 *is developed under subsection (a), the Secretary shall submit*
17 *to the Committee on Transportation and Infrastructure of*
18 *the House of Representatives and the Committee on Com-*
19 *merce, Science, and Transportation of the Senate a report*
20 *that includes such plan.*

21 (e) *REVIEW OF PLAN.*—*Not later than 1 year after the*
22 *date on which a report is submitted under subsection (d),*
23 *and again not later than 5 years thereafter, the Secretary*
24 *shall review the plan included in such report and, after con-*
25 *sultation with aviation industry and labor stakeholders,*

1 *make changes by rule as the Secretary considers appro-*
2 *priate.*

3 (f) *GAO STUDY.*—*Not later than 18 months after the*
4 *date of enactment of this Act, the Comptroller General shall*
5 *conduct and submit to the Committee on Transportation*
6 *and Infrastructure of the House of Representatives and the*
7 *Committee on Commerce, Science, and Transportation of*
8 *the Senate a study assessing the national aviation pre-*
9 *paredness plan developed under subsection (a), including—*

10 (1) *whether such plan—*

11 (A) *is responsive to any previous rec-*
12 *ommendations relating to aviation preparedness*
13 *with respect to an outbreak of a covered commu-*
14 *nicable disease or global health emergency made*
15 *by the Comptroller General; and*

16 (B) *meets the obligations of the United*
17 *States under international conventions and trea-*
18 *ties; and*

19 (2) *the extent to which the United States avia-*
20 *tion system is prepared to respond to an outbreak of*
21 *a covered communicable disease.*

22 (g) *DEFINITIONS.*—*In this section:*

23 (1) *COVERED EMPLOYEE.*—*The term “covered*
24 *employee” means—*

1 (A) *an individual whose job duties require*
2 *interaction with air carrier passengers on a reg-*
3 *ular and continuing basis and who is an em-*
4 *ployee of—*

5 *(i) an air carrier;*

6 *(ii) an air carrier contractor;*

7 *(iii) an airport; or*

8 *(iv) the Federal Government; or*

9 (B) *an air traffic controller or systems safe-*
10 *ty specialist of the Federal Aviation Administra-*
11 *tion.*

12 (2) *COVERED COMMUNICABLE DISEASE.—The*
13 *term “covered communicable disease” means a com-*
14 *municable disease that has the potential to cause a fu-*
15 *ture epidemic or pandemic of infectious disease that*
16 *would constitute a public health emergency of inter-*
17 *national concern as declared, after the date of enact-*
18 *ment of this Act, by the Secretary of Health and*
19 *Human Services under section 319 of the Public*
20 *Health Service Act (42 U.S.C. 247d).*
