## A BILL

To direct the Secretary of Health and Human Services to conduct a public outreach campaign to inform individuals covered under a group health plan or group or individual health insurance coverage of Federal requirements relating to mental health and substance use disorder crisis services, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2        This Act may be cited as the “Access to Mental  
3    Health Services Act”.

4 **SEC. 2. OUTREACH AND REPORT ON ACCESS TO MENTAL**

5                   **HEALTH AND SUBSTANCE USE DISORDER**

6                   **CRISIS SERVICES UNDER GROUP HEALTH**

7                   **PLANS AND HEALTH INSURANCE COVERAGE.**

8        (a) **OUTREACH.**—Not later than January 1, 2024,  
9    the Secretaries of Health and Human Services, Labor,  
10   and the Treasury shall initiate a joint public outreach  
11   campaign to inform individuals covered under a group  
12   health plan or group or individual health insurance cov-  
13   erage (as such terms are defined in section 2791 of the  
14   Public Health Service Act (42 U.S.C. 300gg–91)) of Fed-  
15   eral requirements relating to the availability of, and limi-  
16   tations on the imposition of financial requirements or  
17   treatment limitations for, benefits for mental health and  
18   substance use disorder crisis services under such plans and  
19   coverages. Such outreach shall emphasize the benefits of  
20   such mental health and substance use disorder crisis serv-  
21   ices, including improved individual well-being, and seek to  
22   reduce perceived stigma associated with accessing such  
23   mental health and substance use disorder crisis services.

24        (b) **REPORT.**—Not later than January 1, 2024, the  
25   Secretaries of Health and Human Services, Labor, and  
26   the Treasury shall submit to Congress a joint report on—

1                         (1) coverage of mental health and substance use  
2 disorder crisis services under a group health plan or  
3 group or individual health insurance coverage, in-  
4 cluding—

5                             (A) which mental health and substance use  
6 disorder services are covered as crisis services;

7                             (B) the type of health care providers fur-  
8 nishing such services; and

9                             (C) common reimbursement approaches  
10 and billing codes used with respect to such serv-  
11 ices;

12                         (2) barriers to individuals covered under a  
13 group health plan or group or individual health in-  
14 surance coverage accessing mental health and sub-  
15 stance use disorder crisis services, including geo-  
16 graphic barriers and barriers caused by a limited  
17 availability of such mental health and substance use  
18 disorder crisis services in certain service areas; and

19                         (3) issues relating to unexpected bills such indi-  
20 viduals may receive after being furnished such serv-  
21 ices in certain service settings.

22                         (c) FUNDING.—In addition to amounts otherwise  
23 available for such purposes, there is appropriated

- 1 \$20,000,000, to remain available until expended, for pur-
- 2 poses of carrying out this section.
