A BILL

To direct the Secretary of State and the Administrator of the United States Agency for International Development to promulgate regulations to require all implementing partners receiving foreign assistance funds with activities in Afghanistan to submit a report on any payments or withholdings, including for taxes, fees, duties, and utilities, made to the Taliban, state-owned enterprises, or governing institutions in Afghanistan, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Protecting Taxpayer
5 Dollars from Taliban Theft Act”.

6 **SEC. 2. FINDINGS.**

7 Congress makes the following findings:

8 (1) A May 2024 report by the Special Inspector
9 General for Afghanistan Reconstruction (SIGAR)
10 found that the Department of State and the United
11 States Agency for International Development
12 (USAID) do not know the full scope of the taxes,
13 fees, duties, and utilities paid to the Taliban using
14 United States-funded assistance in Afghanistan.

15 (2) Despite requirements in the Department of
16 State’s Foreign Assistance Directive and USAID’s
17 Acquisitions Regulations and Automatic Directives
18 System, the Department of State and USAID do not
19 include tax reporting clauses in all eligible awards
20 globally, and even then, only require reporting on
21 certain value-added tax and customs duties, rather
22 than all forms of taxation.

23 **SEC. 3. STATEMENT OF POLICY.**

24 It is the policy of the United States that United
25 States taxpayer dollars should not be paid to the Taliban,

1 nor should United States funding directly benefit the
2 Taliban.

3 **SEC. 4. REGULATIONS TO REQUIRE CERTAIN REPORTS**
4 **FROM IMPLEMENTING PARTNERS.**

5 (a) IN GENERAL.—Not later than 180 days after the
6 date of the enactment of this Act—

7 (1) the Secretary of State shall promulgate reg-
8 ulations to require all implementing partners receiv-
9 ing foreign assistance funds from the Department of
10 State with activities in Afghanistan to submit to the
11 Department a report on any payments or
12 withholdings, including for taxes, fees, duties, and
13 utilities, made to the Taliban, state-owned enter-
14 prises, or governing institutions in Afghanistan; and

15 (2) the Administrator of USAID shall promul-
16 gate regulations to require all implementing partners
17 receiving foreign assistance funds from USAID with
18 activities in Afghanistan to submit to USAID a re-
19 port on any payments or withholdings, including for
20 taxes, fees, duties, and utilities, made to the
21 Taliban, state-owned enterprises, or governing insti-
22 tutions in Afghanistan.

23 (b) EXISTING CONTRACTS, GRANTS, AND OTHER
24 FUNDING AWARDS.—Not later than 180 days after the
25 date of the enactment of this Act, the Secretary of State

1 and the Administrator of USAID shall amend existing
2 contracts, grants, and other funding awards relating to
3 Afghanistan to include provisions to prohibit imple-
4 menting partners from making any payments or
5 withholdings, including for taxes, fees, duties, and utili-
6 ties, to the Taliban, state-owned enterprises, or governing
7 institutions in Afghanistan.

8 **SEC. 5. REPORT.**

9 (a) IN GENERAL.—Not later than 1 year after the
10 date of the enactment of this Act, and every 180 days
11 thereafter, the Secretary of State and the Administrator
12 of USAID shall submit to the appropriate congressional
13 committees a report that includes a description of any pay-
14 ments or withholdings, including for taxes, fees, duties,
15 and utilities, made by implementing partners to the
16 Taliban, state-owned enterprises, or governing institutions
17 in Afghanistan, including—

18 (1) an identification of—

19 (A) the implementing partner making the
20 payment;

21 (B) the state-owned enterprise or gov-
22 erning institution to which the payment was
23 made;

24 (2) the type of payment made; and

25 (3) the amount of the payment.

1 (b) APPROPRIATE CONGRESSIONAL COMMITTEES

2 DEFINED.—In this section, the term “appropriate con-

3 gressional committees” means—

4 (1) the Committee on Foreign Affairs of the
5 House of Representatives; and

6 (2) the Committee on Foreign Relations of the
7 Senate.
