## A BILL

To provide for the hiring and training of certain personnel at the Department of Homeland Security, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-  
2 tives of the United States of America in Congress assembled,*

**3 SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Renewed Hope Act  
5 of 2024”.

1     **SEC. 2. IMAGE AUDIO FORENSICS HIRING AND TRAINING**

2                 **PROGRAMS AT THE DEPARTMENT OF HOME-**

3                 **LAND SECURITY.**

4         (a) ADDITIONAL PERSONNEL.—The Secretary of  
5 Homeland Security shall hire, train, and assign not fewer  
6 than—

7                     (1) 40 computer forensics analysts to the Vic-  
8 tim Identification Laboratory of the Child Exploi-  
9 tation Investigations Unit of Homeland Security In-  
10 vestigations;

11                  (2) 30 criminal analysts to the Victim Identifi-  
12 cation Laboratory of the Child Exploitation Inves-  
13 tigations Unit of Homeland Security Investigations;  
14 and

15                  (3) 130 additional computer forensics analysts  
16 and criminal analysts to support identification and  
17 rescue of victims of child sexual exploitation and  
18 abuse at offices of the Special Agent in Charge of  
19 Homeland Security Investigations.

20         (b) EMPLOYMENT OF EXPERTS AND CONSULT-  
21 ANTS.—Section 890A of the Homeland Security Act of  
22 2002 (6 U.S.C. 473) is amended—

23                  (1) by redesignating subsection (g) as sub-  
24 section (i); and

25                  (2) by inserting after subsection (f) the fol-  
26 lowing:

1       “(g) EMPLOYMENT OF EXPERTS AND CONSULT-  
2 ANTS.—

3           “(1) IN GENERAL.—In accordance with section  
4 3109 of title 5, United States Code, at daily rates  
5 not to exceed the equivalent rate prescribed for  
6 grade GS–15 of the General Schedule under section  
7 5332 of such title, the Secretary may procure by  
8 contract the temporary (not in excess of 1 year) or  
9 intermittent services of experts or consultants to  
10 provide image and audio forensic analysis related to  
11 victim identification to support efforts to identify, lo-  
12 cate, and rescue children seen in abusive images.

13           “(2) PLACEMENT.—The Secretary shall pro-  
14 mulgate guidelines for assigning or detailing partici-  
15 pants to positions at the Center, offices of the Spe-  
16 cial Agent in Charge, offices of the Resident Agent  
17 in Charge, and attaché offices.”.

18 **SEC. 3. DECONFLICITION OF CHILD SEXUAL EXPLOITATION**  
19                           **AND ABUSE INVESTIGATIONS WITHIN THE**  
20                           **DEPARTMENT OF HOMELAND SECURITY.**

21       Section 890A of the Homeland Security Act of 2002  
22 (6 U.S.C. 473) is amended by inserting after subsection  
23 (a)(2) the following:

24           “(3) COORDINATION.—The Secretary shall,  
25 with the concurrence of the directors of affected

1       agencies within the Department, establish joint pro-  
2       cedures to deconflict, coordinate, and synchronize  
3       child sexual exploitation investigations with the Cen-  
4       ter.”.

5       **SEC. 4. VICTIM IDENTIFICATION TRAINING PROGRAM.**

6           (a) IN GENERAL.—The Secretary of Homeland Secu-  
7       rity shall establish a Victim Identification Training Pro-  
8       gram (referred to in this section as the “Program”) in  
9       the Cyber Crimes Center.

10          (b) PROGRAM.—The Program shall provide training  
11       on new and advanced technology used to identify victims  
12       to—

13              (1) U.S. Immigration and Customs Enforce-  
14       ment personnel; and

15              (2) Federal, State, local, Tribal, military, and  
16       foreign law enforcement agency personnel engaged  
17       in the investigation of crimes within their respective  
18       jurisdictions, upon request and subject to the avail-  
19       ability of funds.

20          (c) FUNCTIONS.—The functions of the Program shall  
21       include—

22              (1) annual training for a minimum of 24  
23       Homeland Security Investigations special agents and  
24       analysts focused on—

- 1                   (A) training on the most current tools and  
2                   techniques used in victim identification; and  
3                   (B) training on the capabilities of the  
4                   Video Identification Laboratory; and  
5                   (2) increasing personnel knowledge on how to  
6                   conduct audio and video enhancements.

○
