## A BILL

To establish a process to furnish to State educational agencies certain demographic data regarding members of the Armed Forces.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Military and Edu-  
5       cational Data Integration Act”.

6       **SEC. 2. PROCESS TO FURNISH CERTAIN DEMOGRAPHIC**  
7    **DATA REGARDING MEMBERS OF THE ARMED**  
8    **FORCES TO STATE EDUCATIONAL AGENCIES.**

9       (a) ESTABLISHMENT.—The Secretaries concerned, in  
10      consultation with the Secretary of Education, State edu-

1 cational agencies, local educational agencies, and experts  
2 in student data and privacy, shall, not later than 18  
3 months after the date of enactment of this Act, establish  
4 a data sharing process that enables a State educational  
5 agency to—

6 (1) access data described in subsection (b) at-  
7 tributable to individuals who graduated high school  
8 in the State of such State educational agency; and

9 (2) integrate such data into—

10 (A) such State's statewide longitudinal  
11 data system; or

12 (B) an alternate data system operated by  
13 such State.

14 (b) DATA DESCRIBED.—The data described in this  
15 paragraph may include the following information:

16 (1) With respect to an individual who is a mem-  
17 ber of an Armed Force who graduated from sec-  
18 ondary school:

19 (A) The highest level of education at-  
20 tained.

21 (B) The name and location of the edu-  
22 cational institution where the member received  
23 education described in subparagraph (A).

1                             (C) The name and location of the sec-  
2                             ondary school from which the individual grad-  
3                             uated.

4                             (D) Score on the Armed Forces Qualifica-  
5                             tion Test.

6                             (E) The date the member joined an Armed  
7                             Force.

8                             (F) The Armed Force of the member.

9                             (G) Rank.

10                            (H) The area of expertise or military occu-  
11                             pational specialty.

12                            (I) The date of separation, if applicable.

13                            (J) Any other information determined ap-  
14                             propriate by the Secretary concerned.

15                            (2) With respect to an individual who grad-  
16                             uated from secondary school and whose application  
17                             to join an Armed Force was denied:

18                            (A) The highest level of education at-  
19                             tained.

20                            (B) The name and location of the school  
21                             where the individual received education de-  
22                             scribed in subparagraph (A).

23                            (C) The name and location of the sec-  
24                             ondary school from which the individual grad-  
25                             uated.

1                             (D) Score on the Armed Forces Qualifica-  
2                             tion Test.

3                         (c) PRIVACY.—Data transmitted through the data  
4     sharing process under subsection (a) shall be transmitted  
5     confidentially. The Secretaries concerned shall carry out  
6     such subsection in a manner that protects individual pri-  
7     vacy and data security, in accordance with applicable Fed-  
8     eral, State, and local privacy laws.

9                         (d) DEFINITIONS.—In this section:

10                         (1) The term “Secretary concerned” means—

11                             (A) the Secretary of Defense; or  
12                             (B) the Secretary of Homeland Security.

13                         (2) The terms “local educational agency”, “sec-  
14     ondary school”, and “State educational agency”  
15     have the meanings given such terms in section 8101  
16     of the Elementary and Secondary Education Act of  
17     1965 (20 U.S.C. 7801).
