RESOLUTION

Of inquiry directing the Secretary of Homeland Security to provide certain documents in his possession to the House of Representatives relating to immigration enforcement and border security.

- 1 *Resolved, That the Secretary of Homeland Security of*
- 2 *the United States is directed to transmit to the House of*
- 3 *Representatives, not later than fourteen days after the date*

1 of adoption of this resolution, copies of any document,
2 record, audio recording, memorandum, call log, correspond-
3 ence (electronic or otherwise), or other communication in
4 his possession, or any portion of any document, record,
5 audio recording, memorandum, call log, correspondence
6 (electronic or otherwise), or other communication, that re-
7 fers or relates to the following:

8 (1) The number of illegal aliens on the no-fly list
9 or the Federal Bureau of Investigation's Terrorist
10 Screening Database who have been encountered by
11 United States Government personnel at the southwest
12 border, between ports of entry since January 20,
13 2021.

14 (2) The number of illegal aliens on the no-fly list
15 or the Federal Bureau of Investigation's Terrorist
16 Screening Database who have been encountered by
17 United States Government personnel at the southwest
18 border, between ports of entry since January 20,
19 2021, and were subsequently released into the interior
20 of the United States.

21 (3) The nationality of, and a description of the
22 conduct for which, each alien on the no-fly list or the
23 Federal Bureau of Investigation's Terrorist Screening
24 Database who has been encountered by United States
25 Government personnel at the southwest border, be-

1 *tween ports of entry, and subsequently released in the*
2 *United States, was placed on the no-fly list or the*
3 *Federal Bureau of Investigation's Terrorist Screening*
4 *Database.*

5 *(4) Of the aliens described in paragraph (1) who*
6 *were placed into U.S. Immigration and Customs En-*
7 *forcement detention, the length of detention and loca-*
8 *tion of detention for each alien.*

9 *(5) Of the aliens described in paragraph (1), the*
10 *number expelled pursuant to section 362 of the Public*
11 *Health Service Act (42 U.S.C. 265), ordered removed,*
12 *granted voluntary departure, removed pursuant to ex-*
13 *pedited removal, removed pursuant to a reinstated re-*
14 *moval order, and the country to which each was re-*
15 *moved.*

16 *(6) Of the aliens described in paragraph (1), the*
17 *number referred to the Department of Justice for*
18 *prosecution under section 275(a) or 276(a) of the Im-*
19 *migration and Nationality Act (8 U.S.C. 1325(a); 8*
20 *U.S.C. 1326(a)).*

21 *(7) The current status of each case for aliens de-*
22 *scribed in paragraph (1) who are still in the United*
23 *States.*
