9 (A) *the amount of copper or recognized crit-*
10 *ical minerals found; and*

11 (B) *minerals needed for infrastructure, re-*
12 *newable energy, or electric vehicle production.*

13 (2) *All documents and communications referring*
14 *or relating to initiating the mineral withdrawal proc-*
15 *ess within Superior National Forest.*

16 (3) *All documents and communications relating*
17 *to the impact of the mineral withdrawal on Twin*
18 *Metals operation, including but not limited to any*

20 (A) *preventing production of minerals;*

21 (B) *union project labor agreements; and*

22 (C) *the loss of economic benefits at the State*

9 (A) *national security implications;*

10 (B) *mineral supply chain stability implica-*
11 *tions;*

12 (C) *increased dependence on foreign min-*
13 *erals; and*

14 (D) *the economic losses at the State and*
15 *local level.*
