17 *Act (15 U.S.C. 9009b), and from grants under section*  
18 *5003 of the American Rescue Plan Act of 2021, all*  
19 *documents and communications relating to the*  
20 *amount of funds from such loans or grants that have*  
21 *been recovered from any individual or entity that*  
22 *fraudulently obtained such a loan or grant; and*

23 (5) *with respect to actions taken by the Depart-*  
24 *ment of the Treasury on and after January 21, 2021,*  
25 *to assist small business concerns (as defined under*

1        *section 3 of the Small Business Act (15 U.S.C. 632))*  
2        *with addressing government regulations, and all such*  
3        *communications between the Secretary of the Treas-*  
4        *ury and the Administrator of the Small Business Ad-*  
5        *ministration relating to any guidance the Adminis-*  
6        *tration offered Treasury in targeting regulatory as-*  
7        *sistance to small business concerns.*
