RESOLUTION

Requiring Members of the House of Representatives to serve one shift in a passenger seat of a law enforcement vehicle observing the work day of a local law enforcement officer once during the first term of a Member in the House, and for other purposes.

1 *Resolved,*

2 **SECTION 1. SHORT TITLE.**

3 This resolution may be cited as the “Ride-Along Res-
4 olution”.

1 **SEC. 2. REQUIREMENT FOR MEMBERS OF THE HOUSE OF**
2 **REPRESENTATIVES TO PARTICIPATE IN ONE**
3 **RIDE-ALONG DURING FIRST TERM IN THE**
4 **HOUSE.**

5 (a) IN GENERAL.—With respect to any Member of
6 the House of Representatives serving a first term as a
7 Member of the House, each such Member shall participate
8 in one ride-along in the respective congressional district
9 of the Member not later than 1 year after the date such
10 Member is sworn in as a Member of the House.

11 (b) REGULATIONS.—The Committee on House Ad-
12 ministration shall promulgate regulations to carry out this
13 resolution.

14 (c) VIOLATION.—If the Committee on Ethics deter-
15 mines that a Member has not satisfied the requirement
16 under subsection (a) by the deadline described in such
17 subsection, the Committee shall—

18 (1) publish the name of the Member on a read-
19 ily available, public list on the website of the Com-
20 mittee that identifies Members who have not satis-
21 fied such requirement; and

22 (2) cause to be published in the Congressional
23 Record information with respect to the failure of the
24 Member to satisfy such requirement.

25 (d) DEFINITIONS.—In this section:

1 (1) RIDE-ALONG.—The term “ride-along”
2 means an arrangement for a Member of the House
3 of Representatives to serve one shift in a passenger
4 seat of a law enforcement vehicle observing the work
5 day of a local law enforcement officer in the respec-
6 tive congressional district of such Member.

7 (2) MEMBER OF THE HOUSE OF REPRESENTA-
8 TIVES.—The term “Member of the House of Rep-
9 resentatives” includes a Delegate or Resident Com-
10 missioner to the Congress.

11 (e) EFFECTIVE DATE.—This section shall apply with
12 respect to the One Hundred Eighteenth Congress and
13 each succeeding Congress.
