6 or video recording, machine readable material, computer-  
7 ized, digitized, or electronic information created on or  
8 after January 21, 2021, under the control of the President  
9 or the Secretary, respectively, that pertains to the Depart-  
10 ment of Defense and contains any of the following terms  
11 or phrases:

- 13           (2) Gender identity.
- 14           (3) Gender transition.
- 15           (4) Gender reassignment.
- 16           (5) Gender affirming.
