RESOLUTION

Condemning the attempted assassination of former President Donald J. Trump at the Trump International Golf Club in West Palm Beach, Florida, and honoring the Martin County Sheriff's Office for their rapid response and bravery in apprehending the would-be assassin.

Whereas, on September 15, 2024, an attempt was made on the life of former President Donald J. Trump at the Trump International Golf Club in West Palm Beach, Florida;

Whereas such heinous acts of political violence threaten and undermine the core values and stability of democracy and the peaceful discourse upon which the United States was founded;

Whereas former President Donald J. Trump served as the 45th President of the United States and continues to be a leading figure in American political life;

Whereas deputies and officers from the Martin County Sheriff's Office responded rapidly to the threat and demonstrated exceptional bravery, professionalism, and heroism; and

Whereas the swift actions of the Martin County Sheriff's Office led to the successful apprehension of the would-be assassin, preventing further harm: Now, therefore, be it
