# RESOLUTION

Of inquiry requesting the President and directing the Attorney General to transmit, respectively, certain documents

to the House of Representatives relating to communications with the government of Russia.

1        *Resolved*, That the President is requested, and the At-  
2        torney General of the United States is directed, to trans-  
3        mit, respectively (in a manner appropriate to classified in-  
4        formation, if the President or Attorney General deter-  
5        mines appropriate), to the House of Representatives, not  
6        later than 14 days after the date of the adoption of this  
7        resolution, copies of any document, record, memo, cor-  
8        respondence, or other communication in their possession,  
9        or any portion of any such communication, that refers or  
10       relates to the following:

11            (1) Any meeting or communication that oc-  
12            curred between Jefferson Beauregard Sessions III  
13            and any representative of the Russian government,  
14            including his meetings with the Russian Ambassador  
15            to the United States, Sergey I. Kislyak, on July 18,  
16            2016, and September 8, 2016.

17            (2) The Attorney General's testimony before  
18            the Senate Committee on the Judiciary on January  
19            10, 2017, including but not limited to his statement  
20            that he "did not have communications with the Rus-  
21            sians".

22            (3) The Attorney General's written response to  
23            Senator Patrick Leahy's letter of January 17, 2017.

1           (4) The Attorney General's letter of March 6,  
2           2017, to the Senate Committee on the Judiciary.

3           (5) The Attorney General's preparation for con-  
4           firmation hearings before the Senate Committee on  
5           the Judiciary, with respect to the subject of contact  
6           between President Trump's campaign and any rep-  
7           resentative of the Russian government.

8           (6) The Attorney General's recusal from any in-  
9           vestigation related to the 2016 Presidential election,  
10          but not from other related matters, and the imple-  
11          mentation of that recusal.

12          (7) The application of part 600 of title 28,  
13          Code of Federal Regulations, to any case involving  
14          the 2016 Presidential election or any related matter.

15          (8) Any meeting that occurred between any em-  
16          ployee of President Trump's campaign or transition  
17          team and any representative of the Russian govern-  
18          ment, including any meeting that involved Donald J.  
19          Trump, Michael Flynn, Jared Kushner, Carter  
20          Page, J.D. Gordon, Richard Burt, Paul Manafort,  
21          Roger Stone, or Michael Cohen.

22          *That the President is requested, and the Attorney General*  
23          *of the United States is directed, to transmit, respectively*  
24          *(in a manner appropriate to classified information, if the*  
25          *President or Attorney General determines appropriate), to*

1 *the House of Representatives, not later than 14 days after*  
2 *the date of the adoption of this resolution, copies of any*  
3 *document, record, memo, correspondence, or other commu-*  
4 *nication in their possession, or any portion of any such*  
5 *communication, that refers or relates to the following:*

6           (1) *Any meeting or communication that occurred*  
7 *between Senator Jeff Sessions and any representative*  
8 *of the Russian government, including his meetings*  
9 *with the Russian Ambassador to the United States,*  
10 *Sergey I. Kislyak, on July 18, 2016, and September*  
11 *8, 2016.*

12           (2) *Senator Sessions’ testimony before the Senate*  
13 *Committee on the Judiciary on January 10, 2017, in-*  
14 *cluding but not limited to his statement that he “did*  
15 *not have communications with the Russians”.*

16           (3) *Senator Sessions’ written response to Senator*  
17 *Patrick Leahy’s letter of January 17, 2017.*

18           (4) *Attorney General Sessions’ letter of March 6,*  
19 *2017, to the Senate Committee on the Judiciary.*

20           (5) *Senator Sessions’ preparation for confirma-*  
21 *tion hearings before the Senate Committee on the Ju-*  
22 *diiciary, with respect to the subject of contact between*  
23 *President Trump’s campaign and any representative*  
24 *of the Russian government.*

1           (6) *Attorney General Sessions' recusal from any*  
2           *investigation related to the 2016 Presidential election,*  
3           *but not from other related matters, and the implemen-*  
4           *tation of that recusal.*

5           (7) *The application of part 600 of title 28, Code*

7           *2016 Presidential election or any related matter.*

8           (8) *Any meeting that occurred between any em-*
