RESOLUTION

Providing for consideration of the bill (H.R. 1960) to authorize appropriations for fiscal year 2014 for military activities of the Department of Defense and for military construction, to prescribe military personnel strengths for such fiscal year, and for other purposes; and providing for consideration of the bill (H.R. 1256) to direct the Securities and Exchange Commission and the Commodity

Futures Trading Commission to jointly adopt rules setting forth the application to cross-border swaps transactions of certain provisions relating to swaps that were enacted as part of the Dodd-Frank Wall Street Reform and Consumer Protection Act.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 2(b) of
3 rule XVIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 1960) to authorize appropriations
6 for fiscal year 2014 for military activities of the Depart-
7 ment of Defense and for military construction, to prescribe
8 military personnel strengths for such fiscal year, and for
9 other purposes. The first reading of the bill shall be dis-
10 pensed with. All points of order against consideration of
11 the bill are waived. General debate shall be confined to
12 the bill and shall not exceed one hour equally divided and
13 controlled by the chair and ranking minority member of
14 the Committee on Armed Services. After general debate,
15 the Committee of the Whole shall rise without motion. No
16 further consideration of the bill shall be in order except
17 pursuant to a subsequent order of the House.

18 SEC. 2. Upon the adoption of this resolution it shall
19 be in order to consider in the House the bill (H.R. 1256)
20 to direct the Securities and Exchange Commission and the
21 Commodity Futures Trading Commission to jointly adopt

1 rules setting forth the application to cross-border swaps
2 transactions of certain provisions relating to swaps that
3 were enacted as part of the Dodd-Frank Wall Street Re-
4 form and Consumer Protection Act. All points of order
5 against consideration of the bill are waived. The amend-
6 ments recommended by the Committee on Financial Serv-
7 ices now printed in the bill shall be considered as adopted.
8 The bill, as amended, shall be considered as read. All
9 points of order against provisions in the bill, as amended,
10 are waived. The previous question shall be considered as
11 ordered on the bill, as amended, and on any amendment
12 thereto to final passage without intervening motion except:
13 (1) one hour of debate, with 40 minutes equally divided
14 and controlled by the chair and ranking minority member
15 of the Committee on Financial Services and 20 minutes
16 equally divided and controlled by the chair and ranking
17 minority member of the Committee on Agriculture; and
18 (2) one motion to recommit with or without instructions.

19 SEC. 3. The chair of the Committee on Agriculture
20 is authorized, on behalf of the committee, to file a supple-
21 mental report to accompany H.R. 1947.
