Mr. POSEY submitted the following resolution; which was referred to the Committee on the Judiciary

RESOLUTION

Impeaching Joseph R. Biden, President of the United States, for high crimes and misdemeanors, culminating in his failure to protect the States from foreign invasion as is his duty under the Constitution.

1 *Resolved*, That Joseph R. Biden, President of the
2 United States, is impeached for high crimes and mis-
3 demeanors, and that the following articles of impeachment
4 be exhibited to the United States Senate:

5 Articles of impeachment exhibited by the House of
6 Representatives of the United States of America in the
7 name of itself and of the people of the United States of
8 America, against Joseph R. Biden, President of the

1 United States of America, in maintenance and support of
2 its impeachment against him for high crimes and mis-
3 demeanors.

4 ARTICLE I

5 In his conduct of the office of President of the United
6 States, Joseph R. Biden in violation of his constitutional
7 oath faithfully to execute the office of President of the
8 United States and, to the best of his ability, preserve, pro-
9 tect, and defend the Constitution of the United States,
10 and in violation or the constitutional duties of the office
11 of President of the United States prescribed in article II,
12 section 3 of the U.S. Constitution, has failed to take care
13 that the laws be faithfully executed, in that:

14 President Biden failed to secure the U.S.-Mexico Bor-
15 der by failing to enforce the Nation's immigration laws
16 and abandoning U.S. government agents to act unsup-
17 ported by the U.S. government enforcement in the effort
18 to secure our borders.

19 President Biden ended the Migrant Protection Pro-
20 tocol policies that required migrants seeking asylum to
21 wait outside of the United States without due process as
22 required by the Administrative Procedures Act.

23 President Biden abrogated Federal responsibilities
24 with respect to testing incoming migrants for COVID-19.

25 President Biden without authority from Congress or
26 the Constitution released thousands of migrants who en-

1 tered the United States illegally without a date to appear
2 in court for immigration hearings.

3 President Biden knowingly caused to be released mi-
4 grants having tested positive for COVID-19 into the
5 United States, and knowingly transported COVID-19
6 positive migrants throughout the United States.

7 Wherefore President Biden, by such conduct, thus
8 warrants impeachment and trial, removal from office, and
9 disqualification to hold and enjoy any office of honor,
10 trust, or profit under the United States.

11 ARTICLE II

12 In his conduct of the office of President of the United
13 States, Joseph R. Biden, in violation of his constitutional
14 oath faithfully to execute the office of President of the
15 United States and, to the best of his ability, preserve, pro-
16 tect, and defend the Constitution of the United States,
17 and in violation of the constitutional duties of the office
18 of President of the United States as set forth in article
19 IV, section 4 of the U.S. Constitution has failed to ensure
20 that the United States protect each of the States against
21 invasion, in that:

22 President Biden has permitted and even encouraged
23 the unlawful entry of thousands of migrants into the
24 United States across the U.S.-Mexico Border.

25 President Biden, by encouraging and permitting un-
26 lawful emigration across the U.S.-Mexico border, also per-

1 mitted the unlawful entry of persons known to be terror-
2 ists and persons known to belong to foreign political ter-
3 rorist entities that intend great harm to the United States.

4 President Biden, by failing to prevent the entry of
5 known terrorists and persons known to belong to foreign
6 political terrorist entities intending great harm to the U.S.
7 across the U.S.-Mexico border, has failed to protect states
8 from foreign invasion.

9 Wherefore President Biden, by such conduct, thus
10 warrants impeachment and trial, removal from office, and
11 disqualification to hold and enjoy any office of honor,
12 trust, or profit under the United States.
