## RESOLUTION

Providing for consideration of the concurrent resolution (H. Con. Res. 79) directing the Clerk of the House of Representatives to make corrections in the enrollment of H.R. 719, and providing for consideration of the Senate amendment to the House amendment to the Senate amendment to the bill (H.R. 719) to require the Transportation Security Administration to conform to existing Federal law and regulations regarding criminal investigator positions, and for other purposes.

1       *Resolved*, That upon adoption of this resolution it  
2 shall be in order to consider in the House the concurrent  
3 resolution (H. Con. Res. 79) directing the Clerk of the  
4 House of Representatives to make corrections in the en-  
5 rollment of H.R. 719. All points of order against consider-  
6 ation of the concurrent resolution are waived. The concur-  
7 rent resolution shall be considered as read. All points of  
8 order against provisions in the concurrent resolution are  
9 waived. The previous question shall be considered as or-  
10 dered on the concurrent resolution to adoption without in-  
11 tervening motion or demand for division of the question  
12 except 20 minutes of debate equally divided and controlled  
13 by the Majority Leader and the Minority Leader or their  
14 respective designees.

15       SEC. 2. Upon adoption of this resolution it shall be  
16 in order to take from the Speaker's table the bill (H.R.  
17 719) to require the Transportation Security Administra-  
18 tion to conform to existing Federal law and regulations  
19 regarding criminal investigator positions, and for other  
20 purposes, with the Senate amendment to the House  
21 amendment to the Senate amendment thereto, and to con-  
22 sider in the House, without intervention of any point of  
23 order, a motion offered by the chair of the Committee on  
24 Appropriations or his designee that the House concur in  
25 the Senate amendment to the House amendment to the

1 Senate amendment. The Senate amendment and the mo-  
2 tion shall be considered as read. The motion shall be de-  
3 batable for one hour equally divided and controlled by the  
4 chair and ranking minority member of the Committee on  
5 Appropriations. The previous question shall be considered  
6 as ordered on the motion to adoption without intervening  
7 motion.
