## RESOLUTION

Of inquiry requesting the President and directing the Secretary of Health and Human Services and the Secretary of Homeland Security to transmit, respectively, certain documents to the House of Representatives relating to unaccompanied alien children.

1       *Resolved*, That the President is requested, and the  
2 Secretary of Health and Human Services and Secretary  
3 of the Department of Homeland Security are directed, to  
4 transmit, respectively, to the House of Representatives,  
5 not later than 14 days after the date of the adoption of  
6 this resolution, copies of all documents, memoranda, advi-  
7 sory legal opinions, notes from meetings, audio recordings,

1 records (including telephone and electronic mail records),  
2 correspondence, and other communications, or any portion  
3 of any such communications, to the extent that any such  
4 one or more items are within the possession of the Presi-  
5 dent or the Secretaries, respectively, and refer to the fol-  
6 lowing:

7           (1) The health and welfare of unaccompanied  
8 alien children, including the status of COVID–19 in-  
9 fections, treatment, and outcomes, in the care or  
10 custody of Customs and Border Protection and the  
11 Office of Refugee Resettlement.

12           (2) Any current policy, procedure, guidance, or  
13 directive regarding the placement of unaccompanied  
14 alien children in the care or custody of the Office of  
15 Refugee Resettlement with a sponsor, including any  
16 policy that has changed since January 20, 2021, in  
17 order to expedite the placement of such children  
18 with a sponsor.

19           (3) The number of unaccompanied alien chil-  
20 dren placed by the Office of Refugee Resettlement  
21 with sponsors that did not undergo a background  
22 check, public records check, sex offender registry  
23 check, or fingerprint check.

24           (4) All information, including Significant Inci-  
25 dent Reports, regarding allegations of abuse and ne-

1        glect of unaccompanied alien children in Customs  
2        and Border Protection or Office of Refugee Resettle-  
3        ment facilities beginning in November, 2020.

4            (5) The number of unaccompanied alien chil-  
5        dren who were in the care of the Office of Refugee  
6        Resettlement and were not placed with a potential  
7        sponsor pursuant to section V of the memorandum  
8        of agreement entitled “Memorandum of Agreement  
9        Among The Office of Refugee Resettlement of the  
10       U.S. Department of Health and Human Services  
11       and U.S. Immigration and Customs Enforcement  
12       and U.S. Customs and Border Protection of the  
13       U.S. Department of Homeland Security Regarding  
14       Consultation and Information Sharing in Unaccom-  
15       panied Alien Children Matters”, entered into on  
16       April 13, 2018.

17            (6) All Office of Refugee Resettlement current  
18        policies and procedures, guidance, and directives re-  
19        garding the hiring and training of staff, contractors,  
20        or volunteers.

21            (7) All information regarding how the Office of  
22        Refugee Resettlement protects unaccompanied alien  
23        children from smugglers, traffickers, or others who

- 1 might seek to victimize or otherwise engage a child
- 2 in criminal, harmful, or exploitative activity.
