Providing for consideration of the bill (H.R. 3621) to amend the Fair Credit Reporting Act to remove adverse information for certain defaulted or delinquent private education loan borrowers who demonstrate a history of loan repayment, and for other purposes, and providing for consideration of the Senate amendment to the bill (H.R. 550) to award a Congressional Gold Medal, collectively, to the United States Merchant Mariners of World War II, in recognition of their dedicated and vital service during World War II.

Mr. RASKIN, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

## RESOLUTION

Providing for consideration of the bill (H.R. 3621) to amend the Fair Credit Reporting Act to remove adverse information for certain defaulted or delinquent private education loan borrowers who demonstrate a history of loan repayment, and for other purposes, and providing for consideration of the Senate amendment to the bill (H.R. 550) to award a Congressional Gold Medal, collectively, to the United States Merchant Mariners of World War

II, in recognition of their dedicated and vital service during World War II.

1       *Resolved*, That at any time after adoption of this reso-  
2 lution the Speaker may, pursuant to clause 2(b) of rule  
3 XVIII, declare the House resolved into the Committee of  
4 the Whole House on the state of the Union for consider-  
5 ation of the bill (H.R. 3621) to amend the Fair Credit  
6 Reporting Act to remove adverse information for certain  
7 defaulted or delinquent private education loan borrowers  
8 who demonstrate a history of loan repayment, and for  
9 other purposes. The first reading of the bill shall be dis-  
10 pensed with. All points of order against consideration of  
11 the bill are waived. General debate shall be confined to  
12 the bill and amendments specified in this section and shall  
13 not exceed one hour equally divided and controlled by the  
14 chair and ranking minority member of the Committee on  
15 Financial Services. After general debate the bill shall be  
16 considered for amendment under the five-minute rule. In  
17 lieu of the amendment in the nature of a substitute rec-  
18 ommended by the Committee on Financial Services now  
19 printed in the bill, an amendment in the nature of a sub-  
20 stitute consisting of the text of Rules Committee Print  
21 116–47, modified by the amendment printed in part A of  
22 the report of the Committee on Rules accompanying this  
23 resolution, shall be considered as adopted in the House  
24 and in the Committee of the Whole. The bill, as amended,

1 shall be considered as the original bill for the purpose of  
2 further amendment under the five-minute rule and shall  
3 be considered as read. All points of order against provi-  
4 sions in the bill, as amended, are waived. No further  
5 amendment to the bill, as amended, shall be in order ex-  
6 cept those printed in part B of the report of the Com-  
7 mittee on Rules. Each such further amendment may be  
8 offered only in the order printed in the report, may be  
9 offered only by a Member designated in the report, shall  
10 be considered as read, shall be debatable for the time spec-  
11 ified in the report equally divided and controlled by the  
12 proponent and an opponent, shall not be subject to amend-  
13 ment, and shall not be subject to a demand for division  
14 of the question in the House or in the Committee of the  
15 Whole. All points of order against such further amend-  
16 ments are waived. At the conclusion of consideration of  
17 the bill for amendment the Committee shall rise and re-  
18 port the bill, as amended, to the House with such further  
19 amendments as may have been adopted. The previous  
20 question shall be considered as ordered on the bill, as  
21 amended, and on any further amendment thereto to final  
22 passage without intervening motion except one motion to  
23 recommit with or without instructions.

24       SEC. 2. Upon adoption of this resolution it shall be  
25 in order to take from the Speaker's table the bill (H.R.

1 550) to award a Congressional Gold Medal, collectively,  
2 to the United States Merchant Mariners of World War  
3 II, in recognition of their dedicated and vital service dur-  
4 ing World War II, with the Senate amendment thereto,  
5 and to consider in the House, without intervention of any  
6 point of order, a motion offered by the chair of the Com-  
7 mittee on Foreign Affairs or his designee that the House  
8 concur in the Senate amendment with each of the two  
9 amendments specified in section 4 of this resolution. The  
10 Senate amendment and the motion shall be considered as  
11 read. The previous question shall be considered as ordered  
12 on the motion to its adoption without intervening motion  
13 or demand for division of the question except as specified  
14 in section 3 of this resolution.

15       SEC. 3. (a) The question of adoption of the motion  
16 shall be divided between the two House amendments speci-  
17 fied in section 4 of this resolution. The two portions of  
18 the divided question shall be considered in the order speci-  
19 fied by the Chair.

20       (b) Each portion of the divided question shall be de-  
21 batable for one hour equally divided and controlled by the  
22 chair and ranking minority member of the Committee on  
23 Foreign Affairs.

24       SEC. 4. The amendments referred to in the second  
25 and third sections of this resolution are as follows:

1       (a) An amendment consisting of the text of Rules  
2 Committee Print 116–48.

3       (b) An amendment consisting of the text of Rules  
4 Committee Print 116–49.

5       SEC. 5. If only one portion of the divided question  
6 is adopted, that portion shall be engrossed as an amend-  
7 ment in the nature of a substitute to the Senate amend-  
8 ment to H.R. 550.
