A BILL

To promote research, monitoring, and observation of the Arctic and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “~~Arctic Research, Moni-~~
5 ~~toring, and Observing Act of 2013~~”.

1 **SEC. 2. ARCTIC RESEARCH COMMISSION.**

2 (a) DUTIES OF THE ARCTIC RESEARCH COMMISS-
3 SION.—Section 104(a) of the Arctic Research and Policy
4 Act of 1984 (15 U.S.C. 4103(a)) is amended—

5 (1) in paragraph (2), by striking “assist in es-
6 tablishing” and inserting “establish”;

7 (2) by redesignating paragraphs (3) through
8 (10) as paragraphs (4) through (11), respectively;
9 and

10 (3) by inserting after paragraph (2) the fol-
11 lowing:

12 “(3) award—

13 “(A) grants to Federal, State, local, or
14 tribal governments and academic and private
15 organizations to conduct research on or related
16 to the Arctic, including to the marine environ-
17 ment of the Arctic Ocean, its adjacent seas or
18 associated lesser bodies of water; and

19 “(B) such grants on the basis of merit in
20 accordance with the national Arctic research
21 program plan;”.

22 (b) ADMINISTRATION OF THE COMMISSION.—Section
23 106 of the Arctic Research and Policy Act of 1984 (15
24 U.S.C. 4105) is amended—

25 (1) in paragraph (4), by striking “and” at the
26 end;

1 (2) in paragraph (5), by striking the period at
2 the end and inserting “; and”; and

3 (3) by adding at the end the following:

4 “(6) enter into agreements with appropriate
5 agencies or organizations to administer grants made
6 pursuant to this title for Arctic research including
7 reimbursement from funds of the Commission to ad-
8 minister such grants.”.

9 (e) CONFLICTS OF INTEREST; ARCTIC RESEARCH
10 COMMISSION.—Section 103 of the Arctic Research and
11 Policy Act of 1984 (15 U.S.C. 4102) is amended by add-
12 ing at the end the following:

13 “(e) CONFLICT OF INTEREST.—The Commission
14 shall adopt conflict of interest and recusal provisions that
15 apply to any decision by the Commission and to all mem-
16 bers of the Commission as if each member of the Commis-
17 sion is an ‘affected individual’ within the meaning of sec-
18 tion 302(j) of the Magnuson-Stevens Fishery Conservation
19 and Management Act (16 U.S.C. 1852(j)), except that in
20 addition to the disclosure requirements of paragraph (2)
21 of such section 302(j), each member of the Commission
22 shall disclose any financial interest or relationship in an
23 organization or with an individual that is applying for
24 funding from the Commission held by the member of the
25 Commission, including an interest as an officer, director,

1 trustee, partner, employee, contractor, agent, or other rep-
 2 resentative.”.

3 **SEC. 3. NORTH PACIFIC RESEARCH BOARD.**

4 Subsection (e) of section 401 of the Department of
 5 the Interior and Related Agencies Appropriations Act,
 6 1998 (43 U.S.C. 1474d(e)) is amended by striking para-
 7 graph (5) and inserting the following:

8 “(5) The Board may adopt such rules of procee-
 9 dure and establish such committees as it deems nec-
 10 essary to carry out the purposes of this title, includ-
 11 ing the conduct of administrative duties between
 12 meetings.

13 “(6) All decisions of the Board shall be by ma-
 14 jority vote of the full board in regular session.

15 “(7) The Board shall adopt conflict of interest
 16 and recusal provisions that apply to any decision by
 17 the Board and to all members of the Board as if
 18 each member of the Board is an ‘affected individual’
 19 within the meaning of section 302(j) of the Magnu-
 20 son-Stevens Fishery Conservation and Management
 21 Act (16 U.S.C. 1852(j)), except that in addition to
 22 the disclosure requirements of paragraph (2) of such
 23 section 302(j), each member of the Board shall dis-
 24 close any financial interest or relationship in an or-
 25 ganization or with an individual that is applying for

1 funding from the Board, including an interest as an
 2 officer, director, trustee, partner, employee, con-
 3 tractor, agent, or other representative.

4 “(8) The Secretary of Commerce may accept
 5 funds from a source other than the Government of
 6 the United States to be used by the Board to carry
 7 out the Board’s functions.”.

8 **SECTION 1. SHORT TITLE.**

9 *This Act may be cited as the “Arctic Research, Moni-*
 10 *toring, and Observing Act of 2013”.*

11 **SEC. 2. ARCTIC RESEARCH COMMISSION.**

12 *(a) DUTIES OF THE ARCTIC RESEARCH COMMIS-*
 13 *SION.—Section 104(a) of the Arctic Research and Policy*
 14 *Act of 1984 (15 U.S.C. 4103(a)) is amended—*

15 *(1) in paragraph (2), by striking “assist in es-*
 16 *tablishing” and inserting “establish”;*

17 *(2) by redesignating paragraphs (3) through (10)*
 18 *as paragraphs (4) through (11), respectively; and*

19 *(3) by inserting after paragraph (2) the fol-*
 20 *lowing:*

21 *“(3) award—*

22 *“(A) grants to Federal, State, local, or trib-*
 23 *al governments and academic and private orga-*
 24 *nizations to conduct research on or related to the*
 25 *Arctic, including to the marine environment of*

1 *the Arctic Ocean, its adjacent seas or associated*
2 *lesser bodies of water; and*

3 “(B) *such grants on the basis of merit in*
4 *accordance with the national Arctic research*
5 *program plan;”.*

6 **(b) ADMINISTRATION OF THE COMMISSION.**—*Section*
7 *106 of the Arctic Research and Policy Act of 1984 (15*
8 *U.S.C. 4105) is amended—*

9 (1) *in paragraph (4), by striking “and” at the*
10 *end;*

11 (2) *in paragraph (5), by striking the period at*
12 *the end and inserting “; and”; and*

13 (3) *by adding at the end the following:*

14 “(6) *enter into agreements with appropriate*
15 *agencies or organizations to administer grants made*
16 *pursuant to this title for Arctic research including re-*
17 *imbursement from funds of the Commission to admin-*
18 *ister such grants.”.*

19 **(c) CONFLICTS OF INTEREST; ARCTIC RESEARCH COM-**
20 **MISSION.**—*Section 103 of the Arctic Research and Policy*
21 *Act of 1984 (15 U.S.C. 4102) is amended by adding at the*
22 *end the following:*

23 “(e) **CONFLICT OF INTEREST.**—*The Commission shall*
24 *adopt conflict of interest and recusal provisions which shall*
25 *apply to any decision by the Commission and to all mem-*

1 *bers of the Commission which at a minimum are substan-*
 2 *tially equivalent to conflict of interest and recusal provi-*
 3 *sions set forth in section 302(j) of the Magnuson-Stevens*
 4 *Fishery Conservation and Management Act (16 U.S.C.*
 5 *1852(j)) as if each member of the Commission is an ‘affected*
 6 *individual’ within the meaning of such section 302(j), ex-*
 7 *cept that in addition to the disclosure requirements of such*
 8 *section 302(j), each Commission member shall disclose any*
 9 *financial interest or relationship in an organization or*
 10 *with an individual that is applying for funding from the*
 11 *Commission held by the Commission member, including an*
 12 *interest as an officer, director, trustee, partner, employee,*
 13 *contractor, agent, or other representative.”.*

14 **SEC. 3. NORTH PACIFIC RESEARCH BOARD.**

15 *Subsection (e) of section 401 of the Department of the*
 16 *Interior and Related Agencies Appropriations Act, 1998*
 17 *(43 U.S.C. 1474d(e)) is amended by striking paragraph (5)*
 18 *and inserting the following:*

19 *“(5) The Board may adopt such rules of proce-*
 20 *dure and establish such committees as it deems nec-*
 21 *essary to carry out the purposes of this title, includ-*
 22 *ing the conduct of administrative duties between*
 23 *meetings.*

24 *“(6) All decisions of the Board shall be by major-*
 25 *ity vote of the full board in regular session.*

1 “(7) *The Board shall adopt conflict of interest*
2 *and recusal provisions which at a minimum are sub-*
3 *stantially equivalent to conflict of interest and recusal*
4 *provisions set forth in section 302(j) of the Magnuson-*
5 *Stevens Fishery Conservation and Management Act*
6 *(16 U.S.C. 1852(j)) shall apply to any decision by the*
7 *Board and to all members of the Board as if each*
8 *member of the Board is an ‘affected individual’ with-*
9 *in the meaning of such section 302(j), except that in*
10 *addition to the disclosure requirements of such section*
11 *302(j), each Board member shall disclose any finan-*
12 *cial interest or relationship in an organization or*
13 *with an individual that is applying for funding from*
14 *the Board, including an interest as an officer, direc-*
15 *tor, trustee, partner, employee, contractor, agent, or*
16 *other representative.*

17 “(8) *The Secretary of Commerce may accept*
18 *funds from a source other than the Government of the*
19 *United States to be used by the Board to carry out*
20 *the Board’s functions.”.*
