## A BILL

To ensure that all fast-tracked reconciliation bills are subject to a committee hearing, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “No Hearing, No Vote  
5 Act of 2017”.

1 **SEC. 2. COMMITTEE HEARINGS FOR RECONCILIATION**  
2 **BILLS.**

3 (a) IN GENERAL.—Section 310 of the Congressional  
4 Budget Act of 1974 (2 U.S.C. 641) is amended by adding  
5 at the end the following:

6 “(h) COMMITTEE HEARINGS FOR RECONCILIATION  
7 BILLS.—It shall not be in order in the Senate to consider  
8 any reconciliation bill or reconciliation resolution, unless—

9 “(1) the reconciliation bill or reconciliation res-  
10 olution was—

11 “(A) ordered reported to the Senate under  
12 subsection (b)(1) by the committee of the Sen-  
13 ate receiving reconciliation instructions; or

14 “(B) reported by the Committee on the  
15 Budget of the Senate under subsection (b)(2)  
16 after receiving recommendations ordered to be  
17 reported to the Committee on the Budget by 1  
18 or more committees of the Senate receiving rec-  
19 onciliation instructions; and

20 “(2) each committee that ordered reported the  
21 reconciliation bill or reconciliation resolution or or-  
22 dered recommendations to be reported to the Com-  
23 mittee on the Budget held not less than 1 hearing  
24 regarding any major provision of the reconciliation  
25 bill or reconciliation resolution within the jurisdic-  
26 tion of such committee.”.

1           (b) WAIVER AND APPEAL.—Section 904 of the Con-  
2 gressional Budget Act of 1974 (2 U.S.C. 621 note) is  
3 amended—

4           (1) in subsection (c)(1), by inserting “310(h),”  
5 after “310(d)(2),”; and

6           (2) in subsection (d)(2), by inserting “310(h),”  
7 after “310(d)(2),”.
