 - 5 (a) IN GENERAL.—The Reclamation Wastewater and
 - 6 Groundwater Study and Facilities Act (43 U.S.C. 390h
 - 7 et seq.) is amended—

2	1633 as sections 1632, 1633, and 1634, respectively
3	(2) by inserting after section 1630 the fol-

7	"(a) Authorization.—The Secretary, in coopera-
8	tion with the city of Hermiston, Oregon, may participate
9	in the design, planning, and construction of permanent fa-
10	cilities to reclaim and reuse water in the city of

13	"(1) Federal share.—The Federal share of
14	the costs of the project described in subsection (a)
15	may not exceed 25 percent of the total cost of the

19	project described in subsection (a).";

23	(4) in section 1633(c) (as redesignated by para-
24	graph (1)), by striking "1633" and inserting

2	graph (1)), by striking "1632" and inserting
3	"1633".
4	(b) Conforming Amendment.—The table of con-
5	tents contained in section 2 of the Reclamation Projects
6	Authorization and Adjustment Act of 1992 (Public Law
7	102–575; 106 Stat. 4600) is amended—
8	(1) by redesignating the items relating to sec-
9	tions 1631, 1632, and 1633 as the items relating to
10	sections 1632, 1633, and 1634, respectively; and
11	(2) by inserting after the item relating to sec-
12	tion 1630 the following:

"Sec. 1631. City of Hermiston, Oregon, water recycling and reuse project.".
