Mrs. HYDE-SMITH (for herself and Mr. WICKER) introduced the following bill; which was read twice and referred to the Committee on Environment and Public Works

A BILL

To amend the Federal Water Pollution Control Act to modify the requirements for permits for dredged or fill material, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Flood Reduction, Wild-
5 life Habitat, and Water Quality Improvement Act of
6 2019”.

7 **SEC. 2. PERMITS FOR DREDGED OR FILL MATERIAL.**

8 Section 404 of the Federal Water Pollution Control
9 Act (33 U.S.C. 1344) is amended—

1 (1) in subsection (c)—

2 (A) in the third sentence, by striking “The
3 Administrator” and inserting the following:

4 “(5) FINDINGS.—The Administrator”;

5 (B) in the second sentence, by striking
6 “Before making such determination” and in-
7 serting the following:

8 “(4) CONSULTATION.—Before making a deter-
9 mination under paragraph (1)”;

10 (C) by striking the subsection designation
11 and all that follows through “The Adminis-
12 trator” in the first sentence and inserting the
13 following:

14 “(c) PROHIBITION OF SPECIFICATION OF AREAS AS
15 DISPOSAL SITES.—

16 “(1) IN GENERAL.—Subject to paragraph (2),
17 the Administrator”;

18 (D) by inserting after paragraph (1) (as so
19 designated) the following:

20 “(2) LIMITATIONS.—The Administrator may
21 not prohibit the specification of a defined area as a
22 disposal site, or otherwise deny or restrict the use of
23 a defined area as a disposal site—

24 “(A) if the area is or contains a project of
25 the Secretary for flood control;

1 “(B) before an application for a permit
2 under this section for the area has been filed;
3 or

4 “(C) after a permit under this section for
5 the area has been issued by the Secretary.

6 “(3) REQUIREMENTS.—A regional office of the
7 Administrator shall—

8 “(A) before considering a determination
9 under paragraph (1), obtain the approval of the
10 Administrator; and

11 “(B) before publishing notice of a proposed
12 determination under paragraph (1) for the area
13 of a project, review, consider, and adequately
14 refute the findings of an environmental impact
15 statement for the project pursuant to the Na-
16 tional Environmental Policy Act of 1969 (42
17 U.S.C. 4321 et seq.).”; and

18 (E) by adding at the end the following:

19 “(6) IMMEDIATE WITHDRAWAL OF PRIOR DE-
20 TERMINATIONS.—

21 “(A) IN GENERAL.—Notwithstanding any
22 other provision of law, a determination made by
23 the Administrator under paragraph (1) with re-
24 spect to the area of a project that is or contains
25 a project of the Secretary for flood control be-

1 fore the date of enactment of the Flood Reduc-
2 tion, Wildlife Habitat, and Water Quality Im-
3 provement Act of 2019 shall no longer apply
4 if—

5 “(i) a more practicable alternative to
6 the project has not been identified; and

7 “(ii) as a result of a delay in con-
8 struction of the project, severe flooding
9 and damage to life and property have oc-
10 curred.

11 “(B) JUDICIAL REVIEW.—Notwithstanding
12 any other provision of law, an action taken by
13 the Secretary to advance a project described in
14 subparagraph (A) shall not be subject to judi-
15 cial review.”; and

16 (2) in subsection (r), by striking “under section
17 307),” and all that follows through the period at the
18 end and inserting “under section 307).”.
