## A BILL

To amend title 10, United States Code, to authorize the Secretary of Defense or the Secretary of a military department to enter into cooperative agreements to manage certain recreational resources in California.

1       *Be it enacted by the Senate and House of Representa-*

2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Military Recreational

5       Land Act of 2023”.

## 3 THROUGH COOPERATIVE AGREEMENTS.

4 (a) IN GENERAL.—Section 2684 of title 10, United

5 States Code, is amended—

6 (1) in the section header, by inserting “**and**  
7 **recreational**” after “**cultural**”;

8 (2) in subsection (a)—

9 (A) in the first sentence—

10 (i) by inserting “or recreational re-  
11 sources” after “cultural resources”; and12 (ii) by striking “the cultural re-  
13 sources” and inserting “those resources”;  
14 and15 (B) in the second sentence, by inserting “,  
16 if any funds are required” before the period at  
17 the end;

18 (3) in subsection (b)—

19 (A) in the subsection header, by striking  
20 “CULTURAL RESOURCES”; and

21 (B) by striking “cultural”; and

22 (4) in subsection (d)—

23 (A) by amending the subsection header to  
24 read as follows: “DEFINITIONS.—”;25 (B) by redesignating paragraphs (1)  
26 through (5) as subparagraphs (A) through (E),

1           respectively, and moving those subparagraphs,  
2           as so redesignated, two ems to the right;

3           (C) by striking “In this section, the term”  
4           and inserting “In this section:

5           “(1) The term”; and

6           (D) by adding at the end the following new  
7           paragraph:

8           “(2) The term ‘recreational resource’ means a  
9           site that is included in the state seashore of Cali-  
10          fornia, as described in section 5001.6 of the Public  
11          Resources Code of California, or successor similar  
12          provision, and will be operated as a park unit in the  
13          California State Park system by the California De-  
14          partment of Parks and Recreation.”.

15          (b) CLERICAL AMENDMENT.—The table of sections  
16          at the beginning of chapter 159 of such title is amended  
17          by striking the item relating to section 2684 and inserting  
18          the following new item:

“2684. Cooperative agreements for management of cultural and recreational re-  
sources.”.
