A BILL

To amend title 49, United State Code, to require small hub airports to construct areas for nursing mothers, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Friendly Airports for
5 Mothers Improvement Act”.

1 **SEC. 2. MOTHERS' ROOMS.**

2 Section 47107(w) of title 49, United States Code, is
3 amended—

4 (1) in paragraph (1) by striking “In fiscal year
5 2021” and all that follows through “the Secretary of
6 Transportation” and inserting “The Secretary of
7 Transportation”;

8 (2) in paragraph (1)(B) by striking “one men’s
9 and one women’s” and inserting “at least one men’s
10 and at least one women’s”;

11 (3) by striking paragraph (2)(A) and inserting
12 the following:

13 “(A) AIRPORT SIZE.—

14 “(i) IN GENERAL.—The requirements
15 in paragraph (1) shall only apply to appli-
16 cations submitted by the airport sponsor
17 of—

18 “(I) a medium or large hub air-
19 port in fiscal year 2021 and each fis-
20 cal year thereafter; and

21 “(II) an applicable small hub air-
22 port in fiscal year 2023 and each fis-
23 cal year thereafter.

24 “(ii) APPLICABLE SMALL HUB AIR-
25 PORT DEFINED.—In clause (i)(II), the
26 term ‘applicable small hub airport’ means

1 an airport designated as a small hub air-
2 port during—

3 “(I) the 3-year period consisting
4 of 2020, 2021, and 2022; or

5 “(II) any consecutive 3-year pe-
6 riod beginning after 2020.”;

7 (4) in paragraph (2)(B) by striking “the date
8 of enactment of this Act complies with the require-
9 ment in paragraph (1)” and inserting “October 5,
10 2018, complies with the requirement in paragraph
11 (1)(A)”; and

12 (5) in paragraph (2)(C) by striking “paragraph
13 (1)” and inserting “paragraph (1)(A)”.
