# A BILL

To improve the management of driftnet fishing.

- 1       *Be it enacted by the Senate and House of Representa-*
- 2       *tives of the United States of America in Congress assembled,*
- 3       **SECTION 1. SHORT TITLE.**
- 4       *This Act may be cited as the “Driftnet Modernization*
- 5       *and Bycatch Reduction Act”.*

1   **SEC. 2. DEFINITION.**

2       Section 3(25) of the Magnuson-Stevens Fishery Con-  
3 servation and Management Act (16 U.S.C. 1802(25)) is  
4 amended by inserting “, or with a mesh size of 14 inches  
5 or greater,” after “more”.

6   **SEC. 3. FINDINGS AND POLICY.**

7       (a) **FINDINGS.**—Section 206(b) of the Magnuson-Stevens Fishery Conservation and Management Act (16 U.S.C. 1826(b)) is amended—

10           (1) in paragraph (6), by striking “and” at the end;

12           (2) in paragraph (7), by striking the period and inserting “; and”, and

14           (3) by adding at the end the following:

15               “(8) within the exclusive economic zone, large-  
16 scale driftnet fishing that deploys nets with large  
17 mesh sizes causes significant entanglement and mor-  
18 tality of living marine resources, including myriad  
19 protected species, despite limitations on the lengths  
20 of such nets.”.

21       (b) **POLICY.**—Section 206(e) of the Magnuson-Stevens Fishery Conservation and Management Act (16 U.S.C. 1826(e)) is amended—

24           (1) in paragraph (2), by striking “and” at the end;

1                             (2) in paragraph (3), by striking the period and  
2                             inserting “; and”, and

3                             (3) by adding at the end the following—

4                             “(4) prioritize the phase out of large-seale  
5                             driftnet fishing in the exclusive economic zone and  
6                             promote the development and adoption of alternative  
7                             fishing methods and gear types that reduce the inci-  
8                             dental catch of living marine resources to the max-  
9                             imum extent possible.”.

10 **SEC. 4. TRANSITION PROGRAM.**

11                             Section 206 of the Magnuson-Stevens Fishery Con-  
12 servation and Management Act (16 U.S.C. 1826) is  
13 amended by adding at the end the following—

14                             “(i) FISHING GEAR TRANSITION PROGRAM.—

15                             “(1) IN GENERAL.—The Secretary shall con-  
16 duct a transition program to facilitate the phase-out  
17 of large-seale driftnet fishing and adoption of alter-  
18 native fishing practiees that minimize the incidental  
19 catch of living marine resources.

20                             “(2) PERMISSIBLE USES.—

21                             “(A) IN GENERAL.—The Secretary is au-  
22 thorized to provide funding to fishery partici-  
23 pants for one or more of the following:

24                             “(i) Any fee originally associated with  
25 a permit authorizing participation in a

1                   large-scale driftnet fishery, if such permit  
2                   is surrendered for permanent revocation,  
3                   and such permit holder relinquishes any  
4                   claim associated with the permit.

5                   “(ii) A forfeiture of fishing gear asso-  
6                   ciated with a permit described in clause (i).

7                   “(iii) The purchase of alternative gear  
8                   with minimal incidental catch of living ma-  
9                   rine resources, if the fishery participant is  
10                  authorized to continue fishing using such  
11                  alternative gears.

12                  “(B) PAYMENT CONDITION.—The Sec-  
13                  retary may not make a payment to a fishery  
14                  participant under subparagraph (A) unless the  
15                  Secretary certifies that the permit authorizing  
16                  participation has been permanently revoked and  
17                  that no new permits will be issued to authorize  
18                  such fishing.

19                  “(3) AUTHORIZATION OF APPROPRIATIONS.—  
20                  There is authorized to be appropriated for purposes  
21                  of carrying out this subsection, \$450,000 for each of  
22                  fiscal years 2018 through 2020.”.

23 **SEC. 5. EXCEPTION.**

24                  Section 307(1)(M) of the Magnuson-Stevens Fishery  
25                  Conservation and Management Act (16 U.S.C.

1 1857(1)(M)) is amended by inserting before the semicolon  
2 the following: “, unless such large-scale driftnet fishing—  
3                         “(i) deploys, within the exclusive eco-  
4                         nomic zone, a net with a total length of  
5                         less than two and one-half kilometers and  
6                         a mesh size of 14 inches or greater; and  
7                         “(ii) is conducted prior to January 1,  
8                         2020.”.

9 **SECTION 1. SHORT TITLE.**

10         *This Act may be cited as the “Driftnet Modernization  
11 and Bycatch Reduction Act”.*

12 **SEC. 2. DEFINITION.**

13         *Section 3(25) of the Magnuson-Stevens Fishery Con-  
14 servation and Management Act (16 U.S.C. 1802(25)) is  
15 amended by inserting “, or with a mesh size of 14 inches  
16 or greater,” after “more”.*

17 **SEC. 3. FINDINGS AND POLICY.**

18         (i) *FINDINGS.—Section 206(b) of the Magnuson-Stevens Fishery Conservation and Management Act (16 U.S.C. 1826(b)) is amended—*

1           “(8) *within the exclusive economic zone, large-*  
2 *scale driftnet fishing that deploys nets with large*  
3 *mesh sizes causes significant entanglement and mor-*  
4 *tality of living marine resources, including myriad*  
5 *protected species, despite limitations on the lengths of*  
6 *such nets.”.*

7       (b) *POLICY.—Section 206(c) of the Magnuson-Stevens*  
8 *Fishery Conservation and Management Act (16 U.S.C.*  
9 *1826(c)) is amended—*

10           (1) *in paragraph (2), by striking “and” at the*  
11 *end;*

12           (2) *in paragraph (3), by striking the period and*  
13 *inserting “; and”; and*

14           (3) *by adding at the end the following—*

15           “(4) *prioritize the phase out of large-scale*  
16 *driftnet fishing in the exclusive economic zone and*  
17 *promote the development and adoption of alternative*  
18 *fishing methods and gear types that minimize the in-*  
19 *cidental catch of living marine resources.”.*

20 **SEC. 4. TRANSITION PROGRAM.**

21       *Section 206 of the Magnuson-Stevens Fishery Con-*  
22 *servation and Management Act (16 U.S.C. 1826) is amend-*  
23 *ed by adding at the end the following—*

24       “(i) **FISHING GEAR TRANSITION PROGRAM.—**

1           “(1) *IN GENERAL.*—*The Secretary shall conduct*  
2       *a transition program to facilitate the phase-out of*  
3       *large-scale driftnet fishing and adoption of alternative*  
4       *fishing practices that minimize the incidental catch of*  
5       *living marine resources.*

6           “(2) *PERMISSIBLE USES.*—*Any permit holder*  
7       *participating in the transition program under para-*  
8       *graph (1) is eligible for a grant under section 316,*  
9       *if—*

10          “(A) *the grant is used only the purpose of*  
11       *covering—*

12           “(i) *any fee originally associated with*  
13       *a permit authorizing participation in a*  
14       *large-scale driftnet fishery, if such permit is*  
15       *surrendered for permanent revocation, and*  
16       *such permit holder relinquishes any claim*  
17       *associated with the permit;*

18           “(ii) *a forfeiture of fishing gear associ-*  
19       *ated with a permit described in clause (i);*  
20       *or*

21           “(iii) *the purchase of alternative gear*  
22       *with minimal incidental catch of living ma-*  
23       *rine resources, if the fishery participant is*  
24       *authorized to continue fishing using such*  
25       *alternative gears; and*

1               “(B) the Secretary certifies that the permit  
2               authorizing participation has been permanently  
3               revoked and that no new permits will be issued  
4               to authorize such fishing.”.

5 **SEC. 5. EXCEPTION.**

6               Section 307(1)(M) of the Magnuson-Stevens Fishery  
7 Conservation and Management Act (16 U.S.C. 1857(1)(M))  
8 is amended by inserting before the semicolon the following:  
9 “, unless such large-scale driftnet fishing—

10               “(i) deploys, within the exclusive eco-  
11               nomic zone, a net with a total length of less  
12               than two and one-half kilometers and a  
13               mesh size of 14 inches or greater; and

14               “(ii) is conducted within 5 years of the  
15               date of enactment of the Driftnet Mod-  
16               ernization and Bycatch Reduction Act”.
