## A BILL

To waive the guarantee fee for certain business loans made to veterans and spouses of veterans.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Heroes Business Op-  
5 portunity Act of 2023”.

6 **SEC. 2. WAIVER OF GUARANTEE FEE FOR CERTAIN BUSI-**  
7 **NESS LOANS MADE TO VETERANS AND**  
8 **SPOUSES OF VETERANS.**

9 Section 7(a) of the Small Business Act (15 U.S.C.  
10 636(a)) is amended—

1 (1) in paragraph (18)—

2 (A) in subparagraph (A), in the matter  
3 preceding clause (i), by striking “With respect”  
4 and inserting “Except as provided in subpara-  
5 graph (C), with respect”; and

6 (B) by adding at the end the following:

7 “(C) EXCEPTION.—

8 “(i) IN GENERAL.—Notwithstanding  
9 subparagraph (A), the Administration may  
10 not collect a guarantee fee under subpara-  
11 graph (A) with respect to a loan guaran-  
12 teed under this subsection if—

13 “(I) the loan is not made under  
14 paragraph (36) or (37);

15 “(II) the loan is made to a vet-  
16 eran or spouse of a veteran; and

17 “(III) the deferred participation  
18 share of the total loan amount is not  
19 more than \$1,000,000.

20 “(ii) DEFINITION.—In this subpara-  
21 graph, the term ‘veteran or spouse of a  
22 veteran’ means—

23 “(I) a veteran;

24 “(II) an individual who is eligible  
25 to participate in the Transition Assist-

1           ance Program established under sec-  
2           tion 1144 of title 10, United States  
3           Code;

4           “(III) a member of a reserve  
5           component of the Armed Forces  
6           named in section 10101 of title 10,  
7           United States Code;

8           “(IV) the spouse of an individual  
9           described in subclause (I), (II), or  
10          (III); or

11          “(V) the surviving spouse (as de-  
12          fined in section 101 of title 38,  
13          United States Code) of an individual  
14          described in subclause (I), (II), or  
15          (III) who died while serving on active  
16          duty or as a result of a disability that  
17          is service-connected (as defined in  
18          such section).”; and

19          (2) in paragraph (31)—

20                  (A) by striking subparagraph (G); and

21                  (B) by redesignating subparagraph (H) as  
22          subparagraph (G).
