## A BILL

To repeal the Patient Protection and Affordable Care Act and the Health Care and Education Reconciliation Act of 2010 entirely.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “ObamaCare Repeal  
3 Act”.

4 **SEC. 2. REPEAL OF THE PATIENT PROTECTION AND AF-**  
5 **FORDABLE CARE ACT AND THE HEALTH**  
6 **CARE AND EDUCATION RECONCILIATION ACT**  
7 **OF 2010.**

8 (a) PATIENT PROTECTION AND AFFORDABLE CARE  
9 ACT.—Effective on the date that is 180 days after the  
10 date of enactment of this Act, the Patient Protection and  
11 Affordable Care Act (Public Law 111–148) is repealed  
12 and the provisions of law amended or repealed by such  
13 Act are restored or revived as if such Act had not been  
14 enacted.

15 (b) HEALTH CARE AND EDUCATION RECONCILI-  
16 ATION ACT OF 2010.—Effective on the date that is 180  
17 days after the date of enactment of this Act, the Health  
18 Care and Education Reconciliation Act of 2010 (Public  
19 Law 111–152) is repealed and the provisions of law  
20 amended or repealed by such Act are restored or revived  
21 as if such Act had not been enacted.

22 **SEC. 3. BUDGETARY EFFECTS OF THIS ACT.**

23 The budgetary effects of this Act, for the purpose of  
24 complying with the Statutory Pay-As-You-Go Act of 2010,  
25 shall be determined by reference to the latest statement  
26 titled “Budgetary Effects of PAYGO Legislation” for this

1 Act, submitted for printing in the Congressional Record  
2 by the Chairman of the Committee on the Budget of the  
3 House of Representatives, as long as such statement has  
4 been submitted prior to the vote on passage of this Act.
