A BILL

To require the Election Assistance Commission to develop voluntary guidelines for the administration of elections that address the use and risks of artificial intelligence technologies, and for other purposes.

2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Preparing Election Ad-
3 ministrators for AI Act”.

4 **SEC. 2. VOLUNTARY GUIDELINES FOR ADMINISTRATION OF**
5 **ELECTIONS THAT ADDRESS THE USE AND**
6 **RISKS OF ARTIFICIAL INTELLIGENCE TECH-**
7 **NOLOGIES.**

8 (a) **REPORT AND VOLUNTARY GUIDELINES.**—Not
9 later than 60 days after the date of the enactment of this
10 Act, the Election Assistance Commission shall, in con-
11 sultation with the National Institute of Standards and
12 Technology, submit to Congress, issue to State and local
13 election offices, and make available to the public a report
14 with voluntary guidelines for election offices that address
15 the use and risks of artificial intelligence technologies in
16 the administration of elections.

17 (b) **CONTENTS.**—The report submitted and made
18 available pursuant to subsection (a) shall include vol-
19 untary guidelines that address—

20 (1) the risks and benefits associated with using
21 artificial intelligence technologies to conduct election
22 administration activities;

23 (2) the cybersecurity risks of artificial intel-
24 ligence technologies to election administration;

25 (3) how information generated and distributed
26 by artificial intelligence technologies can affect the

1 sharing of accurate election information and how
 2 election offices should respond; and

3 (4) how information generated and distributed
 4 by artificial intelligence technologies can affect the
 5 spreading of election disinformation that undermines
 6 public trust and confidence in elections.

7 **SECTION 1. SHORT TITLE.**

10 **SEC. 2. VOLUNTARY GUIDELINES FOR ADMINISTRATION OF**

14 (a) *REPORT AND VOLUNTARY GUIDELINES.*—*Not later*
 15 *than 60 days after the date of the enactment of this Act,*
 16 *the Election Assistance Commission shall, in consultation*
 17 *with the National Institute of Standards and Technology,*
 18 *submit to Congress, issue to State and local election offices,*
 19 *and make available to the public a report with voluntary*
 20 *guidelines for election offices that address the use and risks*
 21 *of artificial intelligence technologies in the administration*
 22 *of elections.*

23 (b) *CONTENTS.*—*The report submitted and made*
 24 *available pursuant to subsection (a) shall include voluntary*
 25 *guidelines that address—*

1 (1) *the risks and benefits associated with using*
2 *artificial intelligence technologies to conduct election*
3 *administration activities;*

4 (2) *the cybersecurity risks of artificial intel-*
5 *ligence technologies to election administration;*

6 (3) *how information generated and distributed*
7 *by artificial intelligence technologies can affect the*
8 *sharing of accurate election information and how*
9 *election offices should respond; and*

10 (4) *how information generated and distributed*
11 *by artificial intelligence technologies can affect the*
12 *spreading of election disinformation that undermines*
13 *public trust and confidence in elections.*

14 **SEC. 3. STUDY ON USE OF ARTIFICIAL INTELLIGENCE**
15 **TECHNOLOGIES IN THE 2024 ELECTIONS.**

16 (a) *IN GENERAL.*—*Not later than November 5, 2025,*
17 *the Election Assistance Commission, in consultation with*
18 *the National Institute of Standards and Technology, shall*
19 *study and submit to Congress, issue to State and local elec-*
20 *tion offices, and make available to the public a report on*
21 *the use and impacts of artificial intelligence technologies*
22 *in the elections for Federal office held in 2024, including*
23 *how information generated by artificial intelligence tech-*
24 *nologies was shared and the use of artificial intelligence*
25 *technologies by election offices.*

1 **(b) REVIEW AND UPDATE OF VOLUNTARY GUIDE-**
2 *LINES.—Taking into consideration the results of the study*
3 *conducted under subsection (a), the Election Assistance*
4 *Commission shall review and update the voluntary guide-*
5 *lines issued under section 2(a) as appropriate.*
