# A BILL

To improve menopause care and mid-life women's health,  
and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*

2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE; TABLE OF CONTENTS.**

4       (a) SHORT TITLE.—This Act may be cited as the  
5       “Advancing Menopause Care and Mid-Life Women’s  
6       Health Act”.

7       (b) TABLE OF CONTENTS.—The table of contents for  
8       this Act is as follows:

1   **SEC. 2. RESEARCH WITH RESPECT TO MENOPAUSE AND**

2                   **MID-LIFE WOMEN'S HEALTH.**

3                 (a) NIH RESEARCH.—Part A of title IV of the Public  
4   Health Service Act (42 U.S.C. 281 et seq.) is amended  
5   by adding at the end the following:

6   **“SEC. 404P. RESEARCH WITH RESPECT TO MENOPAUSE**

7                   **AND MID-LIFE WOMEN'S HEALTH.**

8                 “(a) RESEARCH AND INNOVATION.—

9                 “(1) IN GENERAL.—The Director of NIH, acting  
10          through the Director of the Office of Research  
11          on Women's Health, shall coordinate and expand re-  
12          search activities conducted by all institutes, centers,  
13          and offices of the National Institutes of Health to  
14          develop and implement Federal research programs  
15          with respect to—

16                 “(A) the impact of the symptoms and tra-  
17          jectories of changes across the menopausal  
18          transition and the postmenopausal period on  
19          women's physical, mental, behavioral, and cog-  
20          nitive health; and

1                 “(B) the prevention of related adverse  
2                 health outcomes among women during the men-  
3                 opausal transition and the postmenopausal pe-  
4                 riod.

5                 “(2) GRANTS.—In carrying out paragraph (1),  
6                 the Director of NIH shall award grants to eligible  
7                 entities to support—

8                 “(A) biomedical and public health research  
9                 and innovation in the development of new treat-  
10                 ments and diagnostic testing services for  
11                 perimenopause and acute and chronic meno-  
12                 pausal symptoms; and

13                 “(B) researchers and clinicians engaged in  
14                 clinical and translational research on meno-  
15                 pause and mid-life women’s health.

16                 “(3) ELIGIBLE ENTITIES.—To be eligible to re-  
17                 ceive a grant under subsection (b), an entity shall  
18                 meet such criteria as the Director of NIH may es-  
19                 tablish, and shall be—

20                 “(A) an accredited entity that offers edu-  
21                 cation to students in various health professions,  
22                 such as—

23                         “(i) a teaching hospital;

24                         “(ii) an accredited school of medicine,  
25                         osteopathic medicine, nursing, or phar-

1 macy, or a physician assistant training  
2 program, including a historically Black col-  
3 lege or university (as defined by the term  
4 ‘part B institution’ in section 322 of the  
5 Higher Education Act of 1965 or described  
6 in section 326(e)(1) of the Higher Edu-  
7 cation Act of 1965) or other minority-serv-  
8 ing institutions (as described in section  
9 371(a) of the Higher Education Act of  
10 1965));

11 “(iii) a certified behavioral health clin-  
12 ic with an accredited medical or nursing  
13 residency program;

14 “(iv) an accredited public or nonprofit  
15 private hospital with an accredited medical  
16 or nursing residency program;

17 “(v) an accredited nurse practitioner  
18 residency program that includes and ac-  
19 credited nursing residency program; or

20 “(vi) a related accredited program en-  
21 gaged in the care, treatment, or manage-  
22 ment of menopausal symptoms;

23 “(B) an academic research institution or  
24 other nonprofit research institution;

25 “(C) a small business; or

1               “(D) such other entity as the Director of  
2               NIH may determine appropriate.

3               “(b) RESEARCH, CONDITION, AND DISEASE CAT-  
4               EGORIZATION.—The Director of NIH shall designate, in  
5               the Research, Condition, and Disease Categorization, new  
6               categories for chronic or debilitating conditions among  
7               women, to analyze and coordinate current and future re-  
8               search on menopause, menopausal symptoms, and short-  
9               term and long-term effects of such symptoms on mid-life  
10              women’s health.

11              “(c) COORDINATION.—The Director of the NIH shall  
12              coordinate and expand Federal research programs and ac-  
13              tivities to study acute and chronic menopausal symptoms,  
14              including—

15              “(1) vasomotor symptoms;  
16              “(2) osteoporosis;  
17              “(3) sarcopenia;  
18              “(4) temporomandibular disorders;  
19              “(5) joint and nerve pain;  
20              “(6) trauma, anxiety, depression, mood dis-  
21              orders, and related mental and behavioral health  
22              conditions;  
23              “(7) short-term memory loss;  
24              “(8) genitourinary conditions;  
25              “(9) alopecia;

1           “(10) vision or hearing impairments;  
2           “(11) digestive and metabolic disorders;  
3           “(12) chronic sleep deficiency, insomnia, and  
4           related sleep disorders; and  
5           “(13) other menopausal symptoms and related  
6           conditions, as the Director of NIH determines ap-  
7           propriate.

8         “(d) TRANSLATIONAL RESEARCH.—The Secretary  
9           shall expand translational research activities to accelerate  
10          translation of Federal research on perimenopause and  
11          menopausal symptoms and facilitate equitable delivery of  
12          perimenopause and menopause care and related mid-life  
13          women’s health services.

14         “(e) OUTREACH AND ENGAGEMENT.—The Secretary  
15          shall expand outreach and engagement activities with ac-  
16          credited schools of medicine, institutions of higher edu-  
17          cation, and research institutions to support Federal re-  
18          search activities with respect to menopausal symptoms.”.

19         (b) PUBLIC HEALTH RESEARCH AND DATA REPORT-  
20          ING ACTIVITIES.—Part A of title III of the Public Health  
21          Service Act (42 U.S.C. 241 et seq.) is amended by adding  
22          at the end the following:

1   **“SEC. 310C. RESEARCH RELATING TO MID-LIFE WOMEN’S**  
2                 **HEALTH.**

3         “(a) PUBLIC HEALTH RESEARCH.—The Secretary  
4 shall expand research activities with respect to the severity  
5 and duration of menopausal symptoms and related chronic  
6 conditions affecting mid-life health outcomes among  
7 women, including mental and behavioral health outcomes.  
8 In carrying out activities under this section, the Secretary  
9 shall coordinate with existing programs and activities of  
10 the Department of Health and Human Services.

11         “(b) HEALTH CARE QUALITY RESEARCH.—The Sec-  
12 retary shall expand research, program evaluation, and  
13 quality improvement activities to improve health care de-  
14 livery for the care, treatment, or management of  
15 perimenopause and menopausal symptoms and related  
16 chronic conditions, including data collection with respect  
17 to preventive services that support mid-life health out-  
18 comes among women and barriers to care.

19         “(c) DASHBOARD.—The Secretary shall establish and  
20 maintain a dashboard for the reporting of data on meno-  
21 pausal symptoms and mid-life health outcomes among  
22 women gathered through public health surveillance activi-  
23 ties with respect to screening, testing, treatment, and pre-  
24 vention services, and the impact of this section and section  
25 404P on such efforts.

1       “(d) OCCUPATIONAL HEALTH RESEARCH.—The Sec-  
2 retary shall conduct research activities and expand data  
3 collection with respect to workplace stressors related to se-  
4 vere acute or chronic menopausal symptoms, physical in-  
5 jury, or other adverse health outcomes among women, in-  
6 cluding traumatic stress, anxiety, depression, and related  
7 mental and behavioral health conditions. The Secretary  
8 shall review existing evidence, identify gaps in services,  
9 and develop evidence-informed recommendations for re-  
10 lated public health interventions and support services.

11       “(e) INTERAGENCY COORDINATION.—The Secretary  
12 shall develop and implement new interagency research ini-  
13 tiatives or programs to address menopausal symptoms.”.

14       (c) AUTHORIZATION OF APPROPRIATIONS.—For the  
15 purpose of carrying out sections 404P and 310C of the  
16 Public Health Service Act, as added by subsections (a)  
17 and (b), respectively, there are authorized to be appro-  
18 priated \$25,000,000 for each of fiscal years 2025 through  
19 2029.

20 **SEC. 3. PUBLIC HEALTH PROMOTION AND PREVENTION.**

21       Title III of the Public Health Service Act (42 U.S.C.  
22 241 et seq.) is amended by adding at the end the fol-  
23 lowing:

## **“PART W—ACTIVITIES TO PROMOTE MID-LIFE WOMEN’S HEALTH**

### **3 SEC. 39900. PUBLIC HEALTH PROMOTION ACTIVITIES.**

4       “(a) CHRONIC CONDITIONS AND PUBLIC HEALTH  
5 PROMOTION.—The Secretary shall expand public health  
6 promotion and prevention activities with respect to mid-  
7 life women’s health and chronic conditions, including dia-  
8 betes, hypertension, heart disease, iron-deficiency anemia,  
9 inflammation, fibroids, endometriosis, and other related  
10 conditions and adverse health outcomes, at the discretion  
11 of the Secretary.

12        "(b) EARLY DETECTION, DIAGNOSIS, AND TREAT-  
13 MENT —

14           “(1) IN GENERAL.—The Secretary shall award  
15 grants to eligible entities to improve the early detec-  
16 tion, diagnosis, and treatment of perimenopause and  
17 menopausal symptoms and support public health ac-  
18 tivities to expand access to quality care services and  
19 improve mid-life health outcomes among women.

“(2) ELIGIBLE ENTITIES.—To be eligible to receive a grant under paragraph (1), an entity shall

22 “(A) be—

1                         “(ii) an accredited entity that offers  
2                         education to students in various health  
3                         professions; or

4                         “(iii) such other type of entity, as the  
5                         Secretary determines appropriate; and

6                         “(B) submit an application to the Sec-  
7                         retary at such time, in such manner, and con-  
8                         taining such information as the Secretary may  
9                         require.

10                 “(c) CARE COORDINATION.—The Secretary shall  
11                 award grants to eligible entities described in subsection  
12                 (b)(2) to support care coordination and care planning ac-  
13                 tivities, including such activities otherwise supported  
14                 under this Act, and expand access to quality primary care  
15                 and specialty care services to improve—

16                 “(1) mid-life women’s health, including activi-  
17                 ties to support the integration of primary care and  
18                 specialty care;

19                 “(2) bone health and muscle loss;

20                 “(3) mental and behavioral health care services;

21                 “(4) joint, nerve, and muscle pain prevention  
22                 services;

23                 “(5) digestive and metabolic health;

24                 “(6) prevention and management of multiple  
25                 chronic conditions;

1           “(7) physical therapy and injury prevention  
2       support services for populations affected by acute  
3       and chronic menopausal symptoms; and

4           “(8) other services that address acute and  
5       chronic conditions that affect women’s health in  
6       perimenopause and menopause.

7       “(d) MENTAL HEALTH AND SUBSTANCE USE PRE-  
8 VENTION.—The Secretary shall develop recommendations  
9 and best practices to—

10          “(1) increase access to mental and behavioral  
11       health care services and substance use disorder pre-  
12       vention services for women experiencing  
13       perimenopause or menopausal symptoms; and

14          “(2) expand substance use disorder treatment,  
15       recovery, and support services for women experi-  
16       encing perimenopause, early menopause, premature  
17       menopause, and related conditions.

18       “(e) HEALTH CARE DELIVERY.—The Secretary shall  
19       develop recommendations and best practices for—

20          “(1) reducing disparities in the management of  
21       menopausal symptoms;

22          “(2) improving access to perimenopause and  
23       menopause health care services; and

24          “(3) providing patient-centered perimenopause  
25       and menopause counseling and treatment.

1       “(f) SAFETY AND EFFECTIVENESS.—The Secretary

2 shall carry out and support—

3           “(1) outreach and engagement activities of the  
4 Food and Drug Administration with health care pro-  
5 viders on perimenopause and menopause and mid-  
6 life women’s health;

7           “(2) oversight efforts to assess the safety and  
8 effectiveness of new diagnostic tools for  
9 perimenopause or menopausal symptoms, including  
10 devices that use artificial intelligence; and

11          “(3) support existing activities of the Depart-  
12 ment of Health and Human Services to enforce pri-  
13 vacy protections for patients.

14       “(g) AUTHORIZATION OF APPROPRIATIONS.—To  
15 carry out this section, there are authorized to be appro-  
16 priated \$10,000,000 for each of fiscal years 2025 through  
17 2029.”.

18 **SEC. 4. PUBLIC HEALTH AWARENESS, EDUCATION, AND**  
19                   **OUTREACH PROGRAM ON MENOPAUSE AND**  
20                   **MID-LIFE WOMEN’S HEALTH.**

21          Part W of title III of the Public Health Service Act  
22 (42 U.S.C. 241 et seq.), as added by section 3, is amended  
23 by adding at the end the following:

1   **“SEC. 399OO-1. PUBLIC HEALTH AWARENESS, EDUCATION,**  
2                   **AND OUTREACH PROGRAM ON MENOPAUSE**  
3                   **AND MID-LIFE WOMEN’S HEALTH.**

4       “(a) IN GENERAL.—The Secretary shall develop and  
5   carry out a national awareness, education, and outreach  
6   program relating to menopausal symptoms, mid-life wom-  
7   en’s health, and related care, treatment, and preventive  
8   services directed at patients, health care providers, first  
9   responders (such as emergency medical service providers),  
10   and related stakeholders. Such awareness, education, and  
11   outreach program shall—

12           “(1) disseminate educational materials and pro-  
13       vide technical assistance for health care providers  
14       and patients to support engagement about  
15       perimenopause and menopause care and treatment  
16       options for menopausal symptoms;

17           “(2) help such providers to identify risk factors  
18       and prevent injury among women with menopausal  
19       symptoms; and

20           “(3) address barriers to related care and treat-  
21       ment services for women.

22       “(b) OUTREACH.—In carrying out this section, the  
23   Secretary shall—

24           “(1) conduct outreach and education activities  
25       related to perimenopause and menopause and mid-  
26       life women’s health that—

1               “(A) include evidence-based information;

2               and

3               “(B) are culturally appropriate, in the case  
4               of such outreach and education activities for In-  
5               dian Tribes;

6               “(2) provide opportunities for State, local, Trib-  
7               al, and territorial public health departments to cus-  
8               tomize public health awareness, education, and out-  
9               reach materials for their populations; and

10              “(3) prioritize populations in areas affected by  
11               barriers to care, including rural and underserved  
12               areas.

13              “(c) COORDINATION.—In carrying out this section,  
14               the Secretary shall coordinate with existing awareness,  
15               education, and outreach programs and activities of the De-  
16               partment of Health and Human Services.

17              “(d) ONLINE RESOURCES.—The Secretary shall de-  
18               velop, operate, and maintain a website to provide edu-  
19               cational materials in accessible formats for health care  
20               providers, patients, and caregivers, regarding  
21               perimenopause, menopause, and mid-life women’s health.

22               Such educational materials may include—

23               “(1) webinars, continuing education modules,  
24               videos, fact sheets, infographics, stakeholder toolkits,

1 or other materials in formats as appropriate and ap-  
2 plicable; and

3               “(2) tailored for health care providers, patients,  
4               caregivers, and other audiences, as the Secretary de-  
5               termines appropriate.

6       “(e) AUTHORIZATION OF APPROPRIATIONS.—To  
7 carry out this section, there are authorized to be appro-  
8 priated \$10,000,000 for each of fiscal years 2025 through  
9 2029.”.

## 10 SEC. 5. TRAINING PROGRAMS TO IMPROVE CARE AND 11 TREATMENT OF MENOPAUSAL SYMPTOMS.

12        Part D of title VII of the Public Health Service Act  
13 (42 U.S.C. 294 et seq.) is amended by inserting after sec-  
14 tion 757 (42 U.S.C. 294f) the following:

15 "SEC. 758. TRAINING PROGRAMS TO IMPROVE CARE AND  
16 TREATMENT OF MENOPAUSAL SYMPTOMS.

17       “(a) GRANTS TO TRAIN HEALTH PROFESSIONALS.—  
18           “(1) IN GENERAL.—The Secretary shall award  
19           grants to eligible entities for the purpose described  
20           in paragraph (2).

“(2) USE OF FUNDS.—A grant awarded under this subsection shall be used to develop, establish, or expand training programs (including accredited residency programs, fellowships, or other related clinical training) for physicians, registered nurses, nurse

1       practitioners, physician assistants, pharmacists,  
2       other health care providers, and students and train-  
3       ees to improve care, treatment, or management serv-  
4       ices for perimenopause, menopausal symptoms, and  
5       related chronic conditions.

6           “(3) ELIGIBILITY.—To be eligible to receive a  
7       grant under this subsection, an entity shall—

8           “(A) be—

9                  “(i) an accredited school of medicine  
10         or osteopathic medicine;

11                  “(ii) an accredited nursing school;

12                  “(iii) an accredited school of phar-  
13         macy;

14                  “(iv) an accredited public or nonprofit  
15         private hospital;

16                  “(v) an accredited medical residency  
17         program;

18                  “(vi) an accredited nurse practitioner  
19         residency program; or

20                  “(vii) a related training program for  
21         clinicians, allied health professionals, or so-  
22         cial workers that interface with affected  
23         populations, which may include hospitals  
24         and research institutions, as determined by  
25         the Secretary; and

1                 “(B) submit an application to the Sec-  
2                 retary at such time, in such manner, and con-  
3                 taining such information as the Secretary may  
4                 require.

5                 “(b) TRAINING OPPORTUNITIES.—The Secretary  
6 shall expand outreach activities to support and expand  
7 training programs, fellowships, and other opportunities for  
8 students, faculty, and trainees (including continuing med-  
9 ical education) or establish new training opportunities to  
10 address barriers to access to—

11                 “(1) primary and specialty care services to sup-  
12 port mid-life women’s health; and  
13                 “(2) early detection, diagnosis, treatment, and  
14 care services for perimenopause, menopausal symp-  
15 toms, and related chronic conditions.

16                 “(c) COORDINATION.—In carrying out this section,  
17 the Secretary shall coordinate with existing awareness,  
18 education, and outreach programs and activities of the De-  
19 partment of Health and Human Services.

20                 “(d) AUTHORIZATION OF APPROPRIATIONS.—To  
21 carry out this section there are authorized to be appro-  
22 priated \$10,000,000 for each of fiscal years 2025 through  
23 2029.”.

1   **SEC. 6. CENTERS OF EXCELLENCE IN MENOPAUSE CAUSE**2                   **AND MID-LIFE WOMEN'S HEALTH.**

3                 Part W of title III of the Public Health Service Act  
4   (42 U.S.C. 241 et seq.), as amended by section 4, is fur-  
5   ther amended by adding at the end the following:

6   **“SEC. 399OO-2. CENTERS OF EXCELLENCE IN MENOPAUSE**7                   **CARE AND MID-LIFE WOMEN'S HEALTH.**

8                 “(a) IN GENERAL.—The Secretary shall designate el-  
9   igible entities as Centers of Excellence in Menopause and  
10 Mid-Life Women's Health, and award grants to such enti-  
11 ties, for purposes of improving professional training re-  
12 sources for health care providers on mid-life women's  
13 health with respect to the care, treatment, and manage-  
14 ment of perimenopause and menopausal symptoms, and  
15 related support services.

16                 “(b) ELIGIBILITY.—To be eligible to receive a des-  
17 ignation and grant under subsection (a), an entity shall—

18                 “(1) be an accredited entity that offers edu-  
19   cation to students in various health professions, or  
20   such other type of entity, as the Secretary deter-  
21   mines appropriate;

22                 “(2) demonstrate community engagement and  
23   partnerships with community stakeholders, including  
24   entities that train health professionals, social work-  
25   ers, community health centers, health systems ad-

1       ministrators, certified behavioral health clinics, and  
2       research institutions; and

3               “(3) submit to the Secretary an application at  
4       such time, in such manner, and containing such in-  
5       formation as the Secretary may require.

6       “(c) ACTIVITIES.—An entity receiving an award  
7       under subsection (a) shall develop and distribute evidence-  
8       based resources to health care providers, patients, and  
9       public health departments regarding the care, treatment,  
10      and management of perimenopause and menopausal  
11      symptoms. Such resources may include information on—

12               “(1) advancements in the treatment or manage-  
13       ment of perimenopause and acute or chronic meno-  
14       pausal symptoms;

15               “(2) the prevention and treatment of related  
16       chronic conditions across different patient popu-  
17       lations to support mid-life women’s health; and

18               “(3) other topic areas that are relevant to the  
19       objectives described in subsection (a).

20       “(d) GEOGRAPHIC DISTRIBUTION.—In awarding  
21       grants under subsection (a), the Secretary shall take into  
22       account regional differences among eligible entities and  
23       ensure equitable geographic distribution.

24       “(e) PRIORITY.—In awarding grants under sub-  
25       section (a), the Secretary shall prioritize eligible entities

1 that provide services in a health professional shortage area  
2 designated under section 332 or to medically underserved  
3 populations, as defined in section 330(b)(3).

4       “(f) EVALUATION.—Each entity receiving an award  
5 under subsection (a) shall submit an annual report to the  
6 Secretary on the activities carried out using such award.

7 The Secretary shall evaluate each project carried out by  
8 an entity receiving an award under this section and shall  
9 report the findings with respect to each such evaluation  
10 to appropriate Federal agencies and public and private en-  
11 tities.

12       “(g) AUTHORIZATION OF APPROPRIATIONS.—To  
13 carry out this section, there are authorized to be appro-  
14 priated such sums as may be necessary for each of fiscal  
15 years 2025 through 2029.”.

16 **SEC. 7. REPORTING REQUIREMENT.**

17       (a) REPORT ON ACTIVITIES CARRIED OUT UNDER  
18 THIS ACT.—Not later than 2 years after the date of enact-  
19 ment of this Act, and every year thereafter, the Secretary  
20 of Health and Human Services shall submit to the Com-  
21 mittee on Appropriations, the Committee on Health, Edu-  
22 cation, Labor, and Pensions, the Committee on Finance,  
23 the Committee on Homeland Security and Government Af-  
24 fairs, the Committee on Indian Affairs, the Committee on  
25 Veterans’ Affairs, and the Special Committee on Aging of

1 the Senate and the Committee on Appropriations, the  
2 Committee on Energy and Commerce, the Committee on  
3 Ways and Means, the Committee on Education and the  
4 Workforce, the Committee on Veterans' Affairs, the Com-  
5 mittee on Natural Resources, and the Committee on Over-  
6 sight and Accountability of the House of Representatives  
7 a report describing the progress of activities carried out  
8 under this Act and the amendments made by this Act.

9 Each such report shall contain—

10                 (1) information with respect to Federal re-  
11 search activities related to perimenopause and meno-  
12 pause and mid-life women's health, including infor-  
13 mation related public health awareness, education,  
14 and outreach activities, including—

15                     (A) data and knowledge gaps, or other bar-  
16 riers, related to research, diagnostic testing,  
17 and treatments with respect to perimenopause,  
18 menopause, menopausal symptoms, and related  
19 health outcomes;

20                     (B) data or information related to barriers  
21 to health care and support services among  
22 women experiencing perimenopause or meno-  
23 pausal symptoms in rural and underserved  
24 areas; and

(3) information about related Federal activities,  
as the Secretary determines appropriate.

13       (b) REPORT ON ACCESS TO CARE AND TREAT-  
14 MENT.—Not later than 2 years after the date of enact-  
15 ment of this Act, the Secretary shall release a report on  
16 barriers to access to care and treatment services for  
17 perimenopause and menopausal symptoms, and rec-  
18 ommendations to reduce any such barriers.

19 (c) AUTHORIZATION OF APPROPRIATIONS.—To carry  
20 out this section, there are authorized to be appropriated  
21 such sums as may be necessary for each of fiscal years  
22 2025 through 2029.

## 23 SEC. 8. COORDINATION.

24 The Secretary of Health and Human Services shall  
25 coordinate activities carried out under this Act (including

1 the amendments made by this Act) with other existing  
2 Federal efforts relating to menopausal symptoms, mid-life  
3 women's health, aging, or public health promotion carried  
4 out by the Department of Veterans Affairs, the Depart-  
5 ment of Defense, and other Federal departments and  
6 agencies, as appropriate.
