A BILL

To amend the Servicemembers Civil Relief Act to provide clarification of delivery of notice of termination of leases of premises and motor vehicles, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Modernizing Notice
5 of Lease Terminations for Servicemembers Act of 2020”.

1 **SEC. 2. CLARIFICATION OF DELIVERY OF NOTICE OF TER-**
2 **MINATION OF LEASES OF PREMISES AND**
3 **MOTOR VEHICLES FOR PURPOSES OF RELIEF**
4 **UNDER SERVICEMEMBERS CIVIL RELIEF**
5 **ACT.**

6 (a) IN GENERAL.—Section 305(c)(2) of the
7 Servicemembers Civil Relief Act (50 U.S.C. 3955(c)(2))
8 is amended—

9 (1) in subparagraph (B), by striking “or” at
10 the end;

11 (2) in subparagraph (C), by striking the period
12 and inserting “; or”; and

13 (3) by adding at the end the following new sub-
14 paragraph:

15 “(D) by electronic means, including—

16 “(i) the direct delivery of material to
17 an electronic address designated by the les-
18 sor (or the lessor’s grantee) or the lessor’s
19 agent (or the agent’s grantee);

20 “(ii) the posting of material to a
21 website or other internet or electronic-
22 based information repository to which ac-
23 cess has been granted to the lessee, the les-
24 sor (or the lessor’s grantee), or the lessor’s
25 agent (or the agent’s grantee); and

1 “(iii) other electronic means reason-
2 ably calculated to ensure actual receipt of
3 the material by the lessor (or the lessor’s
4 grantee) or the lessor’s agent (or the
5 agent’s grantee).”.

6 (b) EFFECTIVE DATE.—The amendments made by
7 subsection (a) shall apply to delivery of notice of lease ter-
8 minations on or after the date the enactment of this Act.
