## A BILL

To amend the Older Americans Act of 1965 to authorize funding for the Research, Demonstration, and Evaluation Center for the Aging Network to engage in certain research and evaluation activities with respect to family caregivers and to revise the definition of the term “family caregiver”.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Family Caregiving Re-  
5       search and Innovation Act”.

1   **SEC. 2. FAMILY CAREGIVERS.**

2                 (a) RESEARCH AND EVALUATION ACTIVITIES.—Sec-  
3   tion 216(b) of the Older Americans Act of 1965 (42  
4   U.S.C. 3020f(b)) is amended—

5                     (1) in paragraph (3), by striking “; and” and  
6   inserting a semicolon;

7                     (2) in paragraph (4), by striking the period and  
8   inserting “; and”; and

9                     (3) by adding at the end the following:

10                     “(5) to carry out research and evaluation activi-  
11   ties under section 201(g) that bolster data, research,  
12   and evidence-based practices with respect to family  
13   caregivers (as defined in section 302), \$30,000,000  
14   for each of fiscal years 2025 through 2029.”.

15                 (b) DEFINITION OF FAMILY CAREGIVER.—

16                     (1) IN GENERAL.—Section 302 of the Older  
17   Americans Act of 1965 (42 U.S.C. 3022) is amend-  
18   ed—

19                     (A) by amending paragraph (3) to read as  
20   follows:

21                     “(3) The term ‘family caregiver’—

22                         “(A) means—

23                             “(i) an adult family member, or an-  
24   other individual, who is an informal pro-  
25   vider of in-home and community care to an  
26   older individual or to an individual of any

age with Alzheimer's disease or a related disorder with neurological and organic brain dysfunction; or

“(ii) an older relative caregiver; and

“(B) does not include an individual providing care whose primary relationship with the individual receiving the care is based on a financial or professional agreement.”;

(B) by redesignating paragraph (4) as paragraph (5); and

(C) by inserting after paragraph (3) the following:

13               “(4) The term ‘older relative caregiver’ means  
14               a caregiver who—

15                         “(A)(i) is age 55 or older; and

16                         “(ii) lives with, is the informal provider of  
17                         in-home and community care to, and is the pri-  
18                         mary caregiver for, a child or an individual with  
19                         a disability;

20                         “(B) in the case of a caregiver for a  
21                         child—

1                         “(ii) is the primary caregiver of the  
2                         child because the biological or adoptive  
3                         parents are unable or unwilling to serve as  
4                         the primary caregivers of the child; and

5                         “(iii) has a legal relationship to the  
6                         child, such as legal custody, adoption, or  
7                         guardianship, or is raising the child infor-  
8                         mally; and

9                         “(C) in the case of a caregiver for an indi-  
10                         vidual with a disability, is the parent, grand-  
11                         parent, or other relative by blood, marriage, or  
12                         adoption, of the individual with a disability.”.

13                         (2) NATIONAL FAMILY CAREGIVER SUPPORT  
14                         PROGRAM.—

15                         (A) DEFINITIONS.—Section 372(a) of the  
16                         Older Americans Act of 1965 (42 U.S.C.  
17                         3030s(a)) is amended—

18                         (i) in paragraph (1), by striking “or  
19                         older relative caregiver”; and  
20                         (ii) by striking paragraph (4).

21                         (B) PROGRAM AUTHORIZED.—Section 373  
22                         of the Older Americans Act of 1965 (42 U.S.C.  
23                         3030s–1) is amended—

24                         (i) in subsection (a), by striking “sys-  
25                         tems” and all that follows through the pe-

1                   riod and inserting “systems of support  
2                   services for family caregivers.”;

3                   (ii) by amending subsection (c)(1) to  
4                   read as follows:

5                   “(1) POPULATION SERVED.—

6                   “(A) IN GENERAL.—Subject to subparagraph (B), services under a State program  
7                   under this part shall be provided to family care-  
8                   givers.

9  
10                  “(B) RESPITE CARE AND SUPPLEMENTAL  
11                  SERVICES.—With regard to the services speci-  
12                  fied in paragraphs (4) and (5) of subsection  
13                  (b), in the case of a caregiver described in  
14                  clause (i) of section 302(3)(A), such services  
15                  shall be provided only to such a caregiver who  
16                  is providing care to an older individual who  
17                  meets the condition specified in subparagraph  
18                  (A)(i) or (B) of section 102(22).”;

19                  (iii) in subsection (f)(3), by striking  
20                  “family caregivers, or older relative care-  
21                  givers,” and inserting “family caregivers”;  
22                  and

23                  (iv) in subsection (i)(1), by striking  
24                  “family caregivers and older relative care-  
25                  givers” and inserting “family caregivers”.

## 1                   (3) ADDITIONAL CONFORMING AMENDMENT.—

2                   Section 417(a)(1)(F)(i) of the Older Americans Act  
3                   of 1965 (42 U.S.C. 3032f(a)(1)(F)(i)) is amended  
4                   by striking “(as defined in section 372(a))” and in-  
5                   serting “(as defined in section 302)”.
