A BILL

To amend title 38, United States Code, to provide a burial allowance for certain veterans who die at home while in receipt of hospice care furnished by the Department of Veterans Affairs.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Gerald’s Law Act”.

1 **SEC. 2. BURIAL ALLOWANCE FOR CERTAIN VETERANS WHO**
2 **DIE AT HOME WHILE IN RECEIPT OF HOS-**
3 **PICE CARE FURNISHED BY DEPARTMENT OF**
4 **VETERANS AFFAIRS.**

5 (a) IN GENERAL.—Subsection (a)(2)(A) of section
6 2303 of title 38, United States Code, as amended by sec-
7 tion 2202(a)(3)(B)(ii) of the Johnny Isakson and David
8 P. Roe, M.D. Veterans Health Care and Benefits Improve-
9 ment Act of 2020 (Public Law 116–315; 134 Stat. 4984),
10 is further amended—

11 (1) in clause (i), by striking “; or” and insert-
12 ing a semicolon;

13 (2) in clause (ii)—

14 (A) in subclause (II), by striking “; or”
15 and inserting a semicolon; and

16 (B) in subclause (III), by striking the pe-
17 riod at the end and inserting “; or”; and

18 (3) by adding at the end the following new
19 clause:

20 “(iii) a home or other setting at which the
21 deceased veteran was, at the time of death, re-
22 ceiving hospice care pursuant to section
23 1717(a) of this title if such care was directly
24 preceded by the Secretary furnishing to the vet-
25 eran hospital care or nursing home care as de-

1 scribed in subclause (I), (II), or (III) of clause
2 (ii).”.

3 (b) **EFFECTIVE DATE.**—The amendments made by
4 subsection (a) shall take effect as if included in the enact-
5 ment of the Johnny Isakson and David P. Roe, M.D. Vet-
6 erans Health Care and Benefits Improvement Act of 2020
7 (Public Law 116–315).
