A BILL

To sunset the Advisory Committee on the Records of Congress, and for other purposes.

1 *Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Advisory Committee on the Records of Congress Sunset Act of 2024”.

1 SEC. 2. MANAGEMENT AND PRESERVATION OF THE
2 **RECORDS OF CONGRESS.**

3 (a) DEFINITIONS.—In this section—

4 (1) the term “Archivist” means the Archivist of
5 the United States;

6 (2) the term “Clerk” means the Clerk of the
7 House of Representatives;

8 (3) the term “Director” means the Director of
9 the Center for Legislative Archives of the National
10 Archives, or any successor thereto;

11 (4) the term “Member of Congress” means a
12 Member of the Senate or the House of Representa-
13 tives, a Delegate to the House of Representatives,
14 and the Resident Commissioner from Puerto Rico;
15 and

16 (5) the term “Secretary” means the Secretary
17 of the Senate.

18 (b) REPORTING.—Not later than February 1 of the
19 second calendar year beginning after the date of enact-
20 ment of this Act, and every calendar year thereafter, the
21 Director shall submit to the Archivist, the Secretary, and
22 the Clerk a report on the management and preservation
23 of the records of Congress during the previous year.

24 (c) REVIEW.—The Archivist, the Secretary, and the
25 Clerk shall meet to review the management and preserva-

1 tion of the records of Congress and Members of Con-
2 gress—

3 (1) not later than 60 days after the date on
4 which the Director submits a report under sub-
5 section (b); and

6 (2) not later than 180 days after the date on
7 which an individual is appointed to the position of
8 Archivist, Secretary, or Clerk.

9 (d) **SUNSET OF ADVISORY COMMITTEE.**—Effective
10 on the date that is 60 days after the date of enactment
11 of this Act, title 44 of the United States Code is amend-
12 ed—

13 (1) by striking chapter 27;

14 (2) by striking the table of sections relating to
15 chapter 27; and

16 (3) in the table of chapters, by striking the item
17 relating to chapter 27.

18 **SECTION 1. SHORT TITLE.**

19 *This Act may be cited as the “Advisory Committee on
20 the Records of Congress Sunset Act of 2024”.*

21 **SEC. 2. MANAGEMENT AND PRESERVATION OF THE
22 RECORDS OF CONGRESS.**

23 (a) **DEFINITIONS.**—In this section—

24 (1) the term “Archivist” means the Archivist of
25 the United States;

1 (2) the term “Clerk” means the Clerk of the
2 House of Representatives;

3 (3) the term “Director” means the Director of the
4 Center for Legislative Archives of the National Ar-
5 chives, or any successor thereto;

6 (4) the term “Member of Congress” means a
7 Member of the Senate or the House of Representatives,
8 a Delegate to the House of Representatives, and the
9 Resident Commissioner from Puerto Rico; and

10 (5) the term “Secretary” means the Secretary of
11 the Senate.

12 (b) REPORTING.—Not later than February 1 of the sec-
13 ond calendar year beginning after the date of enactment
14 of this Act, and every calendar year thereafter, the Director
15 shall submit a report on the management and preservation
16 of the records of Congress during the previous year to—

17 (1) the Archivist;

18 (2) the Secretary;

19 (3) the Clerk;

20 (4) the Committee on Homeland Security and
21 Governmental Affairs and the Committee on Rules
22 and Administration of the Senate; and

23 (5) the Committee on Oversight and Account-
24 ability and the Committee on House Administration
25 of the House of Representatives.

1 (c) *REVIEW.*—*The Archivist, the Secretary, and the*
2 *Clerk shall meet to review the management and preserva-*
3 *tion of the records of Congress and Members of Congress—*

4 (1) *not later than 60 days after the date on*
5 *which the Director submits a report under subsection*
6 *(b); and*

7 (2) *not later than 180 days after the date on*
8 *which an individual is appointed to the position of*
9 *Archivist, Secretary, or Clerk.*

10 (d) *SUNSET OF ADVISORY COMMITTEE.*—*Effective on*
11 *the date that is 60 days after the date of enactment of this*
12 *Act, title 44 of the United States Code is amended—*

13 (1) *by striking chapter 27;*
14 (2) *by striking the table of sections relating to*
15 *chapter 27; and*

16 (3) *in the table of chapters, by striking the item*
17 *relating to chapter 27.*
