## A BILL

To amend title XVIII of the Social Security Act to reauthorize the Rural Flex program, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-  
2 tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Rural Hospital Flexi-  
5 bility Act of 2024”.

6 **SEC. 2. MEDICARE RURAL HOSPITAL FLEXIBILITY PRO-  
7 GRAM GRANTS.**

8       Section 1820 of the Social Security Act (42 U.S.C.  
9 1395i–4) is amended—

10              (1) in subsection (g)—

- 1                             (A) in paragraph (1)—  
2                                 (i) in subparagraph (C), by striking  
3                                 “and” at the end;  
4                                 (ii) by amending subparagraph (D) to  
5                                 read as follows:  
6                                 “(D) providing support for critical access  
7                                 hospitals, certified rural health clinics, and  
8                                 rural emergency hospitals (as defined in section  
9                                 1861(kkk)(2)) for quality improvement, quality  
10                                 reporting, performance improvements,  
11                                 benchmarking, addressing population health,  
12                                 transforming services, and providing linkages  
13                                 and services for behavioral health and sub-  
14                                 stance use disorders responding to public health  
15                                 emergencies;”; and  
16                                 (iii) by adding at the end the fol-  
17                                 lowing new subparagraphs:  
18                                 “(E) providing support for critical access  
19                                 hospitals to convert to rural emergency hos-  
20                                 pitals to stabilize hospital emergency services in  
21                                 their communities; and  
22                                 “(F) conducting outreach regarding the  
23                                 availability of payments for direct graduate  
24                                 medical education costs under section 1886(h),  
25                                 providing information regarding eligibility for

1           direct graduate medical education residency po-  
2           sitions, and providing assistance with the appli-  
3           cation process for the distribution of such posi-  
4           tions to—

5                 “(i) critical access hospitals;  
6                 “(ii) hospitals located in rural areas  
7                     (as defined in section 1886(d)(2)(D)), ex-  
8                     cluding hospitals that are treated as being  
9                     located in a rural area pursuant to section  
10                     1886(d)(8)(E);

11                 “(iii) hospitals located in an area that  
12                     has a rural-urban commuting code of no  
13                     less than 4.0;

14                 “(iv) sole community hospitals (as de-  
15                     fined in section 1886(d)(5)(D)(iii));

16                 “(v) sites that are located within 10  
17                     miles of a sole community hospital (as de-  
18                     fined in section 1886(d)(5)(D)(iii)); and

19                 “(vi) rural emergency hospitals.”;

20             (B) by redesignating paragraphs (3)  
21             through (7) as paragraphs (4) through (8), re-  
22             spectively;

23             (C) after paragraph (2), by inserting the  
24             following new paragraph:

1                 “(3) ACTIVITIES TO SUPPORT CARRYING OUT  
2 OTHER GRANTS.—The Secretary may award grants  
3 or cooperative agreements to entities that submit to  
4 the Secretary applications, at such time and in such  
5 form and manner and containing such information  
6 as the Secretary specifies, for purposes of supporting  
7 recipients in carrying out the activities under this  
8 subsection by providing technical assistance, data  
9 analysis, and evaluation efforts.”;

10                 (D) in paragraph (4), as redesignated by  
11 subparagraph (B)—

12                     (i) in subparagraph (A)—  
13                             (I) in the header by striking  
14                             “HOSPITALS ” and inserting “STATE  
15                             OFFICES OF RURAL HEALTH”; and

16                             (II) by inserting “State Offices  
17                             of Rural Health on behalf of eligible  
18                             small rural” after “award grants to”;

19                     (ii) by amending subparagraph (B) to  
20 read as follows:

21                 “(B) ELIGIBLE SMALL RURAL HOSPITAL  
22 DEFINED.—For purposes of this paragraph, the  
23 term “eligible small rural hospital” means—

24                     “(i) a non-Federal, short-term general  
25 acute hospital that—

1                         “(I) is located in a rural area (as  
2                         defined for purposes of section  
3                         1886(d)); and

4                         “(II) has less than 50 beds; or  
5                         “(ii) a rural emergency hospital (as  
6                         defined in section 1861(kkk)(2));”;

7                         (iii) by amending subparagraph (C) to  
8                         read as follows:

9                         “(C) APPLICATION.—The State Office of  
10                         Rural Health shall submit an application, on  
11                         behalf of eligible small rural hospitals, to the  
12                         Secretary on or before such date and in such  
13                         form and manner as the Secretary specifies.”;

14                         (iv) by amending subparagraph (D) to  
15                         read as follows:

16                         “(D) AMOUNT OF GRANT.—A grant under  
17                         this paragraph shall be determined on an equal  
18                         national distribution so that each eligible small  
19                         rural hospital receives the same amount of sup-  
20                         port related to the funds appropriated.”;

21                         (v) by amending subparagraph (E) to  
22                         read as follows:

23                         “(E) USE OF FUNDS.—State Offices of  
24                         Rural Health and eligible small rural hospitals

1 may use the funds received through a grant  
2 under this paragraph for—

3 “(i) the purchase of computer soft-  
4 ware and hardware;

5 “(ii) the education and training of  
6 hospital staff on billing, operational, qual-  
7 ity improvement, and related value-focused  
8 efforts; and

9 “(iii) other delivery system reform  
10 programs determined appropriate by the  
11 Secretary.”; and

12 (vi) in subparagraph (F)—

13 (I) in clause (i), by striking “A  
14 hospital receiving a grant under this  
15 section” and inserting “An entity re-  
16 ceiving a grant under this para-  
17 graph”; and

18 (II) in clause (ii), by striking  
19 “under this section” and inserting  
20 “under this paragraph” each place it  
21 appears; and

22 (E) in paragraph (5), as redesignated by  
23 subparagraph (B), in the matter preceding sub-  
24 paragraph (A), by striking “or (2)” and insert-  
25 ing “, (2), or (4)” ; and

- 1                   (2) in subsection (j)—  
2                   (A) by striking “from the Federal Hospital  
3                   Insurance Trust Fund”; and  
4                   (B) by striking “in each of fiscal years  
5                   2011 and 2012” and inserting “in fiscal year  
6                   2011 and each subsequent fiscal year”.
