## A BILL

To require the Secretary of Agriculture and the Secretary of the Interior to prioritize the completion of the Continental Divide National Scenic Trail, and for other purposes.

1       *Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled,*

1   **SECTION 1. SHORT TITLE.**

2       This Act may be cited as the “Continental Divide  
3   Trail Completion Act”.

4   **SEC. 2. DEFINITIONS.**

5       In this Act:

6           (1) **AEEQUIA.**—The term “acequia” has the  
7       meaning given the term “community ditch” in New  
8       Mexico Stat. ~~73-2-27~~.

9           (2) **LAND GRANT-MERCED.**—The term “land  
10       grant-merced” means a community land grant  
11       issued under the laws or customs of the Government  
12       of Spain or Mexico that is recognized under chapter  
13       49 of New Mexico Stat. (or a successor statute).

14           (3) **OPTIMAL LOCATION REVIEW.**—The term  
15       “optimal location review” means a review conducted  
16       in accordance with the process described in the  
17       guide entitled “Continental Divide National Scenic  
18       Trail Optimal Location Review Guide” and dated  
19       November 2017.

20           (4) **SECRETARIES.**—The term “Secretaries”  
21       means each of the Secretary and the Secretary of  
22       the Interior.

23           (5) **SECRETARY.**—The term “Secretary” means  
24       the Secretary of Agriculture, acting through the  
25       Chief of the Forest Service.

1                     (6) TEAM.—The term “Team” means the joint  
2                     Forest Service and Bureau of Land Management  
3                     Trail completion team established under section  
4                     3(b).

5                     (7) TRAIL.—The term “Trail” means the Continental  
6                     Divide National Scenic Trail established by  
7                     section 5(a)(5) of the National Trails System Act  
8                     (16 U.S.C. 1244(a)(5)).

9                     **SEC. 3. CONTINENTAL DIVIDE NATIONAL SCENIC TRAIL.**

10                    (a) COMPLETION OF TRAIL.—

11                    (1) IN GENERAL.—Not later than November  
12                     10, 2028, the Secretaries shall, to the maximum ex-  
13                     tent practicable, ensure the completion of the Trail  
14                     as a contiguous route, consistent with sections  
15                     3(a)(2), 5(a)(5), and 7 of the National Trails Sys-  
16                     tem Act (16 U.S.C. 1242(a)(2), 1244(a)(5), 1246).

17                    (2) REQUIRED ACTIVITIES.—The Secretaries  
18                     shall, to the maximum extent practicable, carry out  
19                     necessary activities to achieve the goal described in  
20                     paragraph (1), including the following activities, in  
21                     the following order of priority:

22                    (A) Complete the Trail by acquiring land  
23                     or an interest in land, entering into easement  
24                     agreements, or encouraging a State or local  
25                     government to enter into a cooperative agree-

1           ment to acquire any interest in land, that is  
2           necessary—

3                 (i) to eliminate gaps between sections  
4                 of the Trail; and

5                 (ii) to maintain the nature and pur-  
6                 poses of the Trail.

7                 (B) If appropriate and supported by local  
8                 affected stakeholders, optimize the Trail by re-  
9                 locating, consistent with the nature and pur-  
10                 poses of the Trail, existing incompatible por-  
11                 tions of the Trail onto Federal land as nee-  
12                 ssary to provide for—

13                 (i) maximum outdoor recreation po-  
14                 tential;

15                 (ii) the conservation and enjoyment of  
16                 the nationally significant scenic, historic,  
17                 natural, or cultural qualities of the areas  
18                 through which the Trail passes;

19                 (iii) continuity in land ownership, if  
20                 desired by the owner of the affected land;  
21                 and

22                 (iv) segments of the Trail that are  
23                 comparable in length to the segments of  
24                 the Trail being relocated.

1                             (C) Publish maps of the completed corridor  
2                             of the Trail.

3                             (b) TRAIL COMPLETION TEAM.—

4                             (1) IN GENERAL.—In carrying out subsection  
5                             (a), not later than 1 year after the date of enact-  
6                             ment of this Act, the Secretaries shall establish a  
7                             joint Forest Service and Bureau of Land Manage-  
8                             ment Trail completion team to work in coordination  
9                             with the administrator of the Trail to facilitate the  
10                            completion and optimization of the Trail, pursuant  
11                             to the purposes of section 3(a)(2) of the National  
12                             Trails System Act (~~16 U.S.C. 1242(a)(2)~~), con-  
13                             sistent with the nature and purposes of the Trail.

14                             (2) DUTIES OF THE TEAM.—The Team shall—

15                             (A) carry out land and right-of-way acqui-  
16                             sitions, easement acquisitions, relocations, and  
17                             Trail construction activities, consistent with any  
18                             optimal location reviews, giving priority to land  
19                             that—

20                             (i) eliminates gaps between segments  
21                             of the Trail;

22                             (ii) may be acquired for the Trail by  
23                             the Secretary or the Secretary of the Inter-  
24                             rior by—

25                             (I) purchase from a willing seller;

- 1                             (H) donation;
- 2                             (III) exchange;
- 3                             (IV) cooperative agreement; or
- 4                             (V) easement agreement;
- 5                             (iii) is best suited for inclusion in the
- 6                             Trail corridor in accordance with the pur-
- 7                             poses, policy, and provisions of the Na-
- 8                             tional Trails System Act (16 U.S.C. 1241
- 9                             et seq.);
- 10                            (iv) if appropriate and supported by
- 11                             local affected stakeholders, has been identi-
- 12                             fied as a segment of the Trail on Federal
- 13                             land that should be relocated to provide for
- 14                             maximum outdoor recreation potential and
- 15                             the conservation and enjoyment of the na-
- 16                             tionally significant scenic, historic, natural,
- 17                             or cultural qualities of the areas through
- 18                             which the Trail passes;
- 19                             (v) mitigates land use conflicts;
- 20                             (vi) would support the development of
- 21                             rural communities through use as a trail;
- 22                             and
- 23                             (vii) minimizes the distance to connect
- 24                             compatible segments of the Trail;

1                   (B) provide the necessary administrative  
2                   and technical support to complete conveyances  
3                   of the Trail corridor under subsection (a);

4                   (C) as appropriate, consult with other Federal  
5                   agencies, Governors of the affected States,  
6                   affected Indian Tribes, local governments, af-  
7                   fected land owners, land grant mercedes,  
8                   acequias, and applicable owners or users of a  
9                   land grant mercede or acequia, the Continental  
10                  Divide Trail Coalition, and other volunteer and  
11                  nonprofit organizations that assist in the devel-  
12                  opment, maintenance, and management of the  
13                  Trail; and

14                  (D) support the Secretary in the develop-  
15                  ment of the comprehensive development plan  
16                  for the Trail under subsection (e) and annual  
17                  reports under subsection (f).

18                  (e) **COMPREHENSIVE DEVELOPMENT PLAN.**—

19                  (1) **IN GENERAL.**—Not later than 2 years after  
20                  the date of establishment of the Team under sub-  
21                  section (b), the Secretary shall submit to the Com-  
22                  mittee on Energy and Natural Resources of the Sen-  
23                  ate and the Committee on Natural Resources of the  
24                  House of Representatives a comprehensive develop-  
25                  ment plan for the Trail.

1                             (2) RECOMMENDED INCLUSIONS.—The plan  
2 submitted under paragraph (1) should—

3                             (A) identify any gaps in the Trail with re-  
4 speet to which the Secretaries have not been  
5 able to acquire land or interests in land by pur-  
6 chase from a willing seller, donation, exchange,  
7 cooperative agreement, or easement agreement;

8                             (B) include a plan for closing the gaps  
9 identified under paragraph (1) by acquiring  
10 land or interests in land or entering into an  
11 easement agreement; and

12                             (C) include general and site-specific devel-  
13 opment plans, including anticipated costs.

14                             (d) METHOD OF ACQUISITION.—In carrying out this  
15 section, the Secretaries—

16                             (1) may acquire land or an interest in land only  
17 by—

18                                 (A) purchase from a willing seller with do-  
19 nated or appropriated funds;

20                                 (B) donation;

21                                 (C) exchange;

22                                 (D) cooperative agreement; or

23                                 (E) easement agreement; and

24                             (2) may not acquire land or an interest in land  
25 by eminent domain.

1       (e) MAINTAINING EXISTING PARTNERSHIPS.—In  
2 carrying out this section, the Secretaries shall continue to  
3 maintain and develop working relationships with volunteer  
4 and nonprofit organizations that assist in the develop-  
5 ment, maintenance, and management of the Trail.

6       (f) REPORTS.—Not later than September 30, 2024,  
7 and not later than the end of each fiscal year thereafter  
8 until the date on which the comprehensive development  
9 plan for the Trail is determined by the Secretary to be  
10 fully implemented, the Secretary shall submit to the Com-  
11 mittee on Energy and Natural Resources of the Senate  
12 and the Committee on Natural Resources of the House  
13 of Representatives a report that includes the following:

14              (1) A description of the progress of the Secre-  
15 taries in acquiring land or interests in land to com-  
16 plete the Trail consistent with this Act.

17              (2) The quantity of land or interests in land ac-  
18 quired during the fiscal year and the amount ex-  
19 pended for the land or interests in land.

20              (3) The quantity of land or interests in land  
21 planned for acquisition in the subsequent fiscal year  
22 and the estimated cost of the land or interests in  
23 land.

24              (4) The estimated quantity of land or interests  
25 in land remaining to be acquired after taking into

1 account the acquisitions under paragraphs (2) and  
2 (3).

3 (5) The existing number of miles of the Trail  
4 on Federal land that need to be relocated to provide  
5 for—

6 (A) maximum outdoor recreation potential;

7 and

8 (B) conservation and enjoyment of the na-  
9 tionally significant scenic, historic, natural, or  
10 cultural qualities of the areas through which  
11 the Trail passes.

12 **SECTION 1. SHORT TITLE.**

13 This Act may be cited as the “Continental Divide Na-  
14 tional Scenic Trail Completion Act”.

15 **SEC. 2. DEFINITIONS.**

16 In this Act:

17 (1) SECRETARY.—The term “Secretary” means  
18 the Secretary of Agriculture.

19 (2) TRAIL.—The term “Trail” means the Conti-  
20 nental Divide National Scenic Trail.

21 (3) TRAIL COMPLETION TEAM.—The term “Trail  
22 Completion Team” means the joint Forest Service-Bu-  
23 reau of Land Management Trail completion team es-  
24 tablished under section 4(a).

1 **SEC. 3. COMPLETION OF CONTINENTAL DIVIDE NATIONAL**2 **SCENIC TRAIL.**

3       *Subject to the availability of appropriations, the Sec-*  
4   *retary and the Secretary of the Interior shall seek to com-*  
5   *plete the Trail as a continuous route not later than the 50th*  
6   *anniversary of the date of designation of the Trail as a na-*  
7   *tional scenic trail.*

8 **SEC. 4. TRAIL COMPLETION TEAM.**

9       *(a) IN GENERAL.—Not later than 1 year after the date*  
10   *of enactment of this Act, the Secretary and the Secretary*  
11   *of the Interior shall establish a joint Forest Service-Bureau*  
12   *of Land Management Trail completion team to work in co-*  
13   *ordination with the administrator of the Trail—*

14           *(1) to facilitate the completion and optimization*  
15   *of the Trail, consistent with the purposes of the Trail;*  
16   *and*

17           *(2) to assist in the development of the com-*  
18   *prehensive development plan for the Trail under sec-*  
19   *tion 5.*

20       *(b) CONSULTATION.—As appropriate, the Trail Com-*  
21   *pletion Team shall consult with other Federal agencies, af-*  
22   *fected State, Tribal, and local governments, landowners, af-*  
23   *fected land-grant mercedes owners and users, acequias, and*  
24   *other interested parties in—*

25           *(1) the completion and optimization of the Trail;*  
26   *and*

1                   (2) the development and completion of the com-  
2                   prehensive development plan for the Trail under sec-  
3                   tion 5.

4                   **SEC. 5. COMPREHENSIVE DEVELOPMENT PLAN FOR THE**  
5                   **CONTINENTAL DIVIDE NATIONAL SCENIC**  
6                   **TRAIL.**

7                   (a) *IN GENERAL.*—Not later than 3 years after the  
8 date of establishment of the Trail Completion Team under  
9 section 4(a), the Secretary shall complete a comprehensive  
10 development plan for the Trail.

11                  (b) *PLAN INCLUSIONS.*—The comprehensive develop-  
12 ment plan under subsection (a) shall—

13                  (1) identify any gaps in the Trail for which the  
14 Secretary and the Secretary of the Interior have not  
15 been able to acquire land;

16                  (2) identify opportunities for the use of ease-  
17 ments acquired from willing sellers to facilitate com-  
18 pletion of the Trail; and

19                  (3) include general and site-specific Trail devel-  
20 opment plans, including anticipated costs of the  
21 plans.

22                  **SEC. 6. PARTNERSHIPS.**

23                  The Secretary and the Secretary of the Interior shall  
24 seek to enter into agreements with volunteer and nonprofit

1 organizations, as appropriate, to facilitate the completion  
2 and administration of the Trail.

3 **SEC. 7. EFFECT.**

4 *Nothing in this Act—*

5           *(1) provides any authority to acquire land or in-*  
6           *terests in land for inclusion in the Trail beyond the*  
7           *authorities provided for the Trail in the National*  
8           *Trails System Act (16 U.S.C. 1241 et seq.), including*  
9           *acquisition by eminent domain; or*

10          *(2) makes the acquisition of land or interests in*  
11          *land for the Trail a priority over other land acqui-*  
12          *sition authorizations.*
