A BILL

To amend the Omnibus Public Land Management Act of 2009 to make a technical correction to the water rights settlement for the Shoshone-Paiute Tribes of the Duck Valley Reservation, and for other purposes.

2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Technical Correction
3 to the Shoshone-Paiute Tribes of the Duck Valley Res-
4 ervation Water Rights Settlement Act of 2021”.

5 **SEC. 2. AUTHORIZATION OF PAYMENT OF INTEREST ON**
6 **TRUST FUNDS ESTABLISHED UNDER SETTLE-**
7 **MENT.**

8 Section 10807 of the Omnibus Public Land Manage-
9 ment Act of 2009 (Public Law 111–11; 123 Stat. 1408)
10 is amended—

11 (1) in subsection (b)(3)—

12 (A) by striking “There is” and inserting
13 the following:

14 “(A) IN GENERAL.—There is”; and

15 (B) by adding at the end the following:

16 “(B) INTEREST PAYMENTS.—There is au-
17 thorized to be appropriated to the Secretary for
18 deposit into the Development Fund the interest
19 that would have accrued during the period be-
20 ginning on October 1, 2009, and ending on
21 January 25, 2016, on balances held in the De-
22 velopment Fund, as calculated using the appli-
23 cable rate for interest-bearing obligations of the
24 United States if the amounts in the Develop-
25 ment Fund had been invested in accordance
26 with—

1 “(i) the Act of April 1, 1880 (21 Stat.
2 70, chapter 41; 25 U.S.C. 161); and

3 “(ii) the first section of the Act of
4 June 24, 1938 (52 Stat. 1037, chapter
5 648; 25 U.S.C. 162a).”;

6 (2) in subsection (c)(3)—

7 (A) by striking “There is” and inserting
8 the following:

9 “(A) IN GENERAL.—There is”;

10 (B) by adding at the end the following:

11 “(B) INTEREST PAYMENTS.—There is au-
12 thorized to be appropriated to the Secretary for
13 deposit into the Maintenance Fund the interest
14 that would have accrued during the period be-
15 ginning on October 1, 2009, and ending on
16 January 25, 2016, on balances held in the
17 Maintenance Fund, as calculated using the ap-
18 plicable rate for interest-bearing obligations of
19 the United States if the amounts in the Mainte-
20 nance Fund had been invested in accordance
21 with—

22 “(i) the Act of April 1, 1880 (21 Stat.
23 70, chapter 41; 25 U.S.C. 161); and

1 “(ii) the first section of the Act of
2 June 24, 1938 (52 Stat. 1037, chapter
3 648; 25 U.S.C. 162a).”.

4 **SEC. 2. AUTHORIZATION OF PAYMENT OF ADJUSTED IN-**
5 **TEREST ON DEVELOPMENT FUND.**

6 *Section 10807(b)(3) of the Omnibus Public Land Man-*
7 *agement Act of 2009 (Public Law 111–11; 123 Stat. 1409)*
8 *is amended—*

9 (1) *by striking “There is” and inserting the fol-*
10 *lowing:*

11 “(A) *IN GENERAL.—There is*”; and

12 (2) *by adding at the end the following:*

13 “(B) *ADJUSTED INTEREST PAYMENTS.—*
14 *There is authorized to be appropriated to the*
15 *Secretary for deposit into the Development Fund*
16 *\$5,124,902.12.”.*
