Mr. UDALL (for himself, Mr. WHITEHOUSE, and Mr. CARPER) introduced the following bill; which was read twice and referred to the Committee on Homeland Security and Governmental Affairs

# A BILL

To require the disclosure of certain visitor access records.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Making Access Records  
5       Available to Lead American Government Openness Act”  
6       or the “MAR-A-LAGO Act”.

7       **SEC. 2. FINDINGS.**

8       Congress finds the following:

9           (1) Beginning in 2009, the Obama administra-  
10          tion instituted a policy to release the visitor access  
11          records for the White House complex.

1                         (2) This policy was responsible for making pub-  
2                         lic the names of nearly 6,000,000 visitors to the  
3                         White House in the 8 years of the Obama adminis-  
4                         tration.

5                         (3) This policy provided the people of the  
6                         United States with insight into who influences the  
7                         White House and transparency regarding efforts by  
8                         lobbyists to effect policies, legislation, and Presi-  
9                         dential actions.

10                         (4) To date, the Trump administration has not  
11                         indicated whether it will continue the policy of pub-  
12                         licly releasing White House visitor access records.

13                         (5) Since taking office on January 20, 2017,  
14                         President Trump has conducted official business not  
15                         only in the White House, but also at several of his  
16                         privately owned clubs and resorts.

17                         (6) President Trump's Mar-a-Lago Club in  
18                         Palm Beach, Florida, has been dubbed the "Winter  
19                         White House" and the "Southern White House".

20                         (7) President Trump has spent 5 of his first 9  
21                         weekends in office at Mar-a-Lago.

22                         (8) Mar-a-Lago is a private membership facility  
23                         open to members, their guests, and others who have  
24                         been invited as guests for special events.

1                         (9) Visitors to Mar-a-Lago do not undergo the  
2                         same background checks as White House visitors  
3                         and visitor access records to the club have not been  
4                         released to the public.

5                         (10) The President has conducted official busi-  
6                         ness and hosted international leaders at Mar-a-Lago.

7                         (11) Media reports have shown President  
8                         Trump and members of his Cabinet at Mar-a-Lago  
9                         and nearby Trump International Golf Club inter-  
10                         acting with members and guests, providing access  
11                         unavailable to the general public.

12                         (12) President Trump owns many other prop-  
13                         erties that offer similar amenities and membership-  
14                         only access where he is likely to conduct official  
15                         business during his term in office.

16                         (13) On March 11, 2017, President Trump  
17                         hosted several members of his Cabinet at his Trump  
18                         National Golf Club in Potomac Falls, Virginia, to  
19                         discuss homeland security, health care, and the  
20                         economy according to media reports.

21                         (14) Media reports have indicated that the  
22                         President may use his Bedminster, New Jersey, re-  
23                         sort as a “Summer White House”.

24                         (15) The people of the United States expect  
25                         and deserve transparency in government. The policy

1 to release visitor access records instituted by the  
2 previous administration appropriately balanced  
3 transparency with the need for confidentiality in  
4 government actions.

5 (16) To the extent Mar-a-Lago and any other  
6 private facilities become locations where the Presi-  
7 dent conducts business and interacts with individ-  
8 uals who are not government officials, the same dis-  
9 closures should apply.

10 **SEC. 3. IMPROVING ACCESS TO INFLUENTIAL VISITOR AC-**  
11 **CESS RECORDS.**

12 (a) **DEFINITIONS.**—In this section:

13 (1) **COVERED LOCATION.**—The term “covered  
14 location” means—

15 (A) the White House;

16 (B) the residence of the Vice President;  
17 and

18 (C) any other location at which the Presi-  
19 dent or the Vice President regularly conducts  
20 official business.

21 (2) **COVERED RECORDS.**—The term “covered  
22 records” means information relating to a visit at a  
23 covered location, which shall include—

24 (A) the name of each visitor at the covered  
25 location;

1                         (B) the name of each individual with whom  
2                         each visitor described in subparagraph (A) met  
3                         at the covered location; and

4                         (C) the purpose of the visit.

5                 (b) REQUIREMENT.—Except as provided in sub-  
6         section (c), not later than 30 days after the date of enact-  
7         ment of this Act, the President shall establish, and update  
8         every 90 days, a publicly available database that contains  
9         covered records for the preceding 90-day period.

10                 (c) EXCEPTIONS.—

11                 (1) IN GENERAL.—The President shall not in-  
12         clude in the database established under subsection  
13         (b) any covered record—

14                         (A) the posting of which would implicate  
15                         personal privacy or law enforcement concerns or  
16                         threaten national security; or

17                         (B) relating to a purely personal guest at  
18                         a covered location.

19                 (2) SENSITIVE MEETINGS.—With respect to a  
20         particularly sensitive meeting at a covered location,  
21         the President shall—

22                         (A) include the number of visitors at the  
23                         covered location in the database established  
24                         under subsection (b); and

1                   (B) post the applicable covered records in  
2                   the database established under subsection (b)  
3                   when the President determines that release of  
4                   the covered records is no longer sensitive.
