PULMONARY HYPERTENSION 2 SEC. 101. EXPANSION AND INTENSIFICATION OF ACTIVI-4 TIES. 5 (a) Sense of Congress.—It is the sense of the Con-6 gress that— 7 (1) the Secretary of Health and Human Serv-8 ices (in this Act referred to as the "Secretary"), act-9 ing through the Director of the National Institutes of Health and the Director of the National Heart,

of Health and the Director of the National Heart, Lung, and Blood Institute (in this title referred to as the "Institute"), should continue aggressive work

on pulmonary hypertension;

(2) as part of such work, the Director of the Institute should continue research to expand the understanding of the causes of, and to find a cure for, pulmonary hypertension; and

(3) activities under paragraph (1) may include conducting and supporting—

- 19 ministration and the Director of the Centers for Disease
- 20 Control and Prevention, shall carry out an educational
- 21 campaign to increase awareness of pulmonary hyper-
- 22 tension among health care providers. Print, video, and
- 23 Web-based materials distributed under this program may
- 24 include information on—
- 25 (1) the symptoms of pulmonary hypertension;

- 1 (2) the importance of early diagnosis;
- 2 (3) current diagnostic criteria; and
- 3 (4) Food and Drug Administration-approved
- 4 therapies for the disease.
- 5 (b) Targeted Health Care Providers.—Health
- 6 care providers targeted through the campaign under sub-
- 7 section (a) shall include, but not be limited to, cardiolo-
- 8 gists, pulmonologists, rheumatologists, primary care phy-
- 9 sicians, pediatricians, and nurse practitioners.
