## A BILL

To amend the Wild and Scenic Rivers Act to designate certain segments of the Gila River system in the State of New Mexico as components of the National Wild and Scenic Rivers System, to provide for the transfer of administrative jurisdiction over certain Federal land in the State of New Mexico, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2   *tives of the United States of America in Congress assembled,*

3   **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “M.H. Dutch Salmon  
5   Greater Gila Wild and Scenic River Act”.

6   **SEC. 2. DESIGNATION OF WILD AND SCENIC RIVERS.**

7       (a) DEFINITIONS.—In this section:

8              (1) COVERED SEGMENT.—The term “covered  
9   segment” means a river segment designated by para-  
10   graph (233) of section 3(a) of the Wild and Scenic  
11   Rivers Act (16 U.S.C. 1274(a)) (as added by sub-  
12   section (b)).

13              (2) SECRETARY CONCERNED.—The term “Sec-  
14   retary concerned” means—

15                  (A) the Secretary of the Interior, with re-  
16   spect to a covered segment under the jurisdic-  
17   tion of the Secretary of the Interior; and

18                  (B) the Secretary of Agriculture, with re-  
19   spect to a covered segment under the jurisdic-  
20   tion of the Secretary of Agriculture.

21              (3) STATE.—The term “State” means the State  
22   of New Mexico.

23       (b) DESIGNATION OF SEGMENTS.—Section 3(a) of  
24   the Wild and Scenic Rivers Act (16 U.S.C. 1274(a)) is  
25   amended by adding at the end the following:

1           “(233) GILA RIVER SYSTEM, NEW MEXICO.—  
2       The following segments of the Gila River system in  
3       Las Animas Creek, Holden Prong, and McKnight  
4       Canyon in the State of New Mexico, to be adminis-  
5       tered by the Secretary concerned (as defined in sec-  
6       tion 2(a) of the M.H. Dutch Salmon Greater Gila  
7       Wild and Scenic River Act) in the following classi-  
8       fications:

9           “(A) APACHE CREEK.—The approximately  
10       10.5-mile segment, as generally depicted on the  
11       map entitled ‘Apache Creek’ and dated April  
12       30, 2020, as a wild river.

13           “(B) BLACK CANYON CREEK.—

14           “(i) The 11.8-mile segment, as gen-  
15       erally depicted on the map entitled ‘Black  
16       Canyon Creek’ and dated April 30, 2020,  
17       as a wild river.

18           “(ii) The 0.6-mile segment, as gen-  
19       erally depicted on the map entitled ‘Black  
20       Canyon Creek’ and dated April 30, 2020,  
21       as a recreational river.

22           “(iii) The 1.9-mile segment, as gen-  
23       erally depicted on the map entitled ‘Black  
24       Canyon Creek’ and dated April 30, 2020,  
25       as a recreational river.

1                     “(iv) The 11-mile segment, as gen-  
2                     erally depicted on the map entitled ‘Black  
3                     Canyon Creek’ and dated April 30, 2020,  
4                     as a wild river.

5                     “(C) DIAMOND CREEK.—

6                     “(i) The approximately 13.3-mile seg-  
7                     ment, as generally depicted on the map en-  
8                     titled ‘Diamond Creek’ and dated March  
9                     27, 2020, as a wild river.

10                    “(ii) The approximately 4.7-mile seg-  
11                    ment, as generally depicted on the map en-  
12                    titled ‘Diamond Creek’ and dated March  
13                    27, 2020, as a wild river.

14                    “(iii) The approximately 3.1-mile seg-  
15                    ment, as generally depicted on the map en-  
16                    titled ‘Diamond Creek’ and dated March  
17                    27, 2020, as a recreational river.

18                    “(iv) The approximately 1.6-mile seg-  
19                    ment, as generally depicted on the map en-  
20                    titled ‘Diamond Creek’ and dated March  
21                    27, 2020, as a recreational river.

22                    “(v) The approximately 4.1-mile seg-  
23                    ment, as generally depicted on the map en-  
24                    titled ‘Diamond Creek’ and dated March

1                 “(D) SOUTH DIAMOND CREEK.—The ap-  
2 proximately 16.1-mile segment, as generally de-  
3 picted on the map entitled ‘South Diamond  
4 Creek’ and dated March 27, 2020, as a wild  
5 river.

6                 “(E) GILA RIVER.—

7                 “(i) The approximately 34.9-mile seg-  
8 ment, as generally depicted on the map en-  
9 titled ‘Gila River’ and dated April 30,  
10 2020, as a wild river.

11                 “(ii) The approximately 2.5-mile seg-  
12 ment, as generally depicted on the map en-  
13 titled ‘Gila River’ and dated April 30,  
14 2020, as a recreational river.

15                 “(iii) The approximately 3-mile seg-  
16 ment, as generally depicted on the map en-  
17 titled ‘Gila River’ and dated April 30,  
18 2020, as a wild river.

19                 “(F) GILA RIVER, EAST FORK.—The ap-  
20 proximately 10.3-mile segment, as generally de-  
21 picted on the map entitled ‘East Fork Gila  
22 River’ and dated April 30, 2020, as a wild  
23 river.

24                 “(G) GILA RIVER, LOWER BOX.—

1                 “(i) The approximately 3.1-mile seg-  
2         ment, as generally depicted on the map en-  
3         titled ‘Gila River, Lower Box’ and dated  
4         April 21, 2020, as a recreational river.

5                 “(ii) The approximately 6.1-mile seg-  
6         ment, as generally depicted on the map en-  
7         titled ‘Gila River, Lower Box’ and dated  
8         April 21, 2020, as a wild river.

9                 “(H) GILA RIVER, MIDDLE BOX.—

10                 “(i) The approximately 0.6-mile seg-  
11         ment, as generally depicted on the map en-  
12         titled ‘Gila River, Middle Box’ and dated  
13         April 30, 2020, as a recreational river.

14                 “(ii) The approximately 0.4-mile seg-  
15         ment, as generally depicted on the map en-  
16         titled ‘Gila River, Middle Box’ and dated  
17         April 30, 2020, as a recreational river.

18                 “(iii) The approximately 0.3-mile seg-  
19         ment, as generally depicted on the map en-

21         titled ‘West Fork Gila River’ and dated  
22         May 1, 2020, as a wild river.

23                 “(ii) The approximately 4-mile seg-

3                   “(K) GILITA CREEK.—The approximately  
4                   6.4-mile segment, as generally depicted on the

7                   “(L) HOLDEN PRONG.—The approximately  
8                   7.3-mile segment, as generally depicted on the  
9                   map entitled ‘Holden Prong’ and dated March  
10                  27, 2020, as a wild river.

11                  “(M) INDIAN CREEK.—

12                  “(i) The approximately 5-mile seg-  
13                  ment, as generally depicted on the map en-  
14                  titled ‘Indian Creek’ and dated March 27,  
15                  2020, as a recreational river.

16                  “(ii) The approximately 9.5-mile seg-

20                  “(N) IRON CREEK.—The approximately  
21                  13.2-mile segment, as generally depicted on the

1                     “(i) The approximately 5.3-mile seg-

4         March 27, 2020, as a wild river.

5                     “(ii) The approximately 2.3-mile seg-  
6         ment, as generally depicted on the map en-  
7         titled ‘Las Animas Creek’ and dated  
8         March 27, 2020, as a scenic river.

9                     “(P) LITTLE CREEK.—

10                    “(i) The approximately 0.3-mile seg-

13         2020, as a recreational river.

14                    “(ii) The approximately 18.3-mile seg-  
15         ment, as generally depicted on the map en-  
16         titled ‘Little Creek’ and dated May 1,  
17         2020, as a wild river.

18                    “(Q) MCKNIGHT CANYON.—The approxi-  
19         mately 10.3-mile segment, as generally depicted  
20         on the map entitled ‘McKnight Canyon’ and  
21         dated March 4, 2020, as a wild river.

22                    “(R) MINERAL CREEK.—

23                    “(i) The approximately 8.3-mile seg-  
24         ment, as generally depicted on the map en-

1                   titled ‘Mineral Creek’ and dated March 27,  
2                   2020, as a wild river.

3                   “(ii) The approximately 0.5-mile seg-  
4                   ment, as generally depicted on the map en-  
5                   titled ‘Mineral Creek’ and dated March 27,  
6                   2020, as a recreational river.

7                   “(iii) The approximately 0.5-mile seg-  
8                   ment, as generally depicted on the map en-

19                  “(T) WEST FORK MOGOLLON CREEK.—  
20                  The approximately 8.5-mile segment, as gen-  
21                  erally depicted on the map entitled ‘West Fork  
22                  Mogollon Creek’ and dated March 4, 2020, as  
23                  a wild river.

24                  “(U) MULE CREEK.—The approximately  
25                  4.3-mile segment, as generally depicted on the

1 map entitled ‘Mule Creek’ and dated March 4,  
2 2020, as a wild river.

3 “(V) SAN FRANCISCO RIVER, DEVIL’S  
4 CREEK.—

5 “(i) The approximately 1.8-mile seg-  
6 ment, as generally depicted on the map en-  
7 titled ‘San Francisco River, Devil’s Creek’  
8 and dated October 29, 2021, as a scenic  
9 river.

10 “(ii) The approximately 6.4-mile seg-  
11 ment, as generally depicted on the map en-  
12 titled ‘San Francisco River, Devil’s Creek’  
13 and dated October 29, 2021, as a scenic  
14 river.

15 “(iii) The approximately 6.1-mile seg-  
16 ment, as generally depicted on the map en-  
17 titled ‘San Francisco River, Devil’s Creek’  
18 and dated October 29, 2021, as a scenic  
19 river.

20 “(iv) The approximately 1.2-mile seg-  
21 ment, as generally depicted on the map en-

10         titled ‘San Francisco River, Lower San  
11         Francisco River Canyon’ and dated March  
12         27, 2020, as a wild river.

13                 “(ii) The approximately 0.6-mile seg-  
14         ment, as generally depicted on the map en-  
15         titled ‘San Francisco River, Lower San  
16         Francisco River Canyon’ and dated March  
17         27, 2020, as a recreational river.

18                 “(iii) The approximately 14.6-mile  
19         segment, as generally depicted on the map  
20         entitled ‘San Francisco River, Lower San  
21         Francisco River Canyon’ and dated March  
22         27, 2020, as a wild river.

23                 “(X) SAN FRANCISCO RIVER, UPPER FRIS-  
24         CO BOX.—The approximately 6-mile segment,

2 March 4, 2020, as a wild river.

3 “(Y) SAPILLO CREEK.—The approximately  
4 7.2-mile segment, as generally depicted on the  
5 map entitled ‘Sapillo Creek’ and dated March  
6 27, 2020, as a wild river.

7 “(Z) SPRUCE CREEK.—The approximately  
8 3.7-mile segment, as generally depicted on the  
9 map entitled ‘Spruce Creek’ and dated March  
10 4, 2020, as a wild river.

11 “(AA) TAYLOR CREEK.—

12 “(i) The approximately 0.4-mile seg-  
13 ment, as generally depicted on the map en-  
14 titled ‘Taylor Creek’ and dated April 30,  
15 2020, as a scenic river.

16 “(ii) The approximately 6.1-mile seg-  
17 ment, as generally depicted on the map en-  
18 titled ‘Taylor Creek’ and dated April 30,  
19 2020, as a wild river.

20 “(iii) The approximately 6.7-mile seg-  
21 ment, as generally depicted on the map en-  
22 titled ‘Taylor Creek’ and dated April 30,  
23 2020, as a wild river.

24 “(BB) TURKEY CREEK.—The approxi-  
25 mately 17.1-mile segment, as generally depicted

1           on the map entitled ‘Turkey Creek’ and dated  
2           April 30, 2020, as a wild river.

3           “(CC) WHITEWATER CREEK.—

4           “(i) The approximately 13.5-mile seg-  
5           ment, as generally depicted on the map en-  
6           titled ‘Whitewater Creek’ and dated March  
7           27, 2020, as a wild river.

8           “(ii) The approximately 1.1-mile seg-  
9           ment, as generally depicted on the map en-  
10          titled ‘Whitewater Creek’ and dated March  
11          27, 2020, as a recreational river.

12          “(DD) WILLOW CREEK.—

13          “(i) The approximately 3-mile seg-  
14          ment, as generally depicted on the map en-  
15          titled ‘Willow Creek’ and dated April 30,  
16          2020, as a recreational river.

17          “(ii) The approximately 2.9-mile seg-  
18          ment, as generally depicted on the map en-  
19          titled ‘Willow Creek’ and dated April 30,  
20          2020, as a recreational river.”.

21          (c) WITHDRAWAL.—Subject to valid existing rights,  
22          all Federal land within the boundary of a covered segment  
23          is withdrawn from all forms of—

24           (1) entry, appropriation, or disposal under the  
25          public land laws;

1                   (2) location, entry, and patent under the mining  
2                   laws; and

3                   (3) disposition under all laws pertaining to min-  
4                   eral and geothermal leasing or mineral materials.

5                   (d) MAPS; LEGAL DESCRIPTIONS.—

6                   (1) IN GENERAL.—As soon as practicable after  
7                   the date of enactment of this Act, the Secretary con-  
8                   cerned shall prepare maps and legal descriptions of  
9                   the covered segments.

10                  (2) FORCE OF LAW.—The maps and legal de-  
11                  scriptions prepared under paragraph (1) shall have  
12                  the same force and effect as if included in this sec-  
13                  tion, except that the Secretary concerned may cor-  
14                  rect minor errors in the maps and legal descriptions.

15                  (3) AVAILABILITY.—The map and legal descrip-  
16                  tion prepared under paragraph (1) shall be on file  
17                  and available for public inspection in the appropriate  
18                  offices of the Forest Service, the Bureau of Land  
19                  Management, and the National Park Service.

20                  (e) COMPREHENSIVE RIVER MANAGEMENT PLAN.—  
21                  The Secretary concerned shall prepare the comprehensive  
22                  management plan for the covered segments pursuant to  
23                  section 3(d) of the Wild and Scenic Rivers Act (16 U.S.C.  
24                  1274(d)) after consulting with Tribal governments, appli-

1 cable political subdivisions of the State, and interested  
2 members of the public.

3 (f) INCORPORATION OF ACQUIRED LAND AND INTER-  
4 ESTS IN LAND.—If the United States acquires any non-  
5 Federal land within or adjacent to a covered segment, the  
6 acquired land shall be incorporated in, and be adminis-  
7 tered as part of, the applicable covered segment.

8 (g) EFFECT OF SECTION.—

9 (1) EFFECT ON RIGHTS.—In accordance with  
10 section 12(b) of the Wild and Scenic Rivers Act (16  
11 U.S.C. 1283(b)), nothing in this section or an  
12 amendment made by this section abrogates any ex-  
13 existing rights of, privilege of, or contract held by any  
14 person, including any right, privilege, or contract  
15 that affects Federal land or private land, without  
16 the consent of the person, including—

17 (A) grazing permits or leases;  
18 (B) existing water rights, including the ju-  
19 risdiction of the State in administering water  
20 rights;

21 (C) existing points of diversion, including  
22 maintenance, repair, or replacement;

23 (D) existing water distribution infrastruc-  
24 ture, including maintenance, repair, or replace-  
25 ment; and

1                         (E) valid existing rights for mining and  
2                         mineral leases.

3                         (2) MINING ACTIVITIES.—The designation of a  
4                         covered segment by subparagraph (G) or (H) of  
5                         paragraph (233) of section 3(a) of the Wild and See-  
6                         nic Rivers Act (16 U.S.C. 1274(a)) (as added by  
7                         subsection (b)) shall not—

8                         (A) limit the licensing, development, oper-  
9                         ation, or maintenance of mining activities or  
10                         mineral processing facilities outside the bound-  
11                         aries of the applicable covered segment; or

12                         (B) affect any rights, obligations, privi-  
13                         leges, or benefits granted under any permit or  
14                         approval with respect to such mining activities  
15                         or mineral processing facilities.

16                         (3) CONDEMNATION.—No land or interest in  
17                         land shall be acquired under this section or an  
18                         amendment made by this section without the consent  
19                         of the owner.

20                         (4) RELATIONSHIP TO OTHER LAW.—Nothing  
21                         in this section amends or otherwise affects the Ari-  
22                         zona Water Settlements Act (Public Law 108–451;  
23                         118 Stat. 3478).

24                         (5) NATIVE FISH HABITAT RESTORATION.—

1                             (A) EXISTING PROJECTS.—Nothing in this  
2 section or an amendment made by this section  
3 affects the authority of the Secretary concerned  
4 or the State to operate, maintain, replace, or  
5 improve a native fish habitat restoration project  
6 (including fish barriers) in existence as of the  
7 date of enactment of this Act within a covered  
8 segment.

9                             (B) NEW PROJECTS.—Notwithstanding  
10 section 7 of the Wild and Scenic Rivers Act (16  
11 U.S.C. 1278), the Secretary concerned may au-  
12 thorize the construction of a native fish habitat  
13 restoration project (including any necessary fish  
14 barriers) within a covered segment if the  
15 project—

- 16                                 (i) would enhance the recovery of a  
17 species listed as threatened or endangered  
18 under the Endangered Species Act of 1973  
19 (16 U.S.C. 1531 et seq.), a sensitive spe-  
20 cies, or a species of greatest conservation  
21 need, including the Gila Trout  
22 (*Oncorhynchus gilae*); and  
23                                 (ii) would not unreasonably diminish  
24 the free-flowing nature or outstandingly re-  
25 markable values of the covered segment.

## 1                   (C) PROJECTS WITHIN WILDERNESS

2                   AREAS.—A native fish habitat restoration  
3                   project (including fish barriers) located within  
4                   an area designated as a component of the Na-  
5                   tional Wilderness Preservation System shall be  
6                   constructed consistent with—

7                         (i) the Wilderness Act (16 U.S.C.

8                         1131 et seq.); and

9                         (ii) the applicable wilderness manage-  
10                         ment plan.

11                   (6) STATE LAND JURISDICTION.—Nothing in  
12                   this section or an amendment made by this section  
13                   affects the jurisdiction of land under the jurisdiction  
14                   of the State, including land under the jurisdiction of  
15                   the New Mexico State Land Office and the New  
16                   Mexico Department of Game and Fish.

17                   (7) FISH AND WILDLIFE.—Nothing in this sec-  
18                   tion or an amendment made by this section affects  
19                   the jurisdiction of the State with respect to fish and  
20                   wildlife in the State.

21                   (8) TREATY RIGHTS.—Nothing in this section  
22                   or an amendment made by this section alters, modi-  
23                   fies, diminishes, or extinguishes the reserved treaty  
24                   rights of any Indian Tribe with respect to hunting,  
25                   fishing, gathering, and cultural or religious rights in

1       the vicinity of a covered segment as protected by a  
2       treaty.

3       **SEC. 3. MODIFICATION OF BOUNDARIES OF GILA CLIFF**  
4                   **DWELLINGS NATIONAL MONUMENT AND GILA**  
5                   **NATIONAL FOREST.**

6       (a) TRANSFER OF ADMINISTRATIVE JURISDIC-  
7       TION.—

8               (1) IN GENERAL.—Administrative jurisdiction  
9       over the land described in paragraph (2) is trans-  
10     ferred from the Secretary of Agriculture to the Sec-  
11      retary of the Interior.

12               (2) DESCRIPTION OF LAND.—The land referred  
13      to in paragraph (1) is the approximately 440 acres  
14      of land identified as “Transfer from USDA Forest  
15      Service to National Park Service” on the map enti-  
16      tled “Gila Cliff Dwellings National Monument Pro-  
17      posed Boundary Adjustment” and dated March  
18      2020.
