To authorize the acquisition and protection of nationally significant battlefields and associated sites of the Revolutionary War and the War of 1812 under the American Battlefield Protection Program.

- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "American Battlefield
- 5 Protection Program Amendments Act of 2011".

3	Section 7301(c) of the Omnibus Public Land Man-
4	agement Act of 2009 (16 U.S.C. 469k–1(c)) is amended—
5	(1) in paragraph (1)—
6	(A) by striking subparagraph (A) and in-

8	"(A) Battlefield report.—The term
9	'battlefield report' means, collectively—
10	"(i) the report entitled 'Report on the
11	Nation's Civil War Battlefields', prepared
12	by the Civil War Sites Advisory Commis-
13	sion, and dated July 1993; and
14	"(ii) the report entitled 'Report to
15	Congress on the Historic Preservation of
16	Revolutionary War and War of 1812 Sites
17	in the United States', prepared by the Na-
18	tional Park Service, and dated September
19	2007."; and
20	(B) in subparagraph (C)(ii), by striking
21	"Battlefield Report" and inserting "battlefield
22	report";
23	(2) in paragraph (2), by inserting "eligible sites
24	or" after "acquiring";
25	(3) in paragraph (3), by inserting "an eligible
26	site or" after "acquire";

1	(4) in paragraph (4), by inserting "an eligible
2	site or" after "acquiring";
3	(5) in paragraph (5), by striking "An" and in-
4	serting "An eligible site or an";
5	(6) by redesignating paragraph (6) as para-
6	graph (8);
7	(7) by inserting after paragraph (5) the fol-
8	lowing:
9	"(6) Willing sellers.—Acquisition of land
10	or interests in land under this subsection shall be
11	from willing sellers only.
12	"(7) Report.—Not later than 5 years after the
13	date of enactment of this paragraph, the Secretary
14	shall submit to Congress a report describing the ac-
15	tivities carried out under this subsection, including
16	a description of—
17	"(A) preservation activities carried out at
18	the battlefields and associated sites identified in
19	the battlefield report during the period between
20	publication of the battlefield report and the re-
21	port required under this paragraph;
22	"(B) changes in the condition of the bat-
23	tlefields and associated sites during the period
24	described in subparagraph (A); and

1	"(C) any other relevant developments re-
2	lating to the battlefields and associated sites
3	during the period described in subparagraph
4	(A).''; and
5	(8) by striking paragraph (8) (as redesignated
6	by paragraph (6)) and inserting the following:
7	"(8) Authorization of appropriations.—
8	There are authorized to be appropriated to the Sec-
9	retary to provide grants under this subsection for
10	each of fiscal years 2012 through 2022—
11	"(A) \$10,000,000 for the protection of
12	Civil War battlefields; and
13	"(B) \$10,000,000 for the protection of
14	Revolutionary War and War of 1812 battle-
15	fields ''
