## A BILL

  - 3 SECTION 1. SHORT TITLE.
  - 4 This Act may be cited as the "Marine Mammal Res-
  - 5 cue Assistance Amendments of 2009".
  - 6 SEC. 2. STRANDING AND ENTANGLEMENT RESPONSE.
  - 7 (a) Collection and Updating of Informa-
  - 8 TION.—Section 402(b)(1)(A) of the Marine Mammal Pro-

2	ed by inserting "or entangled" after "stranded".
3	(b) Entanglement Response Agreements.—
4	(1) In general.—Section 403 of that Act (16
5	U.S.C. 1421b) is amended—
6	(A) by striking the section heading and in-
7	serting the following:
8	"SEC. 403. STRANDING OR ENTANGLEMENT RESPONSE
9	AGREEMENTS.";
10	and
11	(B) by striking "stranding." in subsection
12	(a) and inserting "stranding or entanglement.".
13	(2) CLERICAL AMENDMENT.—The table of con-

17	(c) Liability.—Section 406(a) of such Act (16

21	(1) In General.—Section 410 of such Act (16
22	U.S.C. 1421h) is amended—
23	(A) by redesignating paragraphs (1)
24	through (6) as paragraphs (2) through (7), re-

1	(B) by inserting before paragraph (2) (as
2	so redesignated) the following:
3	"(1) The term 'entanglement' means an event
4	in the wild in which a living or dead marine mammal
5	has gear, rope, line, net, or other material wrapped
6	around or attached to it and is—
7	"(A) on a beach or shore of the United
8	States; or
9	"(B) in waters under the jurisdiction of
10	the United States.".

14	(f) John H. Prescott Marine Mammal Rescue
15	AND RESPONSE FUNDING PROGRAM.—
16	(1) Authorization of appropriations.—
17	Section 408(h) of such Act (16 U.S.C. 1421f–1(h))
18	is amended to read as follows:
19	"(h) Authorization of Appropriations.—
20	"(1) In general.—There are authorized to be
21	appropriated to carry out this section, other than
22	subsection (a)(3), \$7,000,000 for each of fiscal years
23	2010 through 2014, to remain available until ex-
24	pended, of which—

1	"(A) \$6,000,000 may be available to the
2	Secretary of Commerce; and
3	"(B) \$1,000,000 may be available to the
4	Secretary of the Interior.
5	"(2) Rapid response fund.—There are au-
6	thorized to be appropriated to the John H. Prescott
7	Marine Mammal Rescue and Rapid Response Fund
8	established by subsection (a)(3), \$500,000 for each
9	of fiscal years 2010 through 2014.
10	"(3) Additional rapid response funds.—
11	There shall be deposited into the Fund established
12	by subsection (a)(3) up to $$500,000$ per fiscal year
13	(as determined by the Secretary) from amounts ap-
14	propriated to the Secretary for carrying out this title
15	and the other titles of this Act.".
16	(2) Administrative costs and expenses.—
17	Section 408(f) of such Act (16 U.S.C. 1421f–1(f))
18	is amended to read as follows:
19	"(f) Administrative Costs and Expenses.—Of
20	the amounts available each fiscal year to carry out this
21	section, the Secretary may expend not more than 6 per-
22	cent or \$80,000, whichever is greater, to pay the adminis-
23	trative costs and administrative expenses to implement the
24	program under subsection (a). Any such funds retained
25	by the Secretary for a fiscal year for such costs and ex-

penses that are not used for such costs and expenses be-2 fore the end of the fiscal year shall be provided under sub-3 section (a).". 4 (3) Emergency assistance.—Section 408 of 5 such Act (16 U.S.C. 1421f–1) is amended— 6 (A) by striking so much of subsection (a) 7 as precedes paragraph (2) and inserting the fol-8 lowing: 9 "(a) In General.—(1) Subject to the availability of 10 appropriations, the Secretary shall conduct a program to be known as the John H. Prescott Marine Mammal Res-12 cue and Response Funding Program, to provide for the recovery or treatment of marine mammals, the collection of data from living or dead stranded or entangled marine 14 15 mammals for scientific research regarding marine mammal health, facility operation costs that are directly related 16 to those purposes, and stranding or entangling events re-17 quiring emergency assistance. All funds available to imple-18 19 ment this section shall be distributed to eligible stranding 20 network participants for the purposes set forth in this 21 paragraph and paragraph (2), except as provided in sub-22 section (f)."; 23 (B) by redesignating paragraph (2) as 24 paragraph (4) and inserting after paragraph 25 (1) the following:

1	"(2) Contract authority.—To carry out the ac-
2	tivities set out in paragraph (1), the Secretary may enter
3	into grants, cooperative agreements, contracts, or such
4	other agreements or arrangements as the Secretary deems
5	appropriate.
6	"(3) Prescott rapid response fund.—There is
7	established in the Treasury an interest bearing fund to
8	be known as the 'John H. Prescott Marine Mammal Res-
9	cue and Rapid Response Fund', which shall consist of a
10	portion of amounts deposited into the Fund under sub-
11	section (h) or received as contributions under subsection
12	(i), and which shall remain available until expended with-
13	out regard to any statutory or regulatory provision related
14	to the negotiation, award, or administration of any grants,
15	cooperative agreements, and contracts.";
16	(C) by striking "designated as of the date
17	of the enactment of the Marine Mammal Res-
18	cue Assistance Act of 2000, and in making such
19	grants" in paragraph (4), as redesignated, and
20	inserting "as defined in subsection (g)(3). The
21	Secretary"; and
22	(D) by striking "subregions." in paragraph
23	(4), as redesignated, and inserting "subregions
24	where such facilities exist.";

1	(E) by striking subsections (d) and (e) and
2	inserting the following:
3	"(d) Limitation.—
4	"(1) In general.—Support for an individual
5	project under this section may not exceed \$200,000
6	for any 12-month period.
7	"(2) Unexpended funds.—Amounts provided
8	as support for an individual project under this sec-
9	tion that are unexpended or unobligated at the end
10	of such period—
11	"(A) shall remain available until expended;
12	and
13	"(B) shall not be taken into account in any
14	other 12-month period for purposes of para-
15	graph (1).
16	"(e) Matching Requirement.—
17	"(1) In general.—Except as provided in para-
18	graph (2), the non-Federal share of the costs of an
19	activity conducted with funds under this section
20	shall be 25 percent of such Federal costs.
21	"(2) WAIVER.—The Secretary shall waive the
22	requirements of paragraph (1) with respect to an ac-
23	tivity conducted with emergency funds disbursed
24	from the Fund established by subsection (a)(3).

1	"(3) In-kind contributions.—The Secretary
2	may apply to the non-Federal share of an activity
3	conducted with a grant under this section the
4	amount of funds, and the fair market value of prop-
5	erty and services, provided by non-Federal sources
6	and used for the activity."; and
7	(F) by redesignating paragraph (2) of sub-
8	section (g) as paragraph (3) and inserting after
9	paragraph (1) the following:
10	"(2) Emergency assistance.—The term
11	'emergency assistance' means assistance provided for
12	a stranding or entangling event—
13	"(A) that—
14	"(i) is not an unusual mortality event
15	as defined in section 409(7);
16	"(ii) leads to an immediate increase in
17	required costs for stranding or entangling
18	response, recovery, or rehabilitation in ex-
19	cess of regularly scheduled costs;
20	"(iii) may be cyclical or endemic; and
21	"(iv) may involve out-of-habitat ani-
22	mals; or
23	"(B) is found by the Secretary to qualify
24	for emergency assistance.".

1	(4) Contributions.—Section 408 of such Act

4	"(i) Contributions.—For purposes of carrying out
5	this section, the Secretary may solicit, accept, receive,
6	hold, administer, and use gifts, devises, and bequests with-
