A BILL

1	Be it enacted by the Senate and House of Representa-
2	tives of the United States of America in Congress assembled,
3	SECTION 1. SHORT TITLE.
4	This Act may be cited as the "New Frontier Congres-
5	sional Gold Medal Act".
6	SEC. 2. FINDINGS.
7	The Congress finds that—
8	(1) as spacecraft commander for Apollo 11, the
9	first manned lunar landing mission, Neil A. Arm-
10	strong gained the distinction of being the first man
11	to land a craft on the moon and first to step on its
12	surface on July 21, 1969;
13	(2) by conquering the moon at great personal
14	risk to safety, Neil Armstrong advanced America sci-
15	entifically and technologically, paving the way for fu-
16	ture missions to other regions in space;
17	(3) Edwin E. "Buzz" Aldrin Jr. joined Arm-
18	strong in piloting the lunar module, Eagle, to the
19	surface of the moon, and became the second person
20	to walk upon its surface;
21	(4) Michael Collins piloted the command mod-
22	ule, Columbia, in lunar orbit and helped his fellow
23	Apollo 11 astronauts complete their mission on the

moon;

- 1 (5) John Herschel Glenn Jr. helped pave the
- 2 way for the first lunar landing when on February
- 3 20, 1962, he became the first American to orbit the
- 4 Earth; and
- 5 (6) John Glenn's actions, like Armstrong's,
- 6 Aldrin's and Collins's, continue to greatly inspire the
- 7 people of the United States.

8 SEC. 3. CONGRESSIONAL GOLD MEDAL.

- 9 (a) Presentation Authorized.—The President is
- 10 authorized to present, on behalf of the Congress, to Neil
- 11 A. Armstrong, Edwin E. "Buzz" Aldrin Jr., Michael Col-
- 12 lins and John Herschel Glenn Jr. each a gold medal of
- 13 appropriate design, in recognition of their significant con-
- 14 tributions to society.
- 15 (b) Design and Striking.—For purposes of the
- 16 presentation referred to in subsection (a), the Secretary
- 17 of the Treasury shall strike gold medals with suitable em-
- 18 blems, devices, and inscriptions, to be determined by the
- 19 Secretary.
- 20 (c) Authorization of Appropriation.—There are
- 21 authorized to be appropriated \$50,000 to carry out this
- 22 section.

23 SEC. 4. DUPLICATE MEDALS.

- 24 (a) Striking and Sale.—The Secretary of the
- 25 Treasury may strike and sell duplicates in bronze of the

- 1 gold medal struck pursuant to section 3 under such regu-
- 2 lations as the Secretary may prescribe, at a price sufficient
- 3 to cover the cost thereof, including labor, materials, dies,
- 4 use of machinery, and overhead expenses, and the cost of
- 5 the gold medal.
- 6 (b) Reimbursement of Appropriation.—The ap-
- 7 propriation used to carry out section 3 shall be reimbursed
- 8 out of the proceeds of sales under subsection (a).

9 SEC. 5. NATIONAL MEDALS.

- The medals struck pursuant to this Act are national
- 11 medals for purposes of chapter 51 of title 31, United
- 12 States Code.
