Enactment of this legislation could reduce dedicated credits to the the Division of Water Quality by (\$333,900) ongoing starting in FY 2021 from the elimination of Utah Pollutant Discharge Elimination System (UPDES) general and individual permits for discharges from Municipal Separate Storm Sewer Systems (MS4) and industrial sources.

Enactment of this legislation could cost the Division of Water Quality \$2,190,500 one-time, over three years, beginning in FY 2020 from the General Fund to report required information to the Natural Resources, Agriculture and Environment Interim Subcommittee. The Division of Water Quality could see reduced personnel costs of (\$333,900) starting in FY 2021 from not issuing General Multi-Sector Industrial Storm Water Permits.

Local Government

UCA 36-12-13(2)(c)

Enactment of this legislation could reduce revenues up to (\$33,000) per year to the 88 Municipal Separate Storm Sewer Systems in Utah which currently charge fees related to stormwater. Cities and counties which currently manage Stormwater Discharges from Construction Activities could see savings on personnel costs from reduced workload associated with no longer inspecting permitted construction sites.

Individuals & Businesses

UCA 36-12-13(2)(c)

Enactment of this legislation could reduce costs by up to \$250 for each businesses not having to apply for a General Multi-Sector Industrial Storm Water Permit. In aggregate costs for businesses could be reduced by (\$333,900) starting in FY 2021.

Regulatory Impact

UCA 36-12-13(2)(d)

Enactment of this legislation could result in a medium reduction in the regulatory burden for Utah residents or businesses.
